Minutes

- 1. Welcome (1 minute)
 - a. President Bridget Cusick called the meeting to order
- 2. <u>Congestion Pricing Resolution</u> (10 minutes)
 - a. Jerry Ferguson and Pierre Ratzki presented a <u>resolution</u> supporting congestion pricing, written primarily by Nancy Lang, chair of the transit policy working group
 - i. After discussion, the Club approved the resolution by a vote of 28 to 2
- 3. <u>Presentation by judicial candidates</u> (5 minutes with discussion)
 - b. Two candidates for Civil Court presented their credentials to the Club
 - i. Both have been nominated by the Democratic County Committee
 - c. Judge Robert Rosenthal:
 - i. Has been a lawyer for 28 years, and has always sought to represent those in need, including the indigent and capital defendants
 - ii. Currently appointed to an interim civil court position, sitting in criminal court
 - d. Ashlee Crawford:
 - i. Works as a court attorney at the Appellate Division, First Department, where she helps analyze appeals
 - ii. Previously Worked at Skadden Arps, where she was able to do a lot of pro bono work and community service
 - iii. Volunteers as an arbitrator at small claims court
 - iv. Big fan of the arts, including dance and music
 - e. The Club asked the candidates to leave the room, and thereafter held a discussion:
 - i. Kim Moscaritolo spoke in favor of both candidates, who have been in the process for years, and are both well qualified, smart, and kind
 - b. The Club ultimately voted to endorse both candidates
- 4. <u>Presentation on the movement to amend the 13th Amendment</u> (20 minutes with Q&A)
 - a. Flores A. Forbes, a criminal justice reform activist, gave a presentation on the movement to "Amend the 13th," which aims to remove the exception clause of the Amendment, in bold below:
 - i. Neither slavery nor involuntary servitude, except as a punishment for crime whereof the party shall have been duly convicted, shall exist within the United States, or any place subject to their jurisdiction

- b. The exception clause insidiously permits slavery for incarcerated persons
 - i. This is thus only country in the world with a constitutional amendment that states that you can be a slave if convicted of a crime
 - ii. Together with the post-Civil War black codes, Jim Crow, and other oppressive laws, the exception clause allowed slavery to continue past the 13th Amendment's enactment in all but name
 - 1. Slavery continues today, as many prisoners work for little to no wages, a problem exacerbated by hyper-incarceration of today
- c. Minimum wages legally allowed to be paid in prison include:
 - i. In parts of the South: nothing
 - ii. California: 15 cents per hour
 - 1. Inmates manufacture goods bought by the UC system, the governor's office, and consumers statewide
- d. This Friday, February 22nd, Mr. Forbes and others will be hosting a panel on Amending the 13th, and Club members were encouraged to attend
- e. Q&A:
 - i. Gabe Panek asked about the response from legislators, and what we can do to push the issue
 - ii. Diana Montford proposed a verbal resolution: to do our best to persuade legislators to amend the 13th Amendment and do away with the exception clause
 - 1. Fred Newton seconded the motion
 - 2. The Club approved the resolution, with one opposed
 - iii. Jeff Green noted that we must work towards closing Rikers
- 5. District Leader candidate presentations and discussions (15 minutes)
 - a. The Club heard presentations from the four candidates for District Leader, as nominated at the February 11th meeting
 - i. Jill Eisner candidate for female District Leader for the 76th AD, Part A
 - 1. Has served as District Leader for two terms
 - 2. Began as an activist in the community, and active in community advisory boards
 - 3. Has been able to work closely with our Assemblymember and other electeds
 - ii. Kim Moscaritolo candidate for female District Leader for the 76th AD, Part B
 - 1. Has served as District Leader for two terms
 - 2. Working to help reform County Party, host educational forums, organizing phone banks and trips to swing states/counties outside of NYC to help elect Democrats in all flippable seats
 - a. Had immense success in our targeted races in 2018
 - iii. Ben Wetzler candidate for male District Leader for the 76th AD, Part A
 - 1. Has served as District Leader for 1 term
 - 2. Working to change the party rules, with the goal of being less Tamany Hall and more small-d democratic

- 3. Worked hard to elect candidates in nearby districts for the 2018 midterms, including campaigning up to 3 days a week in the final run
- iv. Josh Kravitz candidate for male District Leader for the 76th AD, Part B
 - 1. Praised FFDC's values, and advocated for more cooperation between the Upper East Side clubs
 - 2. However, declined the Club's endorsement, as asked to by his club
- b. The Club asked the candidates to leave the room, and thereafter held a discussion:
 - i. Gabe, Esther, Pierre, Devon, and others spoke highly in favor of endorsing Ben and Kim for reelection
 - 1. They have worked hard, and work very well together, especially on issues related to party management, recruiting for the County Committee and other downballot seats, and campaigning in the midterms
 - 2. They do not create conflict, drama, or other issues, but instead foster cooperation
- c. The Club voted to endorse Kim and Ben for reelection, and not to endorse for the other two District Leader seats
- 6. <u>Judicial Delegate Candidate Presentations and Discussion</u> (25 minutes)
 - a. Candidates seeking the Club's endorsement for judicial (or alternate judicial) delegate gave presentations, with each being permitted 60 seconds to speak
 - b. After the candidates' presentations, the Club asked them to leave the room and then held a discussion
 - c. The Club ultimately voted to endorse the following candidates:
