DECLARATION FOR NEW POLITICAL PARTY

It champions grassroots democracy, encouraging citizen participation and decentralized decision-making processes. The party also stands for non-violence, promoting peaceful resolutions to conflicts and a reduction in military spending. The Green Party places great importance on global cooperation and supports international agreements and institutions that foster collaboration and collective action to tackle global challenges. With a holistic approach, the Green Party envisions a society that harmonizes the well-being of people, the planet, and future generations.

- 2. Before the petition is filed, each signer or the circulator must add the residence address of the signer and the date of signing. If the signer is a resident of a second- or third-class municipality, a post office box may be used for the residence address.
- 3. Before the petition is filed, each signer or the circulator must print the name of the signer in the space provided and add the county of voter registration.
 - 4. Abbreviations of common usage may be used. Ditto marks may not be used.
 - 5. Failure to provide all information requested may invalidate the signature.
