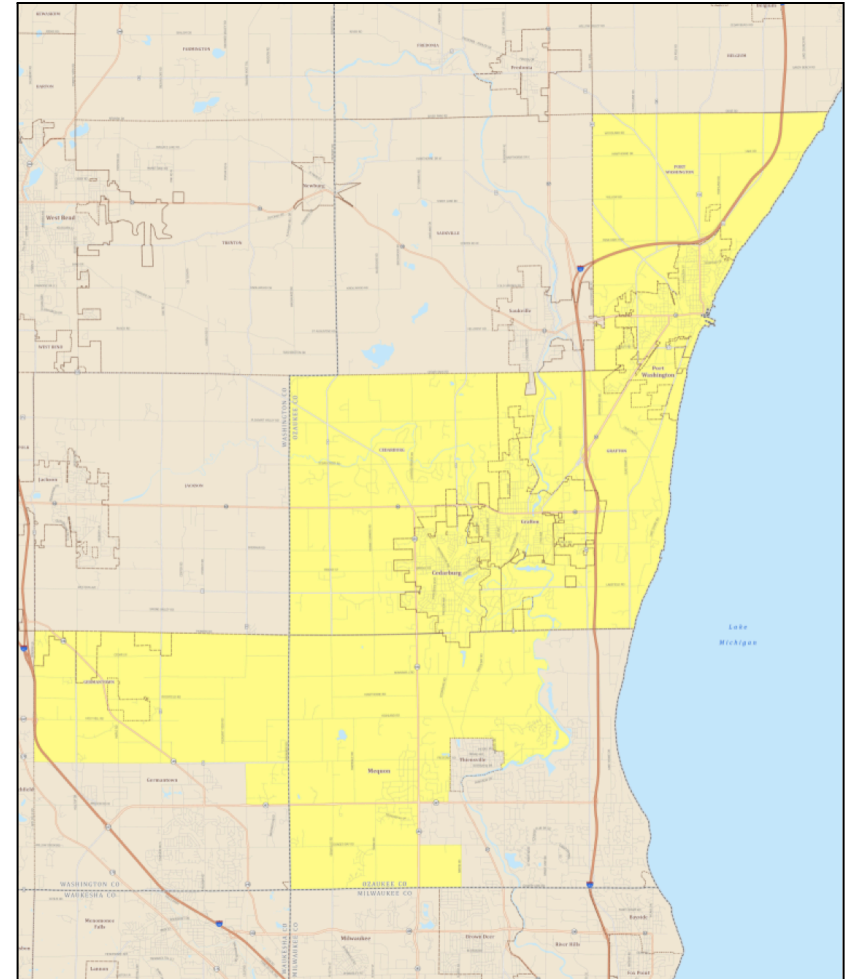

## Collecting Nomination Signatures

Thanks for your help! Here are guidelines for gathering signatures to put Dana's name on the ballot:

- **Sign and date the certificate at the bottom of the form AFTER you are done collecting signatures.** If the date of your certification is before the date people sign, those signatures will not count. This is the most common mistake circulators make.
- **Please check to see that the signer completes all the required information** including the correct date. Email address and/or phone number are not required.
- **Please do not number the pages** in the bottom right-hand corner. The campaign will enter page numbers.
- **Signers must be qualified electors in the state of Wisconsin and reside in District 22** (see map to right).
- **Signers do not need to be registered to vote** to sign the nomination papers.
- **Circulators do not need to reside in the Assembly District in order to gather signatures but must be qualified electors in the state of Wisconsin.**
  - **A qualified elector** is someone who has resided in the state for 28 consecutive days
- **Please return completed nomination forms to the campaign ASAP** so we have ample time to check them for compliance with the election law requirements before they need to be turned in to the Wisconsin Elections Commission.
