HARRIS COUNTY CONVICTION INTEGRITY DIVISION CASE REVIEW FORM

The Conviction Integrity Division ("CID") investigates claims of actual innocence and wrongful convictions by persons who have been convicted by the Harris County District Attorney's Office and do not have a pending post-conviction writ.

The purpose of the CID's investigation is to determine if newly discovered or newly available evidence exists to establish that the convicted person is actually innocent by a clear and convincing standard of proof. "Newly discovered" or "newly available" evidence is evidence that was either not known to the claimant or could not be known to the claimant with the exercise of due diligence at the time of trial, plea, or post-trial motions. Consequently, factual questions that have already been decided by a judge or jury and evidence that has already been presented at trial or a post-conviction proceeding are not newly discovered or newly available evidence.

This form is to be completed by the convicted person.

Do not send original documents or your only copy of documents. If you have supporting documentation, only provide copies, if possible.
