Terms & Conditions of Entry

- The entrant agrees and acknowledges that they have read these Conditions of Entry (and Schedule) and that entry into the Promotion is acceptance of these Conditions of Entry (and Schedule). Any capitalised terms used in these Conditions of Entry have the meaning given in the Schedule, unless stated otherwise.
- The Promotion commences on 1 May 2023 and ends on 4 June 2023 ("the Promotional Entry Period"). Entries are deemed to be received at the time of receipt by the Promoter and not at the time of transmission by the entrant. Records of the Promoter and its agencies are final and conclusive as to the time of receipt.

- 3. The Promoter reserves the right (in its absolute discretion) to disqualify any entrant from the prize draws if it has reasonable grounds to believe:
 - a. the entrant has breached these Conditions of Entry; or
 - b. the entrant is not an Eligible Entrant.
- 4. If there is a dispute as to the identity of an entrant or winner, the Promoter reserves the right, in its sole discretion, to determine the identity of the entrant or winner.
- 5. In the event that there is a dispute concerning the conduct of the Promotion, the decision of the Promoter is final and binding on each entrant and no correspondence will be entered into.

How to Enter

- 6. To enter the Promotion, the entrant must complete the following steps during the Promotional Entry Period:
 - a. Visit the website https://www.australiasbiggestquiz.org/ ;
 - b. Complete a weekly quiz;
 - c. Complete their contact details;
 - d. Complete details of the Official Live Event attended, if applicable.
- 7. Entrants are subject to the following:
 - a. Limit one (1) Entry per person per Entry Period. Multiple entries in an Entry Period from the same person will be disqualified;
 - b. A completed quiz is considered an Entry, regardless of correct responses; and
 - c. The entrant is eligible to win a maximum of one (1) prize per Promotional Entry Period (Week 1 Week 5).
 - d. All entrants are eligible to win a maximum of one (1) prize in the Grand Prize Draw

Prizes

Winners will also be announced across Australia's Biggest Quiz social media platforms (first name, initial, Official Live Event if applicable and state ONLY ie: John S, NSW). If an entrant's contact details change during or after the Promotional Entry Period, it is the entrant's responsibility to notify the Promoter.

Hepatitis Australia (The Promoter) will collect your name, email address and other contact information to enable you to participate in the Promotion so that we can contact you if you are a winner. - 16. All entries in the competition become the property of the Promoter. The Promoter collects personal information from entrants to conduct the competition and may, in the course of business, disclose the personal information to third parties, as required. Entry in this competition is conditional on the provision of the personal information requested. Entries may be entered into a database and the Promoter may use the entrants' names and addresses for future promotional, marketing and publicity in various forms by the Promoter, and the entrant consents to such use. Entrants may direct any request to access their personal information to the Promoter. The Promoter may share an entrant's

details with the prize provider for the sole purpose of arranging delivery of a prize to a winner.

- 17. If for any reason any aspect of this Promotion is not capable of running as planned, including by reason of computer virus, communications network failure, bugs, tampering, unauthorised intervention, fraud, technical failure or any cause beyond the control of the Promoter, the Promoter may in its sole discretion cancel, terminate, modify or suspend the Promotion and invalidate any affected entries, or suspend or modify a prize. Changes will be posted on the <u>https://www.australiasbiggestquiz.org/</u> website and it is the entrant's responsibility to keep themselves informed of any changes.
- 21. The Promoter reserves the right, at any time, to validate and check the authenticity of entries and entrant's details (including an entrant's identity, age, place of residence and eligibility to enter). In the event that a winner cannot provide suitable proof as required by the Promoter to validate their entry, the winner will forfeit the prize in whole and no substitute will be offered.
