I understand your feeling regarding the internet. I have DSL myself and the work from home life is not always the easiest. To answer a couple of your questions; Your house has 5 turbines within 1 mile of it (T23; T24; T26; T28; T31). You should not hear the sound of the turbine adjusting from your house. The turbine noise when it is yawing into the wind is actually very low. If the turbine is maintained properly and greased adequately it won't be heard unless you are right underneath the tower. Jess had sent you the page number and your receptor ID in the past and your receptor ID is 330 and the analysis begins on page 363 of Part 5 of the PNIA. As you have heard from Jess, we are legally required to use setbacks that do not let the sound levels go higher than 45 dBA at the outside of your home. When all turbines are operating at maximum capacity, worst-case sound levels from every wind turbine combined at your home would be 41 dBA (Vestas Turbine). RE: Heritage Wind Proposed Section 94-c Permit Modification

Dear Supervisor Pogue and Town Board Members,

As you know, on January 13, 2022, Heritage Wind was issued a Final Permit from New York State Office of Renewable Energy Siting ("ORES") for the construction of a 33-turbine major wind energy generating facility ("Permit"). The Permit included Site Specific Conditions (SSCs) and applicable Uniform Standards and Conditions (USCs) that must be met during construction and operation of the Facility. However, while authorizing a 33 turbine project, ORES took issue with the location of 6 turbines Heritage Wind had previously proposed within two miles of what was termed the "Iroquois Complex"—an area of federal and state wetland habitat conservation areas located southwest of the Facility Site, consisting of the state-managed Oak Orchard and Tonawanda Wildlife Management Areas and the federally-managed Iroquois National Wildlife Refuge (see *Decision of the Executive Director in Matter 21-00026, Application of Heritage Wind* (January 13, 2022) at page 3-4).

Because of ORES's Final Permit decision regarding the 6 turbines (T1-T6), Heritage Wind has reconsidered the viability of these turbines and has studied and analyzed a project modification that would enable the Project to still generate renewable energy at a level allowed for the interconnection location, but would remove these turbines from the Project layout. For that reason, in the intervening months, Heritage Wind has relocated four of the six turbines to new locations within the previously studied Facility Site to offset the loss of generating capacity resulting from these changes. Two turbines from the Project will be removed entirely, but the Facility's total generating capacity will slightly increase due to the selection of new Vestas turbine models that generate more power per turbine. The turbines will be shorter than previously proposed by 20 ft.

On or about July 27, 2022, Heritage Wind plans to file with ORES a request seeking approval for the changes to the Facility layout. This request will be provided to the Town of Barre, local document repositories, and other statutory parties in the same manner as the prior Section 94c Transfer Application. Given that new turbine locations are proposed, Heritage Wind anticipates a public comment process on the changes under 19 NYCRR 900-11.1.

Overall, Heritage Wind is proposing to utilize a newer turbine model with slightly larger generating capacity—an increase from 5.6 MW per turbine to either 6.0 MW or 6.8 MW per turbine—at a lower total tip height and using fewer total turbines. The Modified Layout proposes up to 31 wind turbines (rather than 33 currently permitted) at a maximum tip height of 656 feet (down from 676 feet in the Permit), as well as a decrease in the total length of access roads and collection lines proposed in the Town. As the filing with ORES will show, the overall Facility impacts are anticipated to be largely the same or less than anticipated from the permitted Facility—for example, the Modified Facility layout reduces impacts to wetlands and grassland bird habitat. Review of the filing by ORES will be limited to the changes proposed between the Permitted Facility and the proposed Modified Facility.

Unfortunately, in order to accommodate the 2-mile "setback" to the Iroquois Complex imposed by ORES, Heritage Wind's Facility modification will not be possible without locating turbines within the existing array and Facility Site, which minimizes potential new impacts, but necessitates a limited waiver of the Town of Barre's 1.5 times turbine tip height setback to non-participating property boundaries for six turbines in the Modified Layout. For that reason, Heritage Wind will seek a limited waiver of this local law as applied only to those six turbine locations.

Lastly, we note that the selection of this newer turbine model will also allow Heritage Wind to increase the overall nameplate of the Facility from 184.8 MW to 186 MW or 200.1 MW. Given that an increase in nameplate capacity is proposed with this filing, Heritage Wind will be submitting additional local agency account funding in the amount \$1,000 per MW of the nameplate capacity increase (\$15,300), at least 75 percent of which would be reserved for host municipalities such as the Town of Barre. We anticipate that the Administrative Law Judges in this case will issue a Notice of Availability of Local Agency Account Funding setting a deadline for funding requests in the same manner as was done last year for the Transfer Application. This will also increase potential PILOT and host community payments and allow the overall economic benefits of the Project to increase while continuing to minimize potential impacts to the environment and the community.

We appreciate the Town's efforts in reviewing the Heritage Wind Project and look forward to you receiving the filing and providing your input and comment on the proposed changes.
