ICIN's Purpose

To enable and empower Indigenous people to benefit from carbon markets through their land and sea management practices. The Indigenous Carbon Industry Network (ICIN) does this by supporting an active network of Indigenous organisations working towards an Indigenous-led carbon industry supporting the advancements and aspirations of Indigenous people across Australia.

The Indigenous Carbon Industry began with one project in 2006 and has expanded to 38 projects, 34 in Savanna Fire Management (SFM) and four in the Human-Induced Regeneration (HIR) carbon method. ICIN is committed to scaling this industry nationally and across all applicable carbon methods.

An organisation wishing to become a **full member** of ICIN must provide:

- Written evidence of their status as an Indigenous producer or Indigenous proponent, and other information or documentation requested by ICIN.
 - Proof of organisation's incorporation or other type of document and/or Proof of organisation's governance structure to show it is Indigenous owned,
 - A description of organisation, and its logo,
 - The names of the carbon project/s your organisation produces carbon credits for and their ID numbers,
 - A description of your project/s and any images and resources you want us to share on your project profile,
- Credit card details for payment.


- Applications are received by the Company Secretary via the online application form

Full Member Brand

The Network has launched its Full Member Brand and accompanying brand rules.

This new initiative is specifically designed for the Network's Full Members and establishes a clear and recognisable brandmark that indicates an organisation is a Full Member of the Indigenous Carbon Industry Network (ICIN).

A Full Member Brandmark (developed and launched as the logo below) has been identified by ICIN Full Members as an opportunity to support Network integrity and further help showcase Indigenous-owned and -led organisations producing carbon credits.

The Full Member Brand is designed to:

- **Showcase ICIN Full Members:** The brand signifies that an organisation is a full member of ICIN. This means it is an Indigenous-owned organisation with a carbon project that is owned by Indigenous land and sea managers of the project area.
- **Enhance differentiation in the carbon market:** This brand allows members to stand out, highlighting their Indigenous leadership and engagement in the Indigenous carbon industry.
- **Protect against misrepresentation:** The Full Member Brand will serve to protect against false claims made by nonIndigenous organisations about their involvement in the creation of Indigenous carbon credits. It safeguards against misrepresentations, ensuring that only eligible members can use the brandmark.

In accordance with its rules, the Full Member Brand is only for use by organisations that are ICIN Full Members. We encourage ICIN Full Members to read the **Brand Rules**.
