

**SCRIPT FOR CALLS** – You will likely be chatting with a staff member when you call the numbers so the script is tailored to that. In the event that the representative picks up, please use your better judgement and change the script.

Hi, my name is \_\_\_\_\_ and I am calling to urge Representative \_\_\_\_\_ to advance HB 1053 to the house floor. As a student of \_\_\_\_\_ and a Washington resident, I believe that **(share why you think the bill is important)**. H.B. 1053 is an important first step in making essential products for women more affordable and accessible in Washington. For these reasons, I support H.B. 1053 and urge Representative \_\_\_\_\_’s support to advance the bill to the floor. Thank you for your time.

**WHY IS THIS IMPORTANT:** The bill passed out of the Finance committee, which is the furthest this bill has gone. Now in order for the bill to go to the House floor for a full vote, the bill has to be advanced by one of the members of the Rules committee. One member has to agree to move the bill out of Rules onto a full floor vote. If the bill cannot get pass this committee then the bill is dies. It is critical that members of this committee hear from constituents of WA and why they think this bill is important.

**CALL NUMBERS** – Focus on calling the co-authors (highlighted in yellow) - thank them for co authoring the bill and request that they advance the bill to the floor (use script). Then call the offices we have met with (in blue). Most of the members we have met with have indicated support so you can mention that in your call.
