These expenses include the salary of a director of community engagement and her assistant travel food and lodging expenses for the outreach work in the Commonwealth of Virginia. The project has several goals: to increase the reach of the Coalition on Solitary Confinement to increase the number of partners in the Coalition and to make contact with different leaders to explain the mission of the Coalition and to gain their support for the mission. The Director of Community Engagement and her assistant traveled to many different communities in Virginia to make in person appearances in front of religious communities colleges and university groups and community and civic groups.

4b (Code:) (Expenses \$ 19,000 including grants of \$ 0) (Revenue \$ 0)

These expenses are for paying for a director of community engagement and advocacy in the State of Maryland. The Director of Community Engagement in Maryland helped write legislation that was passed by the legislature reached out to community partners and met with legislators.

4c (Code:) (Expenses \$ 2,500 including grants of \$ 0) (Revenue \$ 0)

These expenses underwrote IAHR's pen pal project. The pen pal project matches civilians who are not incarcerated with incarcerated people in federal prisons and in Maryland and Virginia state prisons. Pen pals are asked to write at least once a month to their correspondents in prison. The expenses were for the salary of an administrative assistant and for postage for the letters.
