As a social enterprise, Homeboy Recycling exists to achieve social and environmental outcomes through business principles and practices. While providing the highest quality IT Asset Disposition and Electronics Recycling services, we strive not only to minimize negative impacts from our operations (e.g., preventing pollution and injuries) but also to maximize positive impacts: namely, the employment of people facing barriers to work and the recovery of resources from electronic waste. Environmental, Health and Safety issues are thus a top priority and integral part of our business. We are committed to the following:

- Protecting the environment, including preventing pollution, promoting sustainable resource use, and mitigating climate change through responsible recycling practices
- Providing safe and healthy working conditions for the prevention of injury and and ill health
- Eliminating hazards and reducing Environmental, Health and Safety risks
- Fulfilling our compliance obligations, including applicable legal requirements and other requirements relative to the Environmental, Health and Safety aspects of our business
- Continually improving our Environmental, Health and Safety management system to enhance our Environmental, Health and Safety performance (i.e., through monitoring of objectives and targets and rigorous evaluation of our management system)
- The consultation and participation of workers, and where they exist, workers' representatives
- Embracing social accountability; we are guided by the principles of the SA 8000 standard
- Devoting the resources necessary to ensure that our services are provided safely, ethically, and securely
- Operating with exceptional transparency
- Safeguarding any material that potentially contains customer data
- Managing used and end of life electronic equipment based on a reuse, refurbishment, recovery, disposal
  hierarchy, repairing and redeploying electronic devices whenever feasible and authorized (in particular,
  hazardous electronic waste received by Homeboy Recycling will not be directed to incineration, energy
  recovery, or land disposal facilities unless no reuse or recycling options are viable, or unless customer
  requirements for sensitive/proprietary material require incineration-type destruction)
- Utilizing downstream vendors that share our Environmental, Health and Safety commitments and managing R2 Focus Materials throughout the recycling chain to final disposition with due diligence
- Preventing illegal exports of hazardous electronic waste throughout the recycling chain
- The prohibition of forced and child labor, and restrictions on the use of prison operations and disposal of hazardous e-waste, throughout the recycling chain
