

CIRCULATOR INSTRUCTIONS

WEST VIRGINIA NOMINATION PETITIONS

ROBERT F. KENNEDY JR.

1. EACH PETITION PAGE **MUST** BE PRINTED ON 8 ½" x 11" PAPER, IN LANDSCAPE FORMAT – NO EXCEPTIONS.
2. PETITION SIGNATURES MUST BE SEGREGATED BY COUNTY. IN OTHER WORDS, A VOTER MUST SIGN A PETITION FOR THAT VOTER'S COUNTY AS STATED AT THE TOP OF THE "CANDIDATE NOMINATION PETITION."
3. WHILE COLLECTING SIGNATURES YOU MUST HAVE IN YOUR POSSESSION, FOR EACH COUNTY PETITION YOU HAVE IN YOUR POSSESSION, AN OFFICIAL CREDENTIAL FROM THE COUNTY PERMITTING THE CIRCULATION OF MR. KENNEDY'S NOMINATION PETITION.

IF THE OFFICIAL CREDENTIAL IS NOT PROVIDED TO YOU WITH THE NOMINATION PETITION, PLEASE CONTACT THE CAMPAIGN BEFORE COLLECTING SIGNATURES.

4. YOU MUST BE 18 YEARS OF AGE TO CIRCULATE THIS NOMINATION PETITION.
5. YOU MAY NOT PAY, OR PROVIDE ANYTHING OF VALUE, TO INDUCE A PERSON TO SIGN THIS PETITION.
6. YOU MAY NOT MISREPRESENT THE PURPOSE, OR SUBJECT, OF THIS PETITION TO A VOTER. FOR INSTANCE, YOU MAY NOT SAY "SIGN THIS PETITION TO HELP FEED THE POOR" or "SIGN THIS PETITION TO SAVE AMERICA."

THIS PETITION, AND SIGNATURES PLACED THEREON, IS FOR THE SOLE PURPOSE TO PLACE THE NAME OF ROBERT F. KENNEDY JR., ON THE 2024 WEST VIRGINIA GENERAL ELECTION BALLOT AS AN INDEPENDENT CANDIDATE FOR THE OFFICE OF PRESIDENT OF THE UNITED STATES.

7. EACH VOTER MUST PROVIDE – IN HIS/HER OWN HAND:
 - A. HIS/HER SIGNATURE; and,
 - B. HIS/HER PRINTED NAME AS IT APPEARS ON THE VOTER'S REGISTRATION RECORD; and,
 - C. HIS/HER DATE OF BIRTH; and,
 - D. VOTER'S ADDRESS AS IT APPEARS ON THE VOTER'S REGISTRATION RECORD.

*Voters CANNOT sign on behalf of anyone else, even a spouse or family member who has given them permission. Each person must sign for themselves.

- 8. VOTERS MUST USE A BLACK OR BLUE BALLPOINT PEN TO SIGN THEIR NAMES. TRY NOT TO USE GEL PENS, AS THEY CAN SMEAR – ESPECIALLY IF THE PETITION PAGES ENCOUNTER MOISTURE.**
- 9. ORIGINAL OF THE PETITION MUST BE RETURNED TO THE CAMPAIGN – NO COPIES PERMITTED.**
