

CIRCULATOR INSTRUCTIONS

OHIO PETITION

ROBERT F. KENNEDY JR.

1. Each petition page **MUST** be printed on 8 ½ x 11” paper, in Portrait format – NO EXCEPTIONS.
2. Each petition consists of 3 pages which must be stapled together at the top of the petition.
3. As a circulator, you may not sign a petition you are circulating. You must sign a petition circulated by a different circulator (you may sign a petition circulated by a spouse, friend, neighbor, sibling – even if that petition consists of just your signature). The rule here is that you may not certify your own signature as part of “Circulator Statement” that you must execute at the bottom of the second page of the petition.
4. Each petition may only be signed by voters of the same county. After the first voter signs a petition page (i.e., on the 2nd page of the petition) write the name of that voter’s county at the top of the 1st page of the petition so that you can easily find the correct county petition for subsequent voters you encounter (and to make sure a voter does not sign a petition reserved for voters from a different county).
5. You **MUST** be at least 18 years old to circulate this petition.
6. You **MUST** witness (or watch) each voter as they sign this petition.
7. You may NOT misrepresent the purpose of this petition.

The sole purpose of this petition to place the name of Robert F. Kennedy Jr. on Ohio’s 2024 general election ballot as a candidate for the office of President of the United States. You cannot collect a signature by telling a voter the petition is to “Save America” or “Help the Poor.” BE HONEST WITH THE VOTERS.

8. Voters **MUST** use only black or blue ballpoint pens to sign this petition. Do not use gel pens as they can easily smear and result in an invalid signature.
9. Only registered voters may sign this petition.

10. Each voter must (on the 2nd page of the petition):
 - A. Sign their name; and,
 - B. Record their current residential address. A P.O.Box addresses are NOT PERMITTED. If a voter records a P.O.Box address, the signature will be invalid; and,
 - C. Record the City, Village or Township of their residence as shown on their voter record; and,
 - D. Record their County of their voter registration residence; and,
 - E. Record the date they signed the petition.
11. After the last signature is collected for each petition, you MUST execute the “Circulator Statement” at the bottom of the 2nd page of each petition.
 - A. First, record your name on the space provided on the first line; then,
 - B. Second, record the total number of signatures collected on this 2nd page of the petition on the small line provided on the second line; then,
 - C. At the bottom of the “Circulator Statement” sign your name, record your personal address along with your City or Village and your state of residence along with your residential zip code.
12. Return the **ORIGINAL** of each petition to the campaign AFTER you have executed the “Circulator Statement.”
