

CIRCULATOR INSTRUCTIONS

VIRGINIA PETITION

ROBERT F. KENNEDY JR.

1. Each petition page **MUST** be printed on 8 ½ x 11” paper, in Portrait format, FRONT AND BACK – NO EXCEPTIONS. This means this is a 1 page petition, with page 2 printed on the reverse side of petition.
2. Each petition may only be signed by voters of the same County or City. After the first voter signs a petition page, record the name of that voter’s County or City at the top of the petition in the space provided (right underneath the title of the petition “**Petition of Qualified Voters for Electors for President and Vice President**”) so that you can easily find the correct town petition for subsequent voters you encounter (and to make sure a voter does not sign a petition reserved for voters from a different town).
3. As a circulator, you may not sign a petition you are circulating. You must sign a petition circulated by a different circulator (you may sign a petition circulated by a spouse, friend, neighbor, sibling – even if that petition consists of just your signature). The rule here is that you may not certify your own signature as part of the “Affidavit” that you must execute at the bottom of reverse side of the petition.
4. You **MUST** be at least 18 years old to circulate this petition.
5. You **MUST** witness (or watch) each voter as they sign this petition.
6. You may NOT misrepresent the purpose of this petition.

The sole purpose of this petition to place the name of Robert F. Kennedy Jr. on Virginia’s 2024 general election ballot as a candidate for the office of President of the United States. You cannot collect a signature by telling a voter the petition is to “Save America” or “Help the Poor.” BE HONEST WITH THE VOTERS.

7. Voters **MUST** use only black or blue ballpoint pens to sign this petition. Do not use gel pens as they can easily smear and result in an invalid signature.
8. Only registered voters may sign this petition.

9. Each voter must:
 - A. Sign their name; and,
 - B. Print their name; and,
 - C. Record their residential address as it is recorded on their voter registration record; and,
 - D. Record their City/Town; and,
 - E. Record the date they signed the petition.

In addition, the voter may – at their option – record the last 4 digits of their social security number. Don't push this on nervous voters. BUT, if they do provide this information, it will assist in the validation of their signature.

10. After the last signature is collected, you must IN THE PRESENCE OF A NOTARY PUBLIC, execute the "AFFIDAVIT" at the bottom of the reverse side of the petition:
 - A. Print your name on the first line of the AFFIDAVIT; and
 - B. Record your address on the second line of the AFFIDAVIT; and.
 - C. Record the State/Commonwealth of your residence on the third line of the AFFIDAVIT.

THEN

- D. Record your driver's license number, state issuing your driver's license and the last four digits of your social security number (required), on the three lines on the right-hand side of the AFFIDAVIT.

THEN

- E. Sign the AFFIDAVIT where indicated; and
 - F. Make sure the NOTARY PUBLIC fully and properly executes the spaces beneath your signature.
11. Return the **ORIGINAL** of each petition to the campaign AFTER the "AFFIDAVIT" is executed.
