





Report from Sharon Hodgson MP



Brandon Feeley launched his campaign in Washington South on February 24th. Since being selected as the candidate, Brandon and the team have made 425 contacts, with a 57% Labour promise.

SNP Opposition Day debate in Parliament

On Wednesday 21st Feb, I spoke in the Chamber to call for an immediate humanitarian ceasefire in Gaza. The Speaker made the decision to allow votes on the SNP's debate motion, a Government amendment calling for 'humanitarian pauses', and a Labour amendment calling for an 'immediate humanitarian ceasefire'. While this broke convention on the Speaker's behalf, he recognised that MPs needed to have a broad debate, and the opportunity to vote for a ceasefire that respected this. This Opposition Day debate topic was extremely sensitive and internationally significant, and the vote would go on to represent the opinion of the whole House. It would not have been fair, accurate, or safe to hold such a vote without accurate representation of the positions of members across the house, that they could safely and meaningfully support. I called for an immediate humanitarian ceasefire in Gaza, the immediate release of all hostages, an immediate increase of aid into Gaza, and demand an end to the horrific violence and suffering that, if left unopposed, will only cause more death and destruction.

Baby Loss Certificates announcement

On Thursday 21st Feb, the Department for Health and Social Care (DHSC) announced that they are introducing a certificate of recognition for pregnancies lost before 24 weeks. Previously, pregnancies lost before 24 weeks could only be recognised as a miscarriage even if, had the baby been born alive when they may have survived, it would be still classed as a miscarriage rather than a stillbirth, as in the case of my daughter, Lucy. For many families this is fundamentally inaccurate to their experience of loss. This new certificate of registration, which I have been campaigning towards for many years, now means that families like my own can have their child officially recognised. This change has come about thanks to the great work of my colleague Tim Loughton MP, whose Private Member's Bill (2017-2019) and review committee that I was part of, lobbied government to make this important change. As a pre-24-week bereaved mother, I understand the pain and rejection that many feel when our baby's passing isn't recognised as a death. I hope these certificates can help to bring some closure to grieving families, help them to feel heard, and have their babies' passings respected and recognised.

Labour's new deal for working people

For fourteen years, the Conservatives have failed working people and undermined the foundations of a good life: the biggest hit to living standards on record; over a million people on zero-hours contracts; and families pushed to the brink as costs spiral. Labour has a plan to make work pay. Our New Deal for Working People will boost wages and make work more secure. Labour's New Deal will: ban zerohour contracts; end fire and rehire; ensure a genuine living wage; guarantee basic rights from day one; give stronger, properly enforced protections at work; strengthen sick pay and extend it to low paid workers; and tackle the gender pay gap. Labour is a pro-worker and pro-business party, which is why our New Deal will help to keep more people in work, improve worker wellbeing, and put more money in working people's pockets to spend, boosting economic growth, resilience, and conditions for innovation.

Having ran for MP 16 times, in various seats around the country, Galloway's motivations to represent the people of Rochdale clearly boil down to little more than his overwhelming desire to represent himself.
