

- what further issues you think I should be addressing.




Constituency problems - update

There continues to be an increase in the number of constituents seeking my help with their problems.

New cases breakdown – August 2023

In August I took action on **656** cases and recouped **£179,005** for constituents. In 2023 so far I have recouped **£244,644.06** for constituents.



Case summaries:


A mother with autistic children living in Camberwell contacted me because she
had been without electricity in her Council property for 6 weeks due to a fault.
Her family had to use battery-powered torches for light and black mould and
damp had developed in her bathroom because they couldn't turn on the

extractor fan. My constituent contacted Southwark Council but they had still not resolved the issue. I wrote to Southwark Council to request that they urgently undertake the necessary repairs. The Council carried out the repairs and restored electricity to the property.

- I was contacted by a Peckham woman who had been living with a friend for several years but was asked to leave the property and became homeless. She told me that she had contacted Southwark Council about her homelessness but did not receive a satisfactory response. I urgently wrote to Southwark Council on her behalf to ask whether she could be housed in suitable council accommodation. I was then contacted by my constituent who confirmed that she had been given temporary accommodation in Peckham.
- A woman living in Camberwell contacted me to report concerns about bus idling and noise pollution around Camberwell Bus Garage. I shared the woman's concerns with the bus company Abellio London and received a response outlining the steps that they have adopted to monitor and reduce idling and noise levels. I shared this response with my constituent who has confirmed that the issues have now been addressed.
- A Southwark Council tenant wrote to me about a water leak at his home that
 was causing damage to the property. I wrote urgently to Southwark Council to
 ask that they repair the leak as soon as possible. Southwark Council confirmed
 that following my contact they had carried out the repairs to stop the leak and
 offered my constituent £183 compensation for the delay in resolving this. My
 constituent confirmed that the repairs had been completed satisfactorily.
- A man living in Peckham contacted me for help with his daughter's passport application. He had applied for a British passport for his daughter and had submitted her Spanish passport to support the application but the Home Office had yet to return the documentation to them and the family were now unable to go on holiday without the passport. I wrote to the Home Office to request an update on the progress of the application and to ask that the Home Office return the child's Spanish passport to enable her to travel. I received a response from the Home Office confirming that the Spanish passport had been returned to the family and that the British passport was issued.
- I was contacted by a Camberwell man who objected to a parking fine of £60 that he had received from Civil Enforcement Ltd at Butterfly Walk Carpark. He had attempted to appeal the fine as the parking meter was not working on the day he received it but he had not received a response to his appeal. Instead the case was escalated by Civil Enforcement Ltd to a debt collection agency and the amount owed increased. I wrote to Civil Enforcement Ltd about my constituent's case and as a result the original fine and additional fees for non-payment were written off, a total of £170.
- I was contacted by a Peckham man for help because he was due to become homeless after Southwark Council issued a Notice to Quit. I urgently wrote to the council asking for them to outline what support is available to him to ensure that he does not become homeless. I was then contacted by my constituent who informed me that he has since been given temporary accommodation in Camberwell.

 A Peckham woman wrote to me because she has been acting as a carer for her sister for four years without a day off and was having difficulties seeking support from the Council to enable her to take some time for rest and recuperation. I wrote to Southwark Council on her behalf and they agreed to review her care package. As a result, my constituent's sister now receives twice daily home calls, and she attends a day care centre two days per week to enable my constituent to take some time for herself and to feel supported in continuing her caring role.





In August I received 494 emails from constituents on policy issues including:

- <u>Support Shelter's campaign to end the housing emergency</u> I agree we need to build more homes and put affordable housing at the heart of the solution
- Ban E-collars for animals I support a ban on the use of electronic shock collars
- Push the Government to go further to tackle the climate and nature crisis I oppose the Bill, which threatens teachers and nurses with the sack, attacks fundamental freedoms of working people and does nothing to resolve problems affecting our services.
- <u>Support onshore wind</u> I supported amendments to the Energy Bill in favour of onshore wind.
- No new oil and gas projects in the North Sea I share concerns on this issue.
 The Government's plan for new exploration in the North Sea is the wrong answer for the climate emergency.
- Support the campaign for a completely new Mental Health Emergency Helpline
 I support a long-term, whole-Government plan to improve mental health
 outcomes, prioritise prevention, make early intervention a reality
- Support a review of mileage rates I share your concerns and I will continue to monitor developments on this issue closely



Officer charged with murder of Chris Kaba

On September 20th it was announced that the police officer who shot Chris Kaba has been charged with murder. My deepest sympathy remains with Chris' family and I continue to monitor this case closely. It is important that this case proceeds to trial. In accordance with normal fair trial procedure, and to avoid any

suggestion that there will not be a fair trial due to the case being prejudged, I will be

making no further public comment on the circumstances of this

case.

Incident at Rye Lane Hair and Cosmetics

I am aware of the incident on Rye Lane on Monday 11^{th} September and remain in contact with the local borough police commander on this issue. I visited the area on Saturday 16^{th} September.



Farewell Camberwell and Peckham

On Friday 15th September I attended a social with local Councillors and my

successor Miatta Fahnbulleh to say farewell to Camberwell and Peckham Constituency Labour Party. At the next election the boundaries will change, and the consituency will become Peckham.

I owe more than I can ever say to Camberwell and Peckham Labour Party. I can never thank everyone enough and I have complete trust and confidence in Miatta to be an excellent MP for the new constituency of Peckham.




Protesting against planned railway ticket office closures

For many people, public transport is essential for their independence and ability to be

part of society. But using public transport such as trains requires support from the hardworking and vital staff who operate ticket offices at stations. Under current proposals almost all of England's 1,000 ticket offices are due to be closed, with offices remaining open at only the very busiest stations and interchanges. It would mean that major stations in Camberwell and Peckham, including Denmark Hill, Peckham Rye and Queens Road Peckham, would have their ticket office opening hours affected.

I wrote to the CEOs of Southern and Southeastern expressing my concern and opposition as part of the national consultation on this issue. I hope that Ministers will listen to the strength of




Election for Chair of the Committee on Standards

Commons is eligible to cast a vote.



Dear Colleagues

After strong encouragement from colleagues across the House and because I feel both enthusiastic about the role and honoured to be approached by others to do it, I have decided to put myself forward to stand for election for Chair of the Committee on Standards.

As you all know this committee has a clear and specific remit: it is tasked with considering complaints referred to it by the Parliamentary Commissioner for Standards and for overseeing the work of the Commissioner. The vacancy has arisen because Chris Bryant has joined Labour's Front Bench.

The Committee on Standards plays a vital role. What we do, how we manage our inquiries, the outcomes we reach and how we communicate about them is important in restoring and maintaining confidence in Parliament, MPs and our democracy. We must be absolutely fair to MPs and demonstrate integrity to the public.

I'm putting myself forward because:

- 1. I will chair the committee in a totally non-partisan way. I will work collaboratively with all members of the committee and I will always strive to seek consensus, as I did in the recent Privileges Committee Inquiry where we came to a unanimous decision.
- 2. I will chair inquiries in a timely manner, and will ensure that our inquiries are forensic and fair.



3. I will bring to my work as Chair my experience as Leader of the House, Shadow Leader of the House, Solicitor General and Chair of Privileges.

My only aim is to do a good job for the House and for all Members of the House, so that we can contribute through our work to ensuring a strong democracy that enjoys the confidence of the British people.
