## Overview

### Context

This document defines Landcare
Tasmania's high-level vision for the next 5
years. It is intended to be read in
conjunction with Landcare Tasmania's
operational plans which are prepared
annually for each financial year. The
preparation of this document has been
informed by feedback from our members.
We thank Landcare Tasmania's staff, Board
and Members Council for their
contributions in preparing this plan.

### Role

We are the peak body that works to represent, support, strengthen and grow the grassroots community Landcare movement in lutruwita/Tasmania.

Since 1994, Landcare Tasmania has been empowering people to make a difference. Our members are people in local communities who volunteer their time and resources to care for our land and coasts, waterways and wildlife. They are supported by a community of donors, and our broad network of technical experts, partners, and supporters.

Landcare Tasmania is a non-political, not-for-profit charity and Registered Environmental Organisation.







# Purpose

The purpose of the Association is to represent, strengthen, support and grow Tasmania's community Landcare movement.

### **Objectives**

The objects of the Association are to:

- promote Community Landcare;
- connect people and organisations with an interest in Landcare;
- support Landcarers with administration, information and funding;
- represent Community Landcare as an advocacy body; and
- establish and maintain a public fund to be called the Tasmanian Landcare Fund for the specific purpose of supporting the environmental objects/purposes of Landcare Tasmania.





### How we work

#### **Board**

Our volunteer Board members are selected based on a skills-matrix and elected by the membership. The Board is focused on organisational governance. The Board and Members Council both have subcommittees and working groups for various projects.

#### **Members Council**

The volunteer Members Council is a standing subcommittee of the Board that provides advice on strategic direction, represents the members, and is actively involved in many of our initiatives.

### National Landcare Network

The National Landcare Network (NLN) is the representative body for Landcare groups across Australia and works to provide a voice for Landcare at the national level. Landcare Tasmania is a member of the NLN with representatives on the Board and Members Council.

#### Staff

Management to deliver the strategic direction, and to provide the services members need, is delegated to the CEO and delivered by a small team of staff, totalling approximately 4 FTE plus extra project officers when required by funding agreements.

#### Volunteers

Volunteers are the cornerstone of the community Landcare movement. The role of Landcare Tasmania's office and event volunteers is to support our day to day operations, which includes data entry, phone calls, content writing, fulfilling shop orders, event support, and more. This is in addition to the thousands of volunteers on the ground and on the committees of our 300+ member groups.



## Members

An important feature of Landcare Tasmania is that our members operate independently. How they organise themselves and what they choose to work on is largely determined by them. We provide guidance and resources to ensure they can take effective action and ensure safety.

#### Groups

Group membership is available to groups of people large and small, incorporated or unincorporated, working on private or public land, as long as their aim in joining is to improve the health of our landscapes.

Community Groups: Landcare, Bushcare, Coastcare, Wildcare, "Friends of" groups, wildlife care & rescue, Tasmanian Aboriginal groups, issuefocused groups or other volunteer groups

**Property-Based Groups:** Landowners and managers who aim to involve friends, family, and/or people from the wider community as volunteers

**School Groups:** Groups within or associated with a school, working with students

#### Individuals

Any individual can become a member. Many join to support the community Landcare movement. Others join to get support for projects. Individuals do not have voting rights.

#### **Associates**

Associate membership is open to organisations such as businesses, councils, and other community groups and people who do not meet the requirements of being a community care group or an individual member.

Associates do not have voting rights.



### Our Fund



### Tasmanian Landcare Fund

The Tasmanian Landcare Fund (TLF) supports all of our programs, including our core member services as well as much needed grants directly to member-driven projects. Landcare Tasmania Inc. is a charity registered with the ACNC and listed on the Register of Environmental Organisations. The Tasmanian Landcare Fund (TLF) is our public fund, which can receive tax deductible donations.

The Board acts as the management committee of the TLF, ensuring that all funds are managed in line with the Constitution and objectives of Landcare Tasmania, and in accordance with our status as a Registered Environmental Organisation.

In grant rounds awarded to members, an independent technical panel of experts assesses each round of member applications. Members can submit an expression of interest for funding and support at any time through our Project Bank. We administer one round of grants per year. All grants are value-added by members who volunteer their time and other resources.

### **Donors**

Our community of donors is vital to the success of community Landcare.

Donations not only help with project funding, they help us raise the voice of community Landcare, attracting funding partnerships and collaborations to add even more value to the dollar. Importantly, all funds raised stay in Tasmania.

Donors can view all projects seeking funding via our Project Bank.



## Context

### Think global

The community Landcare movement sits at the important junction between people and nature, and is indeed an international movement.

There is increasing global attention on the intersection of social, economic and environmental health and wellbeing, as seen by the launch of the **UN Sustainable Development Goals** (2015) and the **UN Decade on Ecosystem Restoration** (2021).

The community Landcare movement is well-placed to play an important role in supporting change. A report released by Landcare Australia and KPMG in 2021, 'Building resilience in local communities: The wellbeing benefits of participating in Landcare', found significant wellbeing benefits from being a Landcarer, including higher mental and physical health.

Over the next 5 years we aim to report on our alignment with the **Decade on Ecosystem Restoration** principles, and the relevant **Sustainable Development Goals.** 

# SUSTAINABLE DEVELOPMENT GALS



### **Act local**

At Landcare Tasmania, we work to guide our programs and our members towards best-practice actions referring to many established guidelines and standards. We seek significant input from leaders in ecosystem restoration, regenerative agriculture, volunteer engagement and environmental education. Many fields we work in are still emerging. Our programs are dynamic and are continually refined based on available information and resources.

As part of our ongoing review, over the next five years Landcare Tasmania will work to report on our contributions and alignment with several national and statewide frameworks, including, but not limited to, the regional NRM strategies, the National Standards for the practice of ecological restoration in Australia (SERA, 2018), and the The National Standards for Volunteer Involvement (Volunteering Australia, 2015).

- 1.2 We link members with local Aboriginal organisations to incorporate traditional cultural knowledge and land management practices

- 1.4 We direct external funding and facilitate projects at larger scales, to align long-term environmental outcomes over entire catchments and bioregions
- 1.5 We combine training and info sessions with on-ground actions to maximise impact and minimise risk of project failure
- 1.6 We monitor and report on immediate and long term outcomes of our projects
- 1.7 We assist our groups to implement best practice environmental management frameworks and standards in their work
