VERMONT WALK BIKE SUMMIT Transformative Transportation: Bridging Active Transportation, Recreation, and Community Development

The 2024 Vermont Walk Bike Summit Committee invites you to share your expertise and creative endeavors at our upcoming conference. We are planning to meet in person, and there will be a mix of inside and outside meeting space available. We encourage you to think outside-the-box to design sessions that can be conducted partially or completely outside (e.g. in an available outdoor "room," while walking or biking, etc). At least one presenter should be available in person. Innovative session formats, such as facilitated roundtables, live polling, or discussion groups, are encouraged.

This year's Vermont Walk Bike Summit will focus on the intersection of purposeful transportation, restorative recreation and beneficial economic development, and is inspired by the transformative power of large infrastructure investments, such as the Lamoille Valley Rail Trail. Vermont is home to four rail trails, three rails with trails, a bike ferry, a U.S. bicycle route, a slew of hiking trails, and paved paths with more facilities to come. We seek to give voice to the catalytic opportunity of such infrastructure to invite folks to explore walking and biking in different, perhaps previously inaccessible, ways and spaces; inspire communities to promote accessibility for all transportation users to this infrastructure and host these users; and overall promote a more inclusive active transportation landscape. *In short, how do we ensure that Vermont stays true to the "triangle": Transportation, Recreation, and Economy?*

We anticipate organizing presentations into the following tracks, but encourage proposals that explore the linkages between the themes of transportation, recreation and economy through new and inspiring frames. Program tracks will be finalized after receipt of proposals.

- 1. Active Transportation and Recreation How can Vermont's purposeful active transportation system leverage recreational facilities enjoyed by Vermonters and worldwide guests to provide safer and more accessible transportation for everyday living?
- 2. Community Development and Tourism What opportunities exist for these recreational and transportation facilities to economically benefit communities?
- 3. Equity and Accessibility How does equitable and accessible design benefit all users as well as the local community?
- 4. Planning, Design and Maintenance
