3. State the reasons why you believe the decision is unreasonable or inappropriate.

As per Council's submission, the proponent has failed to fully consider the Traffic Impact Assessment associated with the activity, specifically -

1. Accessing the site through an unconstructed road - this is likely to leave Council with an unreasonable cost burden in upgrading a road for no critical community purpose.
2. Accessing the site via an intersection (Unconstructed Road/Peak Downs Highway) that has not been suitably designed to cater for the increase in project traffic and nature of project traffic e.g. long vehicles carrying drill pipes. This creates an ongoing road safety issue that needs to be considered.


