#### 1. READING AND APPROVAL OF PREVIOUS MEETING'S MINUTES

#### 2. OFFICER'S REPORTS

##### a. Chairman

- i. The ballot access signatures were not duly processed by the state, with “understaffing due to covid” as the reason given. Many Town Clerks did not pass them up to the Secretary of State.**
- ii. As the state has failed in their duties, the Lewis Campaign has launched a lawsuit to hold the state accountable and hopefully create change for the future.**

c. Secretary

- i. **The current Roster includes 422 total members, 175 Regular Members, 235 Associate Members, and 12 Lifetime Members. This is an increase of 3 Associate Members, no change in Regular Members and no change in Lifetime Members since the previous roster report on September 26 2022.**

### 3. COMMITTEE REPORTS

a. Strategy and Goals Committee

- i. Survey is being discussed in Discord and is almost finished. It will be shown to the SCC before being sent out.
- ii. Webpage overhaul will be put on hold until after the CRM migration.

b. IT Committee

- i. Received confirmation from National that we are good to go on CRM migration.
- ii. Calendar and officers for New Haven County duly updated on website.
- iii. Text messaging through NationBuilder is going through a shift because of new laws with stricter regulations requiring more info to be submit by text message providers on whom we are messaging. As we are planning to migrate to CRM in the near future and could save 50\$ a month in the meantime, we may consider waiting until the migration is finished to begin text messaging services again.
