- a. Strategy and Goals Committee

- b. IT Committee
  - i. Our current NationBuilder site will continue to be built out. After the 2022 election we will explore merging the site with a WordPress-based CRM.
  - ii. Need to update candidate info on site.
- a. Legislative Research Committee
  - i. Interest in joining the committee has been expressed. A meeting will be held with the interested individuals soon.
- b. Finance Committee
  - i. Still working on finding a new Deputy Treasurer as an important contingency to the Treasurer.
- c. Media Committee
  - i. Looking for additional members to manage accounts on additional social media platforms.
- d. Elections Committee
  - i. Following up with member interested in running for local office.

### 4. NEW BUSINESS

- a. Important to note that town clerks can and are required to notarize all ballot access signature submissions for their respective town. – S. Dincher
- b. Spike Cohen is available the weekend of September 10-11 to speak at an event for us if we are able to put on something relevant. In lieu of such an event we will let Spike know ASAP in order to respect his schedule and work with him on a different date. – S. Dincher
- c. The formation of a standing Event Planning Committee with a concrete schedule for putting on events would be a great asset going forward. – S. Dincher
- d. A template based on successful past events to be used as a support/guidance for the planning of future events can be shared with any member who is interested in putting together an event. – B. Cousins
- e. 2023 will be an opportune year in the election cycle to focus events geographically on candidate support. – S. Dincher
- f. The SCC Discussion Chat on Discord can be used to brainstorm and gather momentum for event planning. – S. Dincher
- g. Ballot access funding – S. Dincher
  - i. Motion by S Dincher to release the remaining \$1700 earmarked for ballot access to the Lewis campaign.
