1. READING AND APPROVAL OF PREVIOUS MEETING'S MINUTES

The reading of the minutes was waived by a motion from the chair without objection from the membership.

2. OFFICER'S REPORTS

- a. Chairman
 - i. We had a front-page article of Saturday's Hartford Courant with quotes from both Mike Liebowitz and Steve Dincher, and with some general discussion of the party's ethos and objectives as well. It was a fair representation and had a favorable perspective.

 - i. Last Balance = \$16,809.51

 - ii. Have made a few suggestions as follows (per the meeting minutes posted to Discord):
 - 1. Set up an ad-hoc events committee to operate under the direction of the S&G committee to organize and support the affiliates in organizing outreach events
 - a. Recommended 4-5 members
 - b. Recommended that the events committee be authorized to engage in fundraising activities to support events
 - c. Various opportunities for events were discussed
- b. Expand the State Media Committee to facilitate greater focus on social media
 - i. Recommends consideration of hiring a social media manager
- c. Other outreach opportunities include:
 - i. Radio/Podcast
 - ii. Mail/Email
 - iii. Newspaper/Patch
 - iv. Telephone
 - 1. An update on the machine of knowledge was requested
- d. Main objectives of the Libertarian Party were discussed as follows:
 - i. Run candidates
 - 1. Various ideas for identifying candidates and winnable races were discussed
 - ii. Pass/advocate legislature
 - iii. Increase membership
 - iv. Increase funds
- e. IT Committee
 - i. Nothing to update at the moment, will likely make headway with migration in coming months.
- a. Legislative Research Committee
 - i. No new updates since last month

- ii. April and May are busier months for this committee's focus, planning to meet again May 9th
- iii. There is a strange piece of online bullying of politicians focused legislation which Republicans are garnering momentum by speaking out against
- iv. Committee will look for anything related to 1A and 2A, as well as any tax increases for us to speak out against

4. NEW BUSINESS

He has also reached out to the Democrat and Republican Parties.
 - ii. The Secretary will reach out to him and offer to connect him with the Chair; if he is still looking for an internship we will find somewhere to put him to good use.

b. Hybrid SCC Meeting
