

Get out and Vote!

It's time we make election day count

It would be comical if it wasn't so consequential, watching the two parties paint the stakes as successively higher each year, should the horrible event come to pass where the other party wins, that is. Then we rinse, wash, and repeat,

Despite this, I am here to implore you, please, go vote, and vote Libertarian! All we have is our grassroots drive, fighting for each inch, to take back the power from the politicians, and voting is the quickest way to advance this cause.

The game is so rigged it isn't even cute anymore

Over the last few months I got into a bit of a Twitter back-and-forth with Kyle Parrish, a useful idiot running for NC's 5th as a house candidate. I'm not one to shy away from some verbal sparring, but I don't look for it either; I went after Kyle because, unprovoked, he was spouting off really disgusting things about Libertarians in general, and attacking David Coatney, Libertarian NC House candidate, over some manufactured nonsense (not fit to reprint here, this newsletter is far too classy for his drivel).

David is well-equipped to handle himself, to be clear, but this unprovoked nastiness demanded attention, and many members of the LPNC joined in over subsequent weeks. For my part, I tried to be respectful (mostly), and consistently challenged his points, even asking him repeatedly if he would debate me. Eventually, after ignoring, deflecting, hiding, and cowering, he blocked me, and that saga ended (for the moment).

I am writing this to convince you to vote, though, not to repeat some silly story about a Twitter fight. I mention it because Kyle has about as much of a chance of winning his race as I do, and I live in Mecklenburg and am not on the ballot. Nevertheless, he attacks anyone not on Team Democrat, viciously, repeatedly. He spews vile and hate-filled rhetoric, mostly against Republicans, but with a healthy dose of anti-Libertarianism in there, and then occasionally asks why the country isn't more united, and says "only Democrats" can bring us back together.

Again, none of this should come as a surprise to anyone reading this. The only thing the two sides of the uniparty seem adept at is spitting venom at anyone on the other team. Even within the party, Kamala **cackled like a stoned hyena** when Colbert asked her about disparaging remarks she made about the man for whom she would eventually work as Vice President. Her excuse, "it was a debate," is a perfect example of how the political game is designed for the players

to go all-in to win, only to win, and to win at all costs. This is not unique to either major party, and it is not going to change as long as the prize is more power to hoard.

Kyle learned that he was a pawn in a game here (<u>right at the 10-minute mark</u>), and it is almost enough to make me feel bad for him. As a worthless candidate with no chance of winning, the party for whom he parrots and champions has done essentially nothing to support him, a fact he laments a bit, not realizing how damning his self-pity is as it speaks to the broken system as a whole.

They would never spend any money or resources on someone who can't win for them. It's about winning, none of the leaders of the other two parties care about principles.

Libertarians can make a difference in a way we never have before

Recently, we received some of the greatest news of 2022 – North Carolina became the second state in the U.S. to <u>pass 50,000 registered Libertarians</u>! Trailing only California and its massive population, we are at the vanguard of the Liberty movement. Our message is the right one, and it is spreading

Of course, this is not something that happened overnight. Rather, it is the diligent work of dedicated LPNC volunteers who have pushed us this far <u>for years</u>. And it is immense progress since 2008, when North Carolinians <u>regained the ability</u> register as Libertarian.

I readily acknowledge that this game is rigged. I understand your hesitation to vote, and your concerns that you are throwing a vote away or even validating this broken system that crushes people in its own relentless power hoarding. But sitting back and doing nothing guarantees the outcome.

Instead, have some hope, and a little faith, that our message, the right message, will win more hearts and minds, and we will grow organically, regaining the power that was taken from us. One way to help do that is to vote Libertarian.

Voting matters. It matters for ballot access, it matters to uniparty candidates who think we are spoiling their elections, it matters for making Liberty issues prominent on voters' minds, and it matters to cement our position as serious participants in this conversation that has been hijacked by partisan self-interest.

So go vote. Then come join us for an election party, or come to a protest against State tyrant over-reach, or just donate \$5 a month if that's what you can do (if every registered Libertarian donated \$5 monthly, we would bring in \$2.5 million annually, which is still not even a hundredth of uniparty spend in NC in 2020, but we could do a lot with it). Then, keep voting, and keep showing up. Find a place to volunteer. Recruit someone else. And vote again. We <u>will</u> win if we don't give up.

To **quote** WakeLP Chair Travis Groo, "...it's a gold rush. Vote gold!"

I am running to return the power of personal choice to the citizens of district 14 and the state of NC. I want to give parents greater freedom to select the best educational options for their children by expanding educational savings accounts, scholarships, and vouchers. I want to reduce or eliminate zoning and land use laws so that people can maximize the economic benefit of their private property and developers can create the quantities and types of housing that are needed to increase

supply and decrease the price of housing in our state. I want to eliminate unnecessary occupational licensing regimes that put a stranglehold on people's ability to leverage their natural talents and build wealth for their families, and I want to create an economic environment in this state that allows for new and innovative businesses to easily emerge and flourish. Lastly, I want to reform our criminal injustice system to bring it back within its constitutional guardrails. Half of the ten amendments in the Bill of Rights are specifically written to make it difficult to put people in cages, yet our state government imprisons a greater percentage of our NC population than almost every other developed nation and even some dictatorships in the third world.

We must end no knock warrants, curb pre-trial detention so that it is the exception and not the rule, limit our prosecutor's ability to utilize the plea bargaining process to coerce people out of their day in court, end qualified immunity so that government employees are liable to the same constitutional standards as citizens, and we must end the heinous practice of federal asset forfeiture sharing

so that our law enforcement agencies are no longer criminals using citizens like an ATM machine whenever they need funds. I believe that the vast majority of our police are good, hard-working people that truly want to build trust with our communities, but we will never build that trust until the management of law enforcement agencies and prosecutors demand that the minority of bad actors stop being the bad guys and behave properly. Personal choice, freedom and liberty, and a society free from fear of government harassment is the roadmap to a better society. Peace and prosperity occur only when individuals are free to make rational choices for themselves, their families, and their communities, unimpeded by excessive government regulation.

North Carolina has the most restrictive and expensive state system of alcoholic beverage control in the nation.

Some of the costs are paid in the form of a "tax" through higher operating costs, and unreasonably

high monopoly salaries for local ABC officials. But much of the cost is paid through inconvenience and nonsensical restrictions on local access: our state has less than half the number retail outlets enjoyed by the surrounding southern states. There is no reason the state should maintain a monopoly on retail sales; private stores can take over this expense, and allow people to buy nearer their homes without driving 20 or 50 miles.

Many people object that having a high price deters excessive alcohol use; if you believe that, it is still time to end the old-fashioned and wasteful ABC. We can impose an alcohol tax that will keep prices about the same after privatization. The difference is that this tax will collect revenue, rather than the current "tax" of having to drive 30 minutes each way. The tax revenue can be used to expand opportunities for school choice in rural areas, communities that until now have depended on the state monopoly on education. If we are careful, we can offer better choices and increase personal responsibility in both alcohol sales and education in rural communities.

Government should, in most cases, get out of their way. Special interests should not dictate what choices are allowed. And no one should get special treatment.



Book Review

The Bitcoin Standard, by Saifedean Ammous

Many consider *The Bitcoin Standard* to be the "Bible" for Bitcoin, and I can see why. The majority of the book is actually focused on the history of money and what makes money valuable, which is really important to understand if you are going to understand the case for Bitcoin. Ammous' writing style is engaging, and his love of Austrian Economics comes through loud and clear, which I appreciated. He takes aim at both Keynesians and Monetarists, since both see a role for the State in regulating the money supply, albeit to different degrees. As I read, I realized how little I actually knew about the history of money; such things as sea shells, glass beads, and heavy stones had

been used in various civilizations, which had subsequently suffered economic catastrophes with the inflation of their money supplies when someone figured out how to easily make/find more of the "money."

The book doesn't get into the tactics of how to actually buy and store Bitcoin, but it does present a compelling case for Bitcoin as the best money we have, particularly from the "store of value" perspective. A money's "store of value" is largely based on its stock to flow ratio (stock = existing supply; flow = new amount created). The harder it is to create new amounts of the money, the higher the stock to flow ratio, and the more likely the money will be a good store of value. This is how gold became the standard across the globe for millennia. And this is why Ammous argues that Bitcoin could be "the best store of value humanity has ever invented."

This was a fantastic book that I found to be an easy read, explaining concepts in layman's terms, while not losing the substance of the argument. I highly recommend this book for both the interesting history as well as the introduction to the case for Bitcoin.

In Defense of Self-Defense: a Practical Matter

Many words have been spent in defense of the 2nd amendment. Those words often focus on philosophical and judicial reasoning. In recent years, those words created strong arguments which led to great strides in our freedom to defend ourselves, such as in the decisions of Heller vs DC eliminating the outright prohibition of owning firearms in the home, or Bruen vs NYSRPA which essentially makes every citizen able to carry a firearm outside the home, through shall-issue permitting.

Discussion of Supreme Court cases, congressional action, and executive order, among other massive federal-level interventions, we sometimes we drift away from why these legal and political arguments are discussed with such gravitas. Stuck on the philosophy, we forget the practical reality that 2A enables individuals to defend themselves against aggressors. Today, I want to focus on the practicality of self-

defense, of which the 2nd amendment is the absolute guarantor for all US citizens. In this discussion, I wish to take a closer look at guns and gun ownership on the individual level. How and why is a single gun beneficial to an individual person?

First, I propose this question to the readers: If you could snap your fingers and get rid of every gun in the US, legal or illegal, would you do it? You may think "yes of course! No more drive-by shootings, school shootings, or rampantly armed criminals!" It is my experience that many people, especially those who do not own guns for self-defense, think about guns almost exclusively from the perspective of criminals. Worries about what harm criminals and other bad-faith actors might promulgate dominate people's minds and the gun-rights conversation.

Lost in this rumination is the reality of what an otherwise peaceful citizen can do with a gun. Guns are the great equalizers. Criminals have the privilege of preparation, thus theoretically putting them at an inherent advantage. They get to ensure they have superior size, strength, speed, age, numbers, weapons, aggression, positioning, and timing. As a general rule, confrontation with a criminal is an ambush, often placing the defender in the least ideal position to survive the fight and forcing the defender to overcome the disadvantage of reacting to a surprise attack.

A firearm, especially combined with training on how to use it, gives the defender a fighting chance by negating or eliminating the criminal advantages discussed above. Think about it this way: if you were only able to land one hit against your attacker do you want that hit to be a punch or a bullet? Sometimes in an ambush we only get one shot, best make it the most effective one you can.

Guns are so effective at stopping fights, they enable entire segments of the population a brand-new ability to live without fear. Elderly, disabled, petite, and non-aggressive individuals can now deliver deadly force with the same level of potential effect as the Navy SEAL, the terrorist, the seasoned criminal, or the SWAT officer. It's unlikely an elderly or permanently disabled person can train enough to overcome their natural disadvantages in a hand-to-hand fight. Petite or pacifistic individuals might have neither the time nor the inclination required to dedicate to becoming skilled in a martial art or other self-defense technique needed to escape such a violent encounter unscathed.

Guns reduce the entry cost of self-defense. This is quite literal in the financial sense; a few hundred dollars can get a person access to a basic firearm that is often more than enough to save that person's life. The cost of each of the many classes it takes to learn hand combat defense adds up quickly, and is likely to easily hit the cost of a middle or possibly high-quality firearm.

The entry cost is not just financial, however. One must also consider the time commitment of each defensive tool. In a world where no firearms were available to defend oneself, one would need to spend many hours over months or years to

become proficient enough at retreating, fighting, and defending in a close encounter to survive, much less win, against an attacker with inherent physical and tactical advantages. With a firearm, safety can be relatively easily taught to a basic level of proficiency, giving the defender infinitely more potential for not just survival, but triumph in a violent encounter.

Theoretically, as soon as someone purchases a firearm, that person's odds in a life-or-death fight increase substantially. In actuality, training is generally necessary to employ a firearm with consistent competence. That said, each training session on the gun range pays way more dividends than any single training session in a martial art, such as BJJ or Krav Maga.

To be clear, this is not to denigrate the martial skills, nor to discourage people from training. Certainly, any well-rounded defender has the ability to physically defend him/herself long enough to employ a firearm. There is an endless list of scenarios where a person's physical skills are called on long before or even instead of his/her firearm skills. The difference between minimum necessary gun skills and minimum necessary martial skills can be compared to the difference between learning to play an instrument and learning how to use an mp3 player.

It is clear there is great value, at the individual level, of owning and carrying a gun for defensive purposes (and there are countless examples supporting this). Guns enable us to be equal in an otherwise unfair fight. They give a lifeline to otherwise helpless victims, making an armed society an equitable society. Further, firearm possession enables freedom and encourages individualism. That is why, if I could push a button and make every gun disappear, I'd push the button next to it, putting a decent weapon in every citizen's hands.

Libertarianism has a long, rich <u>history in North Carolina</u>. As we build the cause of the liberty for the future, we will always remember where we came from and those who worked to get us here. "Libertarians are different because we believe that the Golden Rule, an idea shared by people and cultures all over the world and throughout history, not only applies to one-on-one relationships but to all human relationships and to relationships among nations. We are different because we mind our own business. We're different because we insist on leaving people alone."

As Libertarians, we believe that our philosophy of self-ownership and non-aggression, when soundly understood and properly applied, maximizes our human potential to prosper by creating a space for individual freedom to flourish.

With a homicide rate of about 5 per 100,000 (lower than in the 1970s and 1980s), 99.99% of Americans did not die from gun violence in recent years; Americans are 10 times more likely to die from unintentional injuries than from homicide. 99.999% of school children are not killed in school shootings; 100 times as many children are killed in auto accidents. People are emotional and respond to stories; we're not designed to analyze big numbers. When people use one anecdote to convince others why we should have guns for protection or get rid of guns for protection, it may seem convincing, but the argument may not be as strong as it seems.

I have Libertarian tendencies and don't think the government needs to tell people how to live their lives. I don't think changing gun laws are going to make people appreciably more or less safe. I do think that being a role model is an appropriate way to try to influence others. I think our country would have a greater positive influence in the world if we focused more on being a good role model and less on using guns and violence to influence life in other peoples' countries.

As far as I am concerned, you should decide for yourself whether having a weapon that could protect or injure you or a family member is something you want to keep around. I don't have guns; I don't need guns to feel safe in America.
