Charity Lasagna Luncheon for Pastor Moses



Since October of last year, the LPNC has been supporting the efforts of Pastor Moses, whose selfless ministry to people who have the least was shut down by the City of Gastonia. Pastor Moses spoke out after Gastonia police arrested Iraq veteran Joshua Rohrer for being homeless, an event which led to the death of his service dog, Sunshine. The city shut his church down shortly after.

Pastor Moses is raising money for his ministry to the homeless, including efforts to transport two donated trailers, which he will use to provide shelter and much more.

On Saturday, December 10, LPNC Treasurer Mike Ross displayed extraordinary culinary talents, making a huge lasagna meal for a fundraiser co-hosted by Pastor Moses' ministry and 2020 Libertarian Vice Presidential nominee Spike Cohen's organization, You Are the Power. Mike has been leading the charge for justice for Joshua and Pastor Moses from the beginning, and Spike has been perhaps the biggest advocate, tirelessly showing up to city council meetings and other events.

Pastor Moses told the Tarheel, "What we're doing at this fundraiser here today, it really lifts our spirits because of what a big help it will be to the homeless and to the needy community, and I'm just excited. You have no idea, to have guys like Mike, and Joe, and Spike, and Brandon and all the guys that came out today to help support this cause, it's priceless. I'm so humbled, I'm so honored, and I'm so thankful, especially when I think about how it's going to get cold here in the next few days. Having these trailers is imperative to keep people safe and help preserve life when the weather changes."

"And we're going to use them for an educational component as well, so people can get their GED, continue their education, learn a trade. Really, it's limitless what we can do now, having these trailers. Thank you for being here and allowing me to share this.""

The event raised nearly \$8000, which is enough to transport the trailers. However, there is much more to do, and you can contribute **here**.



Chair Chats



Travis Groo Wake County LP Chair

In a year when the number of registered Libertarians has reached record highs in North Carolina, and coming off another incredibly successful election day for Wake, the Tarheel caught up with Travis Groo, who chairs the Wake LP, which has been at the forefront of getting candidates on ballots, running competitive campaigns, and growing the number of registered Libertarians.

We asked Travis, who has been featured in North Carolina media in a nod to Wake LP's success (Libertarians enter most state legislative races in Wake County | Raleigh News and Observer), about who he is, what motivates him, and how he and the members of his affiliate have been able to see consistent improvement in the returns on their activism.

Tarheel: Travis, before we get into Wake LP's well-oiled machine, tell us a little about yourself. Are you from NC originally? What issues are you passionate about? And when did you realize you were Libertarian, and why?

Travis Groo: Thank you so much for taking the time to speak with me, I really appreciate it. I was born and raised in Wylie, Texas, which is just northeast of Dallas. I moved to Florida when I was 15 and finished out high school and college there. I graduated from the University of West Florida with a Bachelor of Arts in Communication Arts/Advertising. After college I moved to Atlanta, GA, and settled there for about 12 years. It's where both of my amazing kids were born.

Atlanta was a great place to live, but the public schools where we were living were not so great. The kids were homeschooled until we moved to North Carolina. I'm settled in here now and so happy that I met my most amazing, coolest, goofiest, and prettiest fiancé in the world. I actually met her at a Wake LP meetup during the pandemic when most of everything was shutdown by government. It was the best thing that's ever happened to me, and during a really weird time in history. This is now my home and where I've decided to plant my roots.

The issues that I am most passionate about are some of the same issues we've been running on in Wake County. I'm huge on school choice and giving parents the full control over their kids' education. Allowing choice in education opens paths to academic success. The right learning environment prepares students for new challenges. It allows students to find a place to excel. It rewards innovative, engaged teachers. It rewards students for their hard work and effort.

I'm also passionate about criminal justice reform, freeing up the healthcare industry, and freeing up people's ability to make a living without government interference. Certificate of Need (CON) laws should be abolished. The John Locke Foundation states that, "The most straightforward and direct effect of CON is that it makes it more expensive, time-consuming, and difficult to open or expand a health care facility and to acquire health care equipment." It's time to free up North Carolina from strict government regulations that stifle competition and makes prices higher. Bureaucrats have a stronghold on the free market and the healthcare system.

I realized that I was a Libertarian when I read the platform and it all made so much sense. The rest is history.

Tarheel: That's an interesting backstory. When did you know that you wanted to be more active, and what made you decide you wanted to Chair an affiliate?

Groo: Soon after registering as a Libertarian during the Trump/Clinton presidential campaign, and we all remember the mess that was, I received a call from both David Ulmer, former Chair of the Libertarian Party of Wake County, and Brad Hessel, all things Libertarian. They invited me to a Wake LP meetup, which is where I made first contact.

I started getting involved with charity and outreach events, and I knew I had found my people. David asked me if I'd be interested in running for public office. With a little arm twisting, I agreed to it. I ran for House District 11 in 2018 and it was a great experience. After that I was elected as Vice Chair of the Libertarian Party of Wake County. I learned so much and became even more involved. Then I ran for Senate District 17 in 2020. I stayed active and I was elected as Chair, and here I am today. Lots has happened in between, and all of it has been a great learning experience.

Tarheel: Have you held any other positions in the LPNC? How is affiliate Chair different?

Groo: The only non-elected position I've held within the LPNC is Chair of the Convention Committee two years in a row. Chair of an affiliate is different because when something goes wrong or the public perception is off, everyone looks at you. Since you're the face of the party as Chair, when things go great people congratulate you, but when things go bad, they want answers and solutions and look to you. There's a huge amount of responsibility in being the face of any organization. Unless you've been there, done that, it's very hard to explain.

Tarheel: OK, on to the important stuff! How is Wake able to drive registration numbers and have so many quality candidates, especially in an area of NC that's not necessarily known for being Libertarian friendly?

Groo: "The proliferation of Libertarian candidates is an attempt to raise the party's profile and encourage Libertarians elsewhere in the state to do the same," I said in an <u>interview</u>. "This has to do with Wake County [Libertarians] being very focused on elections. We're trying to set an example for other affiliates to follow... we want to keep getting bigger and we expect to be bigger in two years."

Basically, we've been focused, driven, and committed to running quality candidates to give voters an option other than the duoply. It's taken years of hard work and a lot of behind-the-scenes stuff that nobody sees. We have a pretty incredible team here in Wake, and I'm so thankful to be a part of it. Without the team effort we wouldn't be able to do this. It takes all of us to get things done the right way. I trust my team and I trust the people around me. I trust the folks that have been around a lot longer than I have too!

Tarheel: What are the biggest challenges you face, and how have you been able to overcome them?

Groo: I think I speak for all of us when I say one of the biggest challenges I face is finding volunteers to do the work. We always need principled Libertarians canvassing, tabling, promoting, and spreading the message of liberty. I truly believe volunteerism is at the core of what being a Libertarian means. The more we volunteer and help our neighbors, communities, friends, and family, the less people feel the need to rely on government handouts and bailouts. If we own ourselves and we are self-governed, we shouldn't need an intrusive government telling us how to live our lives or spend our money.

We certainly don't need another governor telling us what we can consume or who we can love. It's just weird to think that we keep electing people to tell us how to live our lives, when that should be left up to us to decide, the people, and the self-governed. Just don't hurt people, or take their stuff, it's not complicated.

We overcome these challenges by staying persistent and sticking with our principles. Our values guide us, and, if we truly believe in them, the challenges we face don't seem as paralyzing. I'd say to anyone reading, stay the course no matter how hard it may seem. Hard work always pays off.

Tarheel: What is next for Wake LP, and for you?

Groo: What's next for Wake LP is more of the same: recruiting, building, developing, and encouraging others. For me, [editor's note: Travis paused a long time, and smiled here] I don't want to let the cat out of the bag, but I've got a few things in the works. Regardless, I will be active in the party and try to encourage as many of us as possible to keep working hard and stay involved as much as possible. We're all busy and have lives outside of this party, but please do what you can.

Tarheel: Thank you for your time, and for all you do. One final question, what advice would you give other affiliates just getting started to be able to replicate your success?


Groo: My advice is for all affiliates across the state to meet weekly. This creates consistency that is needed. Even if it's super small at first, keep going and keep meeting and it will grow. Have a special guest speaker every once in a while and boost your Facebook events so folks outside of your circle are reached. Promote the events and share them as much as possible. Finally, run quality candidates in your county, city, and towns. Give voters a better option. Surround yourself with greatness!

Book Review

Industrial Society and Its Future, by Ted Kaczynki

"The Industrial Revolution and its consequences have been a disaster for the human race"



The opening sentence of an essay by mathematician turned murderer, Ted Kaczynski, is a bold one and sets the tone for what is certainly one of the most interesting essays I've read in quite a while. Generally one would recoil at the mention of the "Unabomber," yet despite this, *Industrial Society and Its Future*, at 35,000 words, is a surprisingly easy read due to its plain language and a disarming idiosyncratic flair. Kaczynski outlines the fundamentals of a social-political ideology unlike anything in the current zeitgeist. His homily to Neo-Luddism is observant, well researched, and even prescient in some regards. His even-keel delivery is made all the more shocking as it belies the heinous crimes for which he is now imprisoned. The essay is a reflection of a man who personifies the blurry line between genius and madness.

Kaczynski's contention with modernity centers around something he terms "The Power Process" and the ways in which the industrial-technological system and modern society disrupts this process. While his concept of the power process seems a bit contrived, it is nonetheless an interesting perspective. Kaczynki's theory is certainly NOT libertarian. However, neither is it liberal, nor conservative, nor leftist, nor even rightwing. It's altogether different and singular in its focus. With a wide menu of topics, observations, and conclusions, there is certainly a lot to digest with this essay, particularly in the wider context of the times in which it was written. However, don't mistake fascination with advocacy. In his philosophy the author

advocates for violence and in his life, he committed wicked acts of violence in a twisted effort to further said philosophy. With that clarification in place, I would certainly recommend reading it, especially if discussions of political philosophies, controversial ideas, and sad ironies are something that appeal to you.

SHORT Act Summary

The words "gun" and "legislation" rarely appear together bearing good tidings, especially at the federal level. When laws are proposed that do simple things like remove some degree of state interference with your ability to exercise your basic rights, we at the LPNC like to point it out.

Senate bill <u>\$4986</u>, also known as The Stop Harassing Owners of Rifles Today Act (SHORT Act), is a bill that seeks to remove short-barreled rifles (SBRs), short-barreled shotguns (SBSs), and a classification known as any other weapons (AOWs) from the National Firearms Act (NFA). This would eliminate the federal requirement to register such devices with the Bureau of Alcohol, Tobacco, Firearms and Explosives (ATF). It would also eliminate the <u>tax stamp</u> required for each, an amount that currently sits at \$200 per SBR or SBS and \$5 per AOW. Other elements of the bill include requiring the ATF to destroy all records related to these devices and their owners within one year of its enactment, qualifying a background check as meeting all state requirements for the registration and licensure of such devices, and prohibiting future federal or state taxes being levied against such devices. The SHORT Act accomplishes this by removing "shotgun," "rifle," and other similar terms from the definition of "firearm" in <u>section 5845</u> of the NFA.

Representative Andrew Clyde (R-GA) introduced an identical bill in the House of Representatives, known as HR 9033. Clyde's bill is intended to prevent a new ATF rule change to the years' long pistol brace debate. He said, "By deregulating these NFA firearms, this legislation prohibits the ATF from enacting an unconstitutional pistol ban through a simple rule change." Unlike most modern Congressional bills, the SHORT Act consists of just six pages, certainly an element that should make any Libertarian pleased.

Of course, this bill is unlikely to pass, especially with Senate Democrats discussing more gun control as a proposed solution to gun violence, notwithstanding that it occurs in whatever area with already-strict gun control the media is currently panic-pimping. Regardless, we as Libertarians should never stop supporting laws that reduce overall government power and do so using short, easily read bills.

Regardless of all the political maneuvering, I would urge readers to contact your Congressional representatives, and demand that they prove their commitment to our rights by supporting the SHORT Act. It is a positive when laws chip away at the NFA, which is perhaps the worst example of government overreach codified; it limits Constitutional rights and does so while imposing an immoral and reprehensible tax on citizens wishing to exercise that right.

Libertarianism has a long, rich <u>history in North Carolina</u>. As we build the cause of the liberty for the future, we will always remember where we came from and those who worked to get us here. My Planks for the 2020 Election

Fire Mandy Cohen

Pressure the new governor to fire and replace Dr. Mandy Cohen and the senior management team at the North Carolina Department of Health and Human Services.

Zero Liability

Pressure the new governor and state legislature to reverse the lockdown and allow the economy to resurrect itself. Zero liability for commerce means that when businesses reopen, their requirements should be no more onerous than the rules in place in 2019. Every

business, and every business man and woman is essential. We must roll back restrictions to repair the damage from the public overreaction. Regulators of health and safety must consider both the benefits and the costs to frivolous state impositions like obsessive surface cleaning and plexiglass barriers. Businesses can voluntarily take additional safety measures to transact if they perceive inordinate panic in the behavior of their customers. But businesses have no legal obligation to cater to their most paranoid customers, and fickle customers are free to spend their dollars elsewhere for any reason they want.

Jail Cooper

The Governor does not enjoy immunity for crimes. The cause of excess deaths in North Carolina and elsewhere is the illegal response to what we now know is a minor disease. The U.S. economy and North Carolina were shut down based on wildly inaccurate models that predicted 2.2 million American deaths. Since then, millions of North Carolina residents continue to suffer financially, physically, and mentally. Crises are like drugs for those in office, offering Governors the option to retain powers over the public.

Does the Governor have authority to prolong an emergency declaration motivated by virus eradication? The series of absurd reasons for containment permits him to bypass state law and federal Constitutional rights. Cooper, like other Democratic governors who are being challenged in Ohio and Michigan, conveniently expanded his privilege to keep people under virtual house arrest with no legal consequences to himself. He threw North Carolinians under the bus. When will "non-essential" business owners, their employees and their customers get a chance to speak up?

The emergency declaration is an exercise of power that should be reviewed by the courts. The ballot box is an insufficient remedy because the damage has been extreme. If courts are unwilling to review any action based on public health, it's rendering itself useless. North Carolina should not suffer from judicial indifference over Cooper's destructive actions.

If we don't challenge the Governor's decision, whether he is still in office or out, the tyranny manifested under the guise of a COVID-19 response can be applied to a wide array of "public health" issues. That includes obesity, drugs, racism, guns, and rights of association and protest. Not only that, but "public health" indoctrination and propaganda included gag orders, censorship, and tight media control. The federal Center for Disease Control (CDC) even stopped evictions on the grounds of "public health." This is just the tip of the iceberg when one stops to consider a Federal takeover of public health.

CDC confirmed that 94 percent of the deaths attributed to the virus were from people who had as many as two to three other serious illnesses. The majority of those deaths are individuals 75 and older. Six percent of the deaths were directly from COVID-19, according to the CDC. The Governor made a calculated tradeoff to allegedly save lives in the short run while destroying the livelihood of North Carolinians in the long run.

Businesses are struggling, and many will never re-open. Drug overdoses and suicides have increased. Many people were unable to get treatment for conditions not related to COVID-19 because hospitals were closed to accommodate the rush of patients who never arrived. Forcing doctors to make poor decisions for patients does not help public health and clearly violates medical ethics.

Children are struggling because many of them cannot attend school in person. Dentists are seeing a surge in cases of cracked teeth from the rise in tension. Masks provide no real protection against this virus and are promoted as a social-psychological device, not a medical one.

Families have been barred from seeing their loved ones in hospitals and long-term care facilities, and residents in long-term care facilities have suffered because of the lack of in-person communication from their loved one. People living alone, of all ages, have been forced into solitary confinement and are dying at increased rates due to loneliness and lack of self-care.

The courts must end the Governor's crusade and hold him accountable whether he is returned to office or not.
