Previous Minutes:

The previous minutes were then accepted without objection.

Treasurer Report:

LPNC balances are \$35873.85 in the Truist account and \$237.85 in PayPal. The balance in the LPNC Federal account, which the LPNC does not currently use, remains at \$190.54. Income for January 2022 consisted of:

- Convention income \$5547.00. This includes 56 registrations; 54 at \$95 and 2 at \$115. This also includes some small donations and an extra banquet ticket.
- One time donations to the general fund totaled \$75 (2 donors).

- Pledges totaled \$927.50 (52 pledgers).

Total income for Jan 2022 was \$6549.50.

LPNC January expenses, including PayPal fees for pledges and donations, were \$61.99. The PayPal fee for convention income was \$205.61.

Operating expenses totaled \$353.01. This included:

- Dreamhost: \$287.76.
- Textedly: \$61.
- Postage that Barbara spent to mail CFR to SBOE: \$4.25.

Total expenses for January totaled \$620.61
