Chair Report:

Call to Order:

With more regular spending, a card would be useful for the affiliate team. If there is less regular spending, as there is now, a card may not be necessary. Kim Acer believes the spending may be more regular going forward as there is stability on the Affiliate Team. Joe Garcia would like to see a plan for how the money will be spent in general before getting a card for the team.

New Business:

LPNC Position papers: Joe is questioning the usefulness of Position Papers on the LPNC website. Phil Jacobson, from the Messaging Committee, gives some background on why the LPNC has position papers, opinion, and candidate papers. There is consensus that as long as the papers are within the Statement of Principles and marked as contributor papers in some way, there should be an opportunity for members to contribute. Sarah Brady moves "that the LPNC table this until the next meeting in order to workshop a draft policy in order to present it to the Executive Committee." Seconded by Kimberly Acer. The motion passes without objection.

Adding and filling the LPNC Executive Director role: Brian Irving will be filling the role of Executive Director in a volunteer capacity.

Filling the open position of Political & Public Policy Division Director role: Sarah Brady will be taking on the role of Political & Public Policy Division Director. She will be taking this role after having previously filled the role in 2018.
