- Timothy Conard <u>presented</u> an overview of the LPNC Virtual Private Server (VPS). James Higgins, and Brad Hessel are assisting him in IT. Bryce Acer is available on an emergency basis. - Discuss working with Forward Party on ballot access Mac Browder. The Vice
 Chair of the NC Forward Party has requested our help gathering signatures for
 ballot access. Mac wanted to make sure no one would have a problem if we did so

at the Carthage Buggy Festival.

- There was a discussion of a new proposed Party Organization structure<u>LPNC Staff</u>, <u>Live 2 Google Sheets Party Organization Google Slides</u> by Dee Watson. There is a proposal to create County Contacts <u>County Contacts Google Docs</u> and Roaming Treasurers. This would form an informal network of party activists to organize at the local level. This would create a nimble network to assist candidates, and form affiliates as needed. Steven DiFiore expressed concerns that the affiliates teams processes were not taken into account, and Kim Acer had previously contacted the LPNC Executive Committee over concerns about the County Contact position. Chair Ryan Brown requested that all relevant Affiliate Documents that were referenced were sent to the Executive Committee. Dee Watson requested that all documents distributed have a time stamp prior to May 11, 2023, and it was agreed that that caveat would be added.
- The possibility of organizing more around Issue Coalitions was discussed. A new set of email forwarders for issues coalitions should be created. This will be done later when the rest of the structure is settled. A tab for Issue Coalitions can be created under the "Get Involved" section of the website. Also channels can be created in Mattermost for each Issue Coalition.
- The <u>LPNC Staff, Live 2 Google Sheets</u> document is a precursor to the LPNC volunteer report. The spreadsheet is still evolving, but eventually we will create a policy and report structure for the LPNC volunteers.
