Appendix A

Motion

I move that the Libertarian Party of Wisconsin adopt the following resolution:

Resolution

Whereas, the Libertarian Party of Wisconsin platform preamble states:

"As Libertarians, we defend each person's right to engage in any activity that is peaceful and honest and we welcome the diversity that freedom brings. We seek a world of liberty; a world in which all individuals control their own lives and are never forced to compromise their values or sacrifice their property. We believe that no conflict exists between civil order and individual rights and that individuals, groups, or governments should not initiate force against other individuals, groups, or governments;"

Whereas, the Party is bound by its bylaws to take no position or action inconsistent with the Statement of Principles or platform of the Party;

Whereas, the Libertarian Party national platform affirms that *"Individual rights shall not be curtailed, whether based on circumstances of war, epidemic, natural disaster or emergency, or any other pretense"*;

Whereas, Bryce Thon is the founder of the "So To Speak Caucus" and has publicly communicated statements, which have been publicly accessible, through online platforms including X (formerly Twitter), either directly or through accounts under his control or influence;

Whereas, statements associated with this account have included advocacy for policies inconsistent with equal rights and individual liberty, including but not limited to:

- July 18, 2025, and March 28, 2026: "repeal the 19th"
- March 31, 2025: "Repeal the 19th. End women in the workplace. Outlaw abortion. Abolish no fault divorce."
- August 16, 2025: In response to a question asking whether a proposal to remove "40 million immigrants" included "all people born in a foreign country, including U.S. citizens," the account replied: "Yes"
- April 4, 2026: "Prepare to be radicalized. 100m need to be removed from the country to get this back"
- March 7, 2026: "We want white immigration"
- July 12, 2025: "Fun fact: ICE hasn't been aggressive or cruel enough to make 40m+ want to leave on their own."
- April 22, 2026: In response to a post stating "Indians assimilate faster and more extensively than any immigrant group," the account replied: "They all need to go."
- April 22, 2026: "All Indians need to go."

Whereas, such statements are inconsistent with the Party's principles, including equal rights and opposition to discrimination based on sex, nationality, or identity;

Whereas, such statements further conflict with the Libertarian principles of life, liberty, and property by advocating policies that would restrict individual rights and freedoms based on identity rather than individual conduct;

Whereas, such statements also conflict with the principle that individuals, groups, or governments should not initiate force against other individuals, groups, or governments;

Resolved, that the Libertarian Party of Wisconsin formally condemns and rebukes these positions as inconsistent with its principles;

Resolved, that these positions do not represent the views of the Libertarian Party of Wisconsin;

Resolved, that the Libertarian Party of Wisconsin will not support Bryce Thon for any officer, representative, or committee position within the national Libertarian Party or its affiliated bodies.

Notes:

Objection 1: "This violates free speech"

Response:

"No one's speech is being restricted. This resolution does not prevent anyone from speaking—it simply defines what this Party stands for. Freedom of speech includes the freedom of association, and the Party has the right to disavow positions that contradict its principles."

Objection 2: "You're taking statements out of context / this is misrepresentation"

Response:

"The resolution uses direct, dated quotes that are publicly available. Some of these statements have been repeated multiple times and further defended, which makes the intent clear. If additional context is relevant, it can be explained in debate — but the statements themselves are clear and speak for themselves."

Objection 3: "This is factional / divisive / unnecessary drama"

Response:

"Ignoring conduct that contradicts our principles is far more damaging than addressing it. This is not about factions — it's about whether our principles actually mean anything when they're publicly contradicted."

"If we won't uphold our own principles when they're clearly contradicted, then they aren't principles — they're just words."

"This resolution doesn't punish speech — it clarifies what this Party stands for. I urge a yes vote."

Chair's Report – Libertarian Party of Wisconsin Executive Committee
May 17, 2026

I want to thank our Executive Committee members, volunteers, affiliates, and candidates for the continued work.

I want to remind everyone that we currently have two candidates actively collecting signatures for ballot access:

- Dalton LaPorte for Secretary of State, who needs approximately 2,500 signatures by June 1st after announcing a late candidacy.

- Roy Martin for State Assembly District 6, who needs approximately 200 signatures by that same deadline.

Petitioning is difficult work, especially for third-party candidates, and any help members can provide over these final weeks is greatly appreciated.

I also want to remind everyone that the 2026 Libertarian National Convention begins May 21st in Grand Rapids, Michigan, where Wisconsin will have strong delegate participation.

Finally, per requests from members regarding meeting flow and discussion management, responses tonight will be limited to two minutes unless otherwise recognized by the chair.
