# Presidents' Message

Summer is wrapping up and we are heading into fall and the peak of the 2022 election season. While some of us had an opportunity to take a break over the summer, our awesome voter service volunteers were busy updating Vote411 for the General Election, arranging for printing their Voters' Guides, and planning candidate forums, voter registration events, and Get Out the Vote activities. I hear over and over from community members around the state how much your hard work means to voters. Hats off to all of you!!!!

Many of you are aware of the problems that were caused by the Governor's veto of HB 682/ SB 163 which would have allowed the local Boards of Election to begin processing mail-in ballots before election day instead of following current law that says no canvassing of these ballots shall take place until the Thursday following the election. Due to the vast increase in voters choosing to vote by mail, and the many time-consuming and labor-intensive steps that go into reviewing, opening, sorting, counting, and organizing these ballots, some jurisdictions took a month to certify their election. Therefore, the State Board of Elections filed a petition for emergency relief to address issues related to processing absentee ballots. LWVMD

filed an Affidavit of Support for this petition. On

September 23, the judge ruled in favor of the Stage Board of Elections. Thanks to this ruling, beginning on October 1, boards of elections may begin to process mail-in ballots, but results of counts will not be announced until after the election.

The LWVMD's State Board Letter (SBL) is published as way to keep the lines of communication open between the LWVMD and our local League members. Please feel free to copy or summarize any of the information in SBL for use in your own newsletter, websites, and other communications. We also hope to use SBL to highlight some of the achievements of our local Leagues. Nikki and I met with the

local League presidents this month and were, as always, impressed by the impact that your Leagues make in your communities and the many hours that your volunteers put in. If your members have achieved something that you are particularly proud of, please let us know so we can share it in the SBL.

Every dollar raised will go directly to helping the LWVMD's efforts to educate voters and get out the most reliable nonpartisan candidate information possible, the Voters' Guide. The team will kick off the year with a webinar on October 14 that will review how a bill moves through the General Assembly, how the state budget will be shaped in 2023 (a completely new process this year), and how you as an individual can help shape public policy. The webinar will be open to League and non-League members whether they are considering being a volunteer advocate or just want to learn more about the Maryland legislative process.

The basic introductory course will be followed on November 4 by a briefing for individuals who are considering being an LWVMD advocate. Attending this briefing is not a commitment, however it will help you understand what volunteer advocates do, how they are supported by their teams and LWVMD, and how this experience can be incredibly informative and rewarding.

Shortly before the 2023 legislative session begins, the LWVMD will get together with volunteer advocates and Advocacy Team Leaders to update them on new information and answer questions they may have about the upcoming session.

VOTE411 and Voters' **Guides Now Available** 

Local League volunteers have been working hard on VOTE411 and Voters' Guides for the 2022 general election. Since September 24, candidates' responses to the League's questions are available at the VOTE411.org website, the date by which the first ballots were scheduled to be mailed. Each local League has also been preparing a PDF version of their county's Voters' Guide, a copy of which will be sent to the LWVMD.



The LWVMD wants to send a big thank you to all League members around the state who helped compile these resources. 2022 has been a particularly challenging year to put this information together because of the new software for VOTE411, which is still incomplete, and because of the delays in the primary election, which also affected some of the deadlines for the general election. Great job everyone on getting this information to MD voters in a timely manner.

The <u>LWV of the Mid-Shore</u> offers their hearty congratulations and gratitude to two of their longtime members, Pat Comella and Barbara Hale, who played an important role in bringing about the recently issued Valley Proteins Consent Decree. This order will require the Eastern Shore poultry rendering plant to pay approximately \$1 million to settle lawsuits stemming from their operational practices that have adversely impacted the water quality of Transquaking Creek in Dorchester County.



In November 2018, Pat and Barbara worked with the Dorchester Citizens for Planned Growth, the

Chesapeake Bay Foundation, and ShoreRivers to organize a non-partisan, non-adversarial forum that brought this issue to public attention. Subsequently, they worked with the NGO partners to provide data to the Maryland Department of the Environment as it investigated the case.

Thank you, Pat and Barbara, for your hard work and dedicated devotion to protecting the fragile Eastern Shore environment.

# Youth **Advisory** Council of the **Maryland Civic** Education Coalition

The Youth Advisory Council of the Maryland Civic Education Coalition (MDCEC) held a leadership retreat on September 11, 2022, that was centered around serving others and helping the Maryland community. As part of Youth Service America's 9/11 Day of Service, we learned more about the events leading up to the attacks on 9/11 followed by a video including many stories of people whose lives were changed through others' assistance on and after 9/11. With this, Youth Advisory Council members and I participated in servicelearning activities keeping in mind the selfless care that the heroes on 9/11 had for strangers.

With guidance from Lena Morreale Scott, Co-Chair of MDCEC's Steering Committee and Professor of Education at the University of Maryland College Park, we explored the knowledge, skills, and values that are involved in being an effective citizen. 

The other 24 Leaguers, seated in the courtroom, were joined by current UMB law school students. staff, and faculty as well as former graduates and faculty.

This year's panel program topic was, "The Supreme Court, and the Constitution: **Recent Cases and their Implications,"** in which:

- Chaz Arnett spoke about the case, New York State Rifle & Pistol Association Inc. v. Bruen
- Leslie Henry discussed the case, Dobbs v. Jackson Women's Health Organization
- Peter Danchin talked about Kennedy v. Bremerton School District, the praying high school football coach case
- Holly Brewer focused on the significance of the current moment in our Supreme Court's constitutional jurisprudence.

After the Q & A, panelists and attendees adjourned to the Atrium for the Reception. In addition to providing several large pizzas, the University of Maryland, Baltimore, treated everyone to a large sheet cake decorated atop with the Preamble to the Constitution.
