
The LWVUS filed an <u>amicus brief</u> at the U.S. Supreme Court in the Moore v. Harper case against the "independent state legislature theory" (ISLT), a theory that would remove the checks and balances of our democracy and give state legislatures complete authority to rewrite the rules of how federal elections are run at the state level. LWVMD along with all other 49 Leagues in the nation, signed on to this brief. To better understand ISLT, watch this video from the Brennan Center for Justice.

**Rally Against** Indépendent **State** Legislature Theory

Excerpt from <u>LWVUS 10-26-22 Press Release</u> on Independent State Legislature Theory:

"Giving states unchecked power to set rules for federal elections is an assault on the American voter," said Virginia Kase Solomón, CEO of the League of Women Voters of the US. "Historically, state legislatures have enacted the most harmful and suppressive antivoter laws, and pro-voter groups like the League have relied on the ability to fight them in state courts. The Independent State Legislature Theory is a dangerous, fringe ideology that leaves voters effectively defenseless from harmful election laws."

The League of Women Voters has serious concerns about this case because a ruling adopting ISLT would give state legislatures nearly unrestricted authority to set the rules for federal elections, prioritizing the ambitions of politicians over the American voter. Furthermore, if the Supreme Court condones this theory, it will undermine the role of state courts to protect voters when politicians create unconstitutional barriers to voting, draw unlawful voting maps, and invalidate direct democracy efforts like ballot initiatives.

"In creating the US Constitution, the framers were intentional about establishing a checks and balances system to disrupt any one branch of government from becoming too powerful," said Celina Stewart, chief counsel and senior director of advocacy and litigation at the League of Women Voters of the US. "Because state courts have been vested in the salient role of deciding disputes that govern our daily lives, any unraveling of this longstanding balancing would be a dangerous and historic blow to democracy as we know it. We implore the Court to rule in favor of voters and reject the Independent State Legislature Theory."

As this case has massive implications for every state, the League of Women Voters amicus brief expresses the concerns of Leagues representing all 50 states and the District of Columbia. The League's brief focuses on the practical, negative impacts that ISLT will have across the country. Specifically, the brief explores how implementing such a theory would create different election rules for state, local, and federal elections that would cause confusion for administrators and voters alike and would have a deleterious effect in maintaining free and fair elections.

## Making Sense of Our Civic Language

The words Americans use to describe, debate, and examine our civic values, ideals, and practices are also the words we use to connect, share, and cocreate our community and national future. What can we know about how aligned we are on our language choices related to our civic lives? Perhaps a more important concern underlies this question: Are we talking past each other about values we think we share?



In 2021, Philanthropy for Active Civic Engagement (PACE) Funders partnered with Citizen Data to field a nationally representative survey of 5000 American voters and followed up with deep dive sessions, focus groups, mini-papers, minigrants, and infographics to democratize the analysis process.

What assumptions about civic language were confirmed, challenged, or complicated by the data? And perhaps most importantly, what are the hard truths our data present that we need to face and wrestle with as a field?

## Voter Services Statistics

This Election season Marylanders (from all over the world!) kept LWVMD busy. Our <u>Vote411</u> platform was once again one of the most utilized and needed tools to help voters.

The League's website saw countless visits, but our Vote411 and Voter's Guides webpages specifically saw over 18,000 clicks and

views. This came from a number of factors, but we at the State were pleasantly surprised by the amount of people who came to the LWVMD site by organically searching for our Voter's Guides or Vote411. This proves to us that the League is the pinnacle of what voters think of when they think of resources when deciding between candidates.

With Vote411 being one of the only reliable non-partisan platforms, it's no wonder that it received over 87,000 clicks from Marylanders. This represents people from just across the state. We are lucky enough to be able to break this information down by county and even towns in some cases. It's a firm example of why our local League's are so critical during these times in getting voter information out there. It also tells us what else we need to do and where we need to work more.

This year LWVMD was fortunate to be able to put our efforts behind two new mediums of advertisement. One of those was <u>The Baltimore Banner</u>, an online newspaper, where we advertised three ads on their website, one on their mobile site, and one in their daily email newsletter that they call the *The Scan*. Through this campaign we were able to make over 176,000 impressions with their readers! Furthermore, we are happy to report that LWVMD surpassed *The Scan's* normal interaction rate by .05%. This no doubt contributed to the traffic on Vote411.

The second medium we used was social media. While we have utilized this avenue before, this year, along with out Get to the Polls MD campaign, the League made a concerted effort to push Voter's Guides and Vote411. We did this by purchasing ads on Facebook and Instagram. This translated to an explosive amount of traffic such as likes, shares, and engagement. Unfortunately, Facebook stopped allowing ads after November 1 due to the immense amount of election misinformation, but they did allow us to rerun ads they had

already approved. In the ten days leading up Election Day, the League was able to make over 90,000 impressions on social media. We were ecstatic to learn that a large amount of these viewers are youth voters.

Around the state many of our local Leagues got out there to take on their own voter registration and services. Members everywhere took over community colleges, universities, farmers markets, and shopping malls to encourage voters to check out their local guides and find the best way to vote for them. LWV Washington County member, Genie Massey, attended a conference in Ocean City. Members from LWV Baltimore City, including Vice President Deanna Ikhinmwin, answered the call from Morgan State University to educate youth voters and discuss the election. They even went viral on Twitter! Thank you to all the members who got out there to spread the League's mission.

This burgeoning League was recognized in an October Baltimore Sun article about their participation in a march organized by the Poor People's Campaign to encourage people with low incomes in Carroll County to register and cast their ballot in this year's gubernatorial election. Additionally, the registered voters numerous times at

Carroll Community College and at the March for Choice and helped assemble a team who once again crafted the questions that were included in the Carroll County Voters' Guide.

Working with LWVMD Executive Director, Nikki Tyree, they have developed a colorful, informative membership brochure and have been reaching out to other community organizations to let them know about the rebirth of a Carroll County LWV and opportunities for collaboration. Working with their Social Media Team, chaired by Aileen Hepler, this League is also engaged in converting their dozens of <a href="Facebook">Facebook</a> group members to League members with the goal of reaching 30 paid members.

Having co-presidents who are a 20-year old John Hopkins student and a retired Human Resources executive has resulted in terrific learning opportunities and sharing of viewpoints. Both women bring unique skill sets, experiences and knowledge that when combined, will continue to make the organization more diverse and representative of our county, while creating a long-term strategy for growth.
