A Harvard **Case Method** Discussion on Madison's **Federal** Negative and the Making of the Constitution



The LWV of Anne Arundel County is again hosting a Case Method Institute program in collaboration with the Anne Arundel County Public Schools on:

Madison's Federal Negative and the Making of the Constitution Thursday, June 22 6:30 p.m. - 8:00 p.m. via Zoom

The discussion will follow the Case Method, which engages participants in how to examine and respond to a situation in a specific moment in the American democratic process by putting themselves in that time and situation. In looking at Madison's proposal for a federal negative addition to the U.S. Constitution, participants will be asked:

> "If you were drafting the Constitution, how much power would you give the federal government over the states?"

As a participant in this discussion, you will be invited to discuss the case materials, think critically, and learn more about our American democracy. You will be led by moderators from Anne Arundel County schools, Christina Sipe of Broadneck HS and Seth Wolak

of South River HS), and LWVAAC Case Method Project Coordinator Joyce Martin. This event is open to anyone, and may be of special interest to teachers of American history and government who may be interested in using this method in their classrooms.

The League of Women Voters of Maryland, For the People MD, and the <u>University of Maryland Carey School of Law</u> held a forum entitled Crisis of Legitimacy and the Path to Reform on Wednesday, May 3. The panelists were Mark Graber, University System of Maryland Regents' Professor and Constitutional Scholar; Leslie Proll, Senior Director, Voting Rights Program, Leadership Conference on Civil Rights and Human Rights; and John Sherman, Litigation Director, Fair Elections Center.

# LWVMD and **Partners Host Supreme Court Forum**

Professor Graber gave a quick history lesson on the structure of voting in the United States. Leslie Proll talked about the history of the 1965 Voting Rights Act and recent and possible future actions by the Supreme Court to curtail protection of voting rights in our country. John Sherman explained the "shadow docket", the way many election cases, sometimes hugely consequential cases, are decided without full briefing or oral arguments and without any written opinion. The reasoning for putting election cases on the shadow docket is that they must be decided quickly. The problem is that the court is not required to give any rationale for their decisions, which is required for cases on the normal docket.

Mr. Sherman also talked about Moore V Harper, a case to decide whether a state's judicial branch may nullify the decisions made by the state legislature regarding how elections are conducted; this case resulted from a North Carolina gerrymandering case. Following that, the panelists discussed the recent decisions and practices of the Supreme Court that are giving rise to the lack of public confidence in the institution and possible remedies.



# **LWVMD Day** on Capitol Hill Recap



On May 15, LWVMD hosted the MD Congressional delegation at the annual Day on Capitol Hill. Held again virtually, a format which started during Covid, has proven to be popular as it allows for more participation from members across the state. Almost 100 members registered, and about 40 participants attended each half hour meeting, with many people joining when their representative was speaking. Senators Cardin and Van Hollen, and Congressmen Raskin, Mfume, Ivey and Sarbanes all attended; the offices of Congressmen Harris, Hoyer, Ruppersberger, and Trone were represented by knowledgeable staffers.

The topic this year was the ever-relevant voting rights legislation, which faces even more obstacles this session than the previous one. While H.R.1, For The People Act (lead sponsor Rep. John Sarbanes), and the John Lewis Voting Rights Advancement Act of 2021 had both passed the House of Representatives in the previous session, they were not able to overcome filibusters in the Senate.

Rep. Sarbanes promised that they are working on new legislation for this year, but everyone warned that nothing is likely to pass in the House of Representatives this year. Still, they will have fresh bills in both chambers and expect that the Senate in particular will hold new hearings about obstacles faced by voters in many states due to new state-level restrictions on voting which include overly strict ID requirements, restrictions on mailin voting, racial gerrymandering, and other instances of voter suppression. The Supreme Court may also rule in favor of yet more restrictions this session which may in turn lead to proposed new congressional legislation to counter judicial tolerance for state level voter suppression tactics.

Rep. Sarbanes and others noted that, in terms of polling, voting rights has strong bi-partisan support, especially in regards to making it easier for people to vote, more credible drawing of congressional districts, and reductions in the influence of dark money. He said they would restore sections on ethics that had been stripped last year in a failed effort to try to gain more bi-partisan support. He said that Senator Klobuchar would be the lead sponsor on the Senate side, and they agreed they wanted to "keep it bubbling, in the hopper and on the ballot." The John Lewis Voting Rights Advancement Act, which had been merged with the stripped back For the People Act to create the <u>Freedom to Vote Act</u> in 2022, would probably go forward separately to ensure time for more Senate hearings.

Rep. Raskin mentioned that he hopes to introduce or support a proposed constitutional amendment that would explicitly guarantee the right to vote. In response to a question about the electoral college, he noted that Maryland has been a leader in the National Popular Vote compact, and said, "We're two thirds of the way towards 270 electoral votes," which would effectively ensure that the presidential candidate who won the popular vote would also receive enough electoral votes to win.

Senator Cardin, who had also been the lead sponsor of the bill to recognize the ratification of the **Equal Rights Amendment**, noted the bill had majority bi-partisan support: 53 votes, but not enough to overcome the filibuster.

Senator Van Hollen said he supported a carve-out for the filibuster for voting rights, noting that it's only a "Senate-invented rule" that should not block critical reforms after Senators had had ample opportunity to debate the issue; unfortunately, Van Hollen acknowledged, "We don't have the votes to change the rule."

All members stressed that they valued LWV as a very reputable, credible, non-partisan organization, and very much appreciate our strong support for voting rights reform.

# **LWVUS Adpots** Two New Responsibilities **Policies**

Over the past year, the LWVUS Governance Committee has been developing a Member Rights and Responsibilities Policy that defines what it means to be a League member. They also adopted a League Responsibilities Policy. This past April, the LWVUS Board approved both policies at their spring meeting, officially putting them in place.

So, what does this mean for you? It means that the League now has a written definition of what you already do as a member of the League.

A member's rights policy like this is standard in a federated nonprofit organization like the League. As a member, you aren't required to sign anything or change what you do with the League. This just helps to define our shared understanding of what League membership means.

The member's rights policy was developed through many years of research, legal review, professional consultation, and LWV member input. You are encouraged to read the policy and the accompanying explanatory documents on the League Management site here; the adopted League Responsibilities policy can found here.

# **Committees**

Two New **Studies Adopted** at 2023 Convention Part of the work at state convention is to adopt a program for 2023-2025. The process for doing that includes local Leagues reviewing existing positions. Sometimes an existing position has become outdated and needs to be re-visited, and sometimes a gap is identified. In those cases, a study is proposed so a committee can be formed to study the issue and prepare a summary of their findings for presentation to members with the potential for adopting a new or revised position. At the convention just held, two new studies were adopted. If you have an interest in joining a study committee on either one, please let us know at pres@lwvmd.org.

### Study 1: Impaired and Distracted Driving

The current position is focused on drunk driving, although it is recognized that there are many sources of distracted driving, such as drugs, cannabis, or cell phones. A potential study could include a review of the factors that cause impaired diving; how enforcement is implemented and varies across Maryland; and options to address it. This study needs a chair/co-chairs and members to join it.

### **Study 2: Local Control of Education**

The current education position has multiple components to it, including one part that states "continuation of local control over schools." Given the passage of the Blueprint for the Future of Maryland, aimed at reforming education across the state, local Leagues stated the need to review only that portion, not the whole position. It is recommended that such a study define what is meant by "local control," what is mandated by the state, and where flexibilities may exist for local input and direction. The study committee has a chair, Gail Sunderman of Baltimore City, and needs members to join it.

#### Convention

A very successful state convention was held in Frederick, Maryland, on June 3-4, 2023, with over 100 participants who attended in person or virtually; this event was the first time members from across the state met in person since the 2019 convention. The convention had a packed agenda that was informative, productive, and also fun!

The informative part was delivered through a series of nine workshops that covered a wide range of topics, including: democracy at the precipice of Black and White; using LWV positions; polarization; energizing youth voters; election reforms; becoming invincible to defeat; voting and accessibility; health care and democracy; and why civics isn't taught. Some of the sessions were recorded, and those recordings will be shared with members after the summer. A big thanks to all the workshop leaders who each devoted time to prepare and present their sessions.

A productive meeting ensured that needed business got done. Participants adopted revised bylaws that included, among other things, two key changes: first, a clause permitting LWVMD to convene meetings using virtual and hybrid options in addition to in-person, a practice which started during the pandemic and which members felt was important to continue; and second, a reduction in the number of vice presidents on the board from three to one, which was done to establish a more manageable executive committee, and support recruitment to the board and succession planning.

Members also adopted a program for 2023-2025 that included two new studies. One study will be on impaired and distracted driving and another study will be on local control of education; see articles on page 8 for more information. An operating budget of \$180,750 was adopted for 2023-2024 with that includes a vigorous goal for fundraising. While LWVMD appreciates every dollar of support from members, it also wants to reach out to others who support the League's goals and appreciate the work the League does.
