## VOTING IN MARYLAND

To vote you must register. You may register to vote in Baltimore County if you are a U.S. Citizen who resides in Baltimore County and if you are at least 16 years old. However, you cannot vote unless you will be at least 18 years old by the next general election. If you have a valid Maryland-issued State ID number or driver's license number, you may register online at: [www.elections.state.md.us](http://www.elections.state.md.us)

Voter registration applications are available at post offices and libraries. You may register in person at any office of the Motor Vehicle Administration, most State agencies and the Baltimore County Board of Elections, 11112 Gilroy Road, Hunt Valley, Maryland, 21031

After you register, you will receive by mail a Voter Notification Card, which will show your precinct number and polling place. You must always vote in the polling place for your precinct, unless you vote at an early voting site. You can also check your voter registration online.

**Any registered voter may vote by absentee ballot.** Maryland does not have a permanent absentee ballot list, so you must apply prior to each election. During an election, absentee ballot applications are available via the internet from the State Board of Elections at [www.elections.state.md.us](http://www.elections.state.md.us).

Applications are also available in person at the Baltimore County Board of Elections. Call **410-887-5700** or write to the Board at **11112 Gilroy Road, Hunt Valley, Maryland, 21031**.

When you request a ballot, you designate how you want to receive your ballot. If you want to download your ballot, make sure you provide your email address. Your request for an Absentee Ballot must be received at the Board of Election Supervisors no later than seven days before an election. After that, you must complete the application at the Board of Elections.

- \* Request action. Ask for an answer.
- \* Express thanks for favorable votes.
