

Observer Team Annual Report 2021-2022 LWVCC Observer Teams

There have been changes this past year in the way the Observer Teams operate. Initially, the teams for the Board of Education, Planning Commission and Board of County Commissioners met individually. Two years ago, the observers transitioned to a joint meeting held quarterly. The productivity of the joint meetings persuaded the observers from every group to meet jointly monthly, which we began in January, 2022.

Important county issues always funnel through major county agencies, including the Planning Commission, the Board of County Commissioners or the Board of Education all three of which have dedicated observers. Many of the issues our League follows involve one of these three boards. The ability to discuss issues with people who are educated about the way these county departments function and what issues are surfacing during the meetings of these organizations increases our understanding of how issues develop and are resolved. Not only is it educational, but it's also enjoyable.

For example, this past two years, the County has seen an increasing focus on racial issues as a result of events such as the "Black Lives Matter" movement and controversy over "Critical Race Theory" which involved both the Board of Education and the Board of County Commissioners. Similarly, the Board of County Commissioners has been responding to the mandate to develop a "Police Accountability Board.

The new Town Center Master Plans which are currently being developed are primarily being presented to the public through the Planning Commission and the Board of County Commissioners. The fact that observers have focused on these major agencies has helped the Study Group that is tracking the development of the Prince Frederick Town Center Master Plan complete its task.

At present, the requirement for a written observation report has been dropped, although we appreciate the written notes and may reconsider this policy.

For those League members who would like to learn more about the Calvert County government, please consider joining one of the observer teams. Information about the specific observer duties (Board of Education, Board of County Commissioners, Planning Commission) will be on the LWVCC website.

Meetings are held at 9:30 am, the first Monday of the month. The next meeting will be virtual, Monday, June 6, 2022. Visitors are very welcome.

Report of the Prince Frederick Master Plan Study Group

The proposed study of the development of the Prince Frederick Master Plan was approved at the 2020 Annual Meeting. Over the past two years, the study group has been meeting weekly, and the study is approaching completion. The study has tracked

the County's development of the Prince Frederick Town Center Master Plan, which will be the first of many Town Center Master Plans to be adopted.

The goals of the study are the following:

- A. Assess the outreach efforts to Countians to educate the public and encourage participation in the development of the Town Center Master Plan.
- B. Assess the extent to which the Master Plan addresses the many concerns expressed by citizens during the outreach meetings and surveys as to what should be included in the Town Center Master Plan.
 - C. Assess the transparency of the process to develop the Master Plan.

The timeline of the study:

The first draft of the new Prince Frederick Master Plan was released to the public in July, 2020, when the Department of Planning and Zoning presented it to the Planning Commission. Following protocol, a public comment period followed the presentation. (The League Study Group did not submit comments because at that point in time, our study was insufficiently complete.)

The next step is for the Planning Commission to formally adopt the draft Master Plan, after which there will be a second comment period (60 days) to provide an opportunity for the public to comment on the final draft. After the 60-day comment period ends, and after the Planning Commission makes any final changes, the Master Plan will be forwarded to the Board of County Commissioners for approval.

During the upcoming 60-day comment period, (which we anticipate will occur around the time of the LWVCC Annual Meeting in May, 2022) the Study Group would like to submit an "interim LWVCC Study Group report" as the League's comment. When the Prince Frederick Master Plan is finally approved by the Board of County Commissioners, we will complete the report and release the final Study Group report.

The role of the LWVCC Board:

A draft of the "interim report" will be submitted to the LWVCC board for approval before we submit it to the Planning Commission during its comment period. Likewise, the "final report" will be submitted to the LWVCC board for approval before the completed study is released to the membership for approval.

Membership approval: Not all studies are submitted for membership approval. (Some studies are primarily for education of League members.) However, it is possible that the Board will want to take action or make a public comment based on this report. In that case, it would be appropriate that the report be reviewed by the membership.

The timing of the release of the study for approval by the membership is uncertain, depending on the actions of the Planning Commission and approval by the LWVCC board. When the study is finalized, and after Board approval, the study will be put online for members to read and (hopefully) approve.

Study Group members: The Study Group has been ably led by Tricia Powell. Other group members have been Sue Bilek, Sharron Bickel, Malcolm Funn, JC Hooker, Karen Horton, Michael Moore, Randi Vogt, Duwane Rager, Lila West and Gladys White. Members of the Observer Teams have also contributed to the work on the study.

Report of the Redistricting Committee


The Committee was charged with reviewing Board of County Commissioner (BOCC) election districts and boundaries following the decennial census to account for population changes. The Committee, considering changes in population, arrived at the conclusion to recommend the most practical and geographically and numerically equal district boundaries.

The Redistricting Committee was comprised of nine appointees:
5-appointees were selected by the Calvert County Commissioners.
1-appointee was selected by the Calvert County Democratic Party
1-appointee was selected by the Calvert County Republican Party
1-appointee was selected by the Calvert County League of Women Voters
1-appointee was selected by the NAACP of Calvert County

One of the main points that was reiterated by Chairperson Parran was that the Board of County Commissioners cannot change the number of districts in the county and that such change would require state legislation; however, any individual or organization can introduce a bill for a change.

All of the meetings were available for public viewing at the Calvert County Redistricting Committee.

Report of the Task Force on Social Justice and Police Accountability

The creation of the Task Force was prompted by publication of a BOCC proposal on how the Policy Accountability Act of 2021 ought to be implemented, based largely on recommendations from outgoing Commissioner Tim Hutchins. The resolution called for three law enforcement retirees for the 9-member Police Accountability board as well as a member from the mental health community and a chaplain with experience with either the military and/or law enforcement. Further, those from the law enforcement community would be required to have 20 years of law enforcement experience, a college degree in criminal justice or similar field, and training from the FBI Academy.

The Task Force (Sandra Raviv, chair, Tricia Powell, Len Zuza, Gladys White, Renee Yuengling, JC Hooker, and Mary Ann Zaversnik) began meeting in July, 2021 and held bi-weekly meetings to research issues associated with civilian review boards and determine what goals the Task Force wanted to pursue. A citizens forum was planned and held in early September, offering the viewing public diverse perspectives on policing from a panel of mental health representatives, law enforcement, youth, and minority groups.

The Task Force then examined each updated resolution from the BOCC, and offered comments both in person at meetings and public hearings, and virtually through the County website. With the assistance of other local organizations (LWVMD, NAACP, PRISM, and ACLU), we were able to achieve several significant modifications in the final resolution regarding composition of the Police Accountability Board and Charging Committee, term of office for volunteer members, etc. There has been considerable push-back from the law enforcement community on the topic of police accountability and we have been disappointed in aspects of the application process adopted by the BOCC.

Our next steps will create a fact sheet for informing citizens about the role of sheriffs in the County, as well as a survey to tap what citizens want in their sheriff to be. These materials will be distributed to our members and other local organization memberships prior to the July primaries.

Voter Services Report, 2021-2022

Voter Registration Training

Three trainings were sponsored by the Committee; the Board of Elections (BOE) provided the virtual trainings on June 2, July 7, and September 8, 2021. Each training was one-half hour. The Voter Services committee would like to extend their appreciation to Gail Hatfield, Paula Bailey, Kristen Scott and the entire BOE staff for their cooperation and participation in these events. A special thanks to Janet Bellizzi for arranging these events that were available to all of our outreach partners.

For 2022, two training sessions are planned in early spring.

Vote 411.org

With the approach of the 2022 election process, the county has a large number of candidates applying for various positions, primarily the School Board, County Commissioners, and Sheriff. Janet Ashby is working diligently with the State League and will obtain answers to a set of questions scripted by the voter services team and our members. The 411.org online information will be available in May for the now July primaries. Printed copies will be given to the public libraries for their patrons.



Voter Registration Events

Voter Service Events:

First Event: Community Day at Jefferson Patterson Park. The Calvert County branch of NAACP sponsored a community day on June 19, 2021. We registered individuals to vote and gave out information about the climate study, and membership applications, and pamphlets on the importance of voting. The event was well attended; Renita Alexander provided a table for the event. Sandy Raviv, Cheryl Hannon, Lila West, Dawn Tucker, and Cassandra Okwumabua helped to register individuals. It was a wonderful day at the park.

Second Event: The National Night Out was held in August, 2021. Volunteer members Sandy Raviv and Herb Wolff participated at Kellam's Field in Chesapeake Beach while Norma Onley, Janet Ashby, Gladys White, and Cheryl Hannon covered the event at Calvert Pines Senior Center in Prince Frederick. Both locations were able to register people to vote and provide information about the voting process.

Third Event: St. John Vianney Family Life Center's Community Fair on Oct 15, 2021 in Prince Frederick. The fair addressed the needs of the homeless and most needy in our community. We gave away snacks, toiletries, and clothing items such as socks, hats, and gloves. Some individuals registered to vote assisted by Malcolm Funn, Cheryl Hannon, Renita Alexander, Gladys White, Cassandra Okwumabua, and Norma Onley. Remaining items **were** donated to Project Echo on November 26th for their clients. We received thank you cards from both organizations for our support.

National Voter Registration Day Event

We held this event at the College of Southern Maryland (CSM) on September 28, 2021. Janet Bellizzi and Gladys White conducted a virtual presentation entitled "Your Vote-Your Choice-Your Future, Part 2." The presentation lasted approximately one hour, which included the most updated information from Calvert County Board of Elections. A question-and-answer period followed the session. We worked with Erica Fisher, who was the student liaison for CSM at the Prince Frederick campus. A large number of students attended this presentation as well as representatives from other CMS campuses. Our goal was to educate students to the importance of voting. If the pandemic permits, we will participate at a live "Spring Fling" event at CSM on April 19, 2022.

Voter Bill of Rights

For the 2022 elections, the Voters Bill of Rights will be updated with information obtained from the Calvert County Board of Elections and the State BOE. This is a useful tool but must be accurate.

I would personally like to thank the Voter Service Committee for all their hard work during the 2020 election period. We were able to accomplish our regular goals during the COVID-19 pandemic and to educate the public during this election season. The committee consisted of the following people: Janet Ashby, Janet Bellizzi, Sharron Bickel, and J.C. Hooker. We would also like to thank Carol Booker for her assistance.
