Board Meeting Minutes
December 13, 2022
Holiday Meeting at The Narrows Restaurant

Attending: Patricia Jamison, Liz Hammond, Barbara Sharkey, Pat Sommers, Mary Campbell, Jinny Guy, Joyce Woodford and Gina Crook, non-Board member Carolyn Moorshead.

Patricia Jamison called the meeting to order at 6:31 p.m.

Prior Minutes: Pat Sommers had distributed the final version of the minutes from the November 14, 2022 Board meeting before the meeting. Liz Hammond moved to approve the minutes and Jinny Guy seconded. The minutes were approved unanimously.
