About This Voters' Guide

This *Voters' Guide* is published by the League of Women Voters of Queen Anne's County and covers all races for which voters in Queen Anne's County may vote. The League has a long tradition of publishing the verbatim responses of candidates to questions important to voters. All candidates for state or local office, who filed with the State Board of Elections, were invited to submit information about their candidacy to our web-based VOTE411 system. All invited candidates were asked to provide their campaign contact information and their responses to a series of questions posed for each office. All candidates were limited to 400 characters for each response; responses shown are what candidates entered up to the stated limit. All candidate responses appear as written in their own words and are included in VOTE411 in their entirety. Due to printing constraints, not all questions and responses are included in this Guide; and only candidate website, if available, is included here for contact information. Go to VOTE411.org to see all questions and candidate-submitted information. The League offers this Voters' Guide to assist citizens in their decision-making process as they prepare for participation in the 2022 gubernatorial elections.

Party Primaries in Maryland

Party primaries in Maryland are "closed" primaries. You must be a member of a political party to participate in that party's primary, though all voters may vote for nonpartisan offices such as the Board of Education. You may change your party affiliation up until the close of voter registration on June 28 by completing a voter registration form and submitting it to your County Board of Elections.

You may also change your party affiliation online if you have a Maryland driver's license or identification card from the Motor Vehicle Administration.

If you have not previously registered to vote, you may register during early voting (July 7-14) at an early voting center in your county and choose a party at that time. For those already registered, you may correct your address or other information during early voting; however, you cannot change your party registration at that time.

You must be at least 18 years old by Nov 8, 2022 and a registered voter in your County to be eligible to vote in the Primary.

HOW TO USE THIS GUIDE

Read this *Guide* with your mail-in or sample ballot in hand, and mark your ballot accordingly. Take your sample ballot with you when you vote as *you are not permitted to use electronic devices, such as smartphones, tablets, and computers, inside polling places.*

Pay attention to the number of votes you can cast for each race; checking more than the maximum allowed will invalidate your vote for that race.

Check both sides of your ballot for additional races.

Maryland Statewide Offices

Maryland Governor / Lieutenant Governor

DUTIES: The Governor is the head of the executive branch and appoints the heads of statewide departments and judges in the state courts. The Governor proposes the annual operating and capital budgets to the legislature and may veto legislation passed by the legislature. The Lieutenant Governor assists the Governor and carries out specific duties assigned by the Governor. The Lieutenant Governor fills the office of Governor in case of death, resignation, or disability.

Rushern L. Baker, III / Nancy Navarro Campaign Website: rushernbaker.com

QUALIFICATIONS: The Baker/Navarro ticket is the most experienced in the race, with unrivaled State and local governing experience. Both candidates understand how to get things done in Maryland like few others, precisely because they have done them. They will use this experience to bring together diverse stakeholders from across the State together to address our greatest challenges. **ECONOMIC INEQUITIES:** The State is the central player in reducing economic disparities, and lifting up the people who have been historically left behind by the people in power. Our campaign has released the Roadmap for Equity, Inclusion, and

Diversity which will tackle this problem and help

disadvantaged communities support themselves today, build generational wealth for the future. **PUBLIC SAFETY:** Both Rushern and Nancy believe strongly that the status quo in Maryland, and especially in Baltimore is unacceptable. NATURAL RESOURCES: Every Marylander knows that the heart and soul of the State rests in the Chesapeake Bay. It is our greatest asset, and at the moment we are not treating it with anywhere near the respect it deserves. To tackle this, we will establish a pollution revolving fund, which will incentivize polluters to clean up their own waste, and save taxpayers money in the process.

INFRASTRUCTURE: Given the dire situation we are faced with right now, environmental concerns must take precedence over convenience. That said, we believe our infrastructure needs go hand in hand

with our environmental ones. My infrastructure priorities are projects like the Baltimore Red Line and starting the Southern Maryland Light Rail. These projects will be done sustainably and take cars off the roads.

other priorites: One of the greatest challenges we face today is the corrupting influence of money in our political system. That is why we decided to fund our campaign through public financing, to ensure that voters know that we will not deal with PACs and big money donors. Our administration will expand this program, allowing more candidates the ability to run for office without letting dark money influence them.

QUALIFICATIONS: I'm a former nonprofit

executive and Clinton Administration official with a record of driving real change from inside and outside government. After serving in the Clinton Administration, I founded a nonprofit that sparked a movement to advance evidence-based policymaking—working with the Bush & Obama Administrations to enact major reforms that led to significant gains in wages, education, & more. **ECONOMIC INEQUITIES:** Wages for the bottom 40% in MD have been stagnant since the 1980s, as income inequality has soared. We'll partner with MD businesses to provide proven job training programs to every adult who wants to advance. Done right, job training can increase earnings 20-40%. The key is to focus on fast-growing industries, and work hand-in-hand with employers who provide paid internships to the trainees. **PUBLIC SAFETY:** We'll fund crime-fighting strategies shown to produce big reductions in violent crime while building community trust, such as Focused Deterrence—an approach targeted at

repeat violent offenders. When implemented in Oakland CA, it helped cut homicides by 50%. We'll also invest in community policing in "hot-spots" where half of all urban crime occurs—an approach found to cut crime as much as 25%.

schoolers can't read at a basic level; more than ½ can't do basic math. We'll expand solutions that are tested and proven to deliver results. For example, we'll raise an army of tutors from the community to help every struggling 1st and 2nd grader in MD—moving them up toward grade level early, before their problems become serious, & reversing COVID-related learning loss.

HEALTH CARE: Marylanders are paying 50% more in out-of-pocket healthcare costs than they were 10 years ago, after adjusting for inflation. That's unacceptable. Our administration will negotiate significantly lower prescription drug prices - saving Marylanders up to \$100 million each year and offer a robust public option health insurance plan cheaper than those currently on the market. **NATURAL RESOURCES:** MD must lead the nation in cutting carbon emissions. We'll pursue a regional approach, building on the successful Regional Greenhouse Gas Initiative — an 11-state cap-and-trade program that's cut power plant emissions 47%. We'll expand this approach to other sectors by joining the Transportation and Climate Initiative (focused on transportation), as part of our comprehensive climate policy.

administration will ensure a thorough environmental review precedes implementation of any infrastructure project, and we will not pursue projects that would cause unnecessary or irreparable harm to the environment. From mass transit to highways and other investments, our administration will strike a balance between needed

infrastructure and protection of our natural resources.

OTHER PRIORITIES: Our campaign is not taking a dime from corporations, PACs, or MD lobbyists, because Maryland deserves a governor who answers to the voters – not special interests. Our administration will also require independent assessments of our key policies – the results of which will be reported to the governor, voters and General Assembly at the same time.

QUALIFICATIONS: I have spent the past 16 years serving as the State's Comptroller. My extensive track-record in public service has demonstrated that I know the issues that are unique to Marylanders, and I have successfully implemented solutions to solve their problems. ECONOMIC INEQUITIES: The state should help people access job training and placement that lead to stable, lifelong careers. EDUCATION: I will be an education-oriented governor with a focus on empowering our students and teachers. I will address student/teacher burnout by reducing standardized testing, and allow collective bargaining on classroom size. I will also pilot an experiential learning model, push for fully elected local school boards, and ensure no school building suffers from a lack of infrastructure.

HEALTH CARE: I am committed to lowering health costs and expanding affordable primary and preventative care. I will expand Medicaid coverage, focus on controlling prescription drug prices, and expand Maryland's total cost of care model for the commercial insurance market to control the rising costs. I will also ensure every Marylander is within a 15-minute commute to a Federally Qualified Health Center.

NATURAL RESOURCES: One of my greatest concerns is that we do not have a justice oriented approach to addressing environmental concerns. Improving the environment is a matter of effectuating justice. The Comptroller collects and administers Maryland taxes on income (both personal and corporate), retail sales, motor vehicle fuel, tobacco, beer, and wine and liquor, as well as estate taxes. The Comptroller serves on the Board of Public Works along with the Governor and the state Treasurer, who is appointed by the General Assembly. The Board of Public Works must approve major contracts for the purchase of goods or service by any department of state government.

TERM: Four years. No term limit.

SALARIES: \$150,000.

administration of Justice: I will establish community offices throughout the State where every month an Assistant Attorney General will meet with residents to hear their concerns, complaints and information that will help our office initiate, investigate and prosecute, if necessary, criminal conduct, discrimination, and other violations of law in areas such as the environment, elections, civil rights, and elder abuse.

PUBLIC SAFETY: Reducing crime will be my top priority. I will create a Major Offense Bureau to assist or replace local prosecutors in the prosecution of violent and repeat offenders. VOCATIONAL EDUCATION: In 7th or 8th grade, present vocations as a pathway to a career. Exposing middle school students to the potential that the trades have for establishing a successful business is the introduction to a vocational education pathway in high school culminating with internships, work study and an apprenticeship after graduation. Establish a Center for Applied Technology at the current BOE building.

SCHOOL SAFETY: First, ask administrators to identify the most pressing school safety issues they face. Then, ask the Sheriff's Department if there is grant money available to increase School Resource Officer presence in the schools. Propose establishing crisis intervention teams within each school. Provide ongoing training for staffs in the early recognition of indicators that point to antisocial behavior.

PARTNERSHIPS: Teachers are the foundation upon which a top flight public education system is built. The Chamber of Commerce in concert with the Economic Development Commission could establish an incentive fund that encourages retention of our current work force. An incentive fund currently exists to entice businesses to locate in QAC. A well educated work force is essential to continued economic growth.

COMMUNITY INVOLVEMENT: Seek advice from community leaders, teachers, and PTA's. Encourage QAC students to seek a career in education. If the county's teachers reflect the county's demographic, then diversity and inclusion in the work force become possible. Unless salaries and benefits are competitive with neighboring jurisdictions, equity and opportunity for the student body as well as its teachers suffers.

OTHER PRIORITIES: The Education Trust Fund should support enhanced funding for Maryland's Public Schools. It is derived from

gaming and casinos. Approximately 1/3 is used for that purpose. The Kirwan Commission expects those funds to support its recommendations in the Blueprint for Maryland's Future. Where has the other 2/3 gone? Hundreds of millions for salaries, benefits, and health care has been lost.

Counts and similar opportunities to assist our students.

COMMUNITY INVOLVEMENT: We have to listen to all of our community members as to the issues they have in participating in the education process. Then we have to find/create opportunities for the ones to actually have a real place to assist us that also shows how valuable they are to the process. I also would include various minority groups to share their experiences and opportunities for our minority students.

OTHER PRIORITIES: As the Board we need to keep our focus on education issues and keep partisan politics away.
