We also learned about Civil War activity in Howard County, and the birth of a Jewish community in Columbia. Holiday House Tour: December 10th from 2-5

Please join the Society for an exclusive holiday house tour of historic Carrollton Hall (1832). Originally dubbed Folly Quarter or Folly Farm, Carrollton Hall and the Shrine of Saint Anthony. share the same historic site in Ellicott City.

Located on a portion of Charles Carroll's Doughoregan Estate, the historic manor house was finally completed in 1832 as a gift from the Declaration of Independence signer to his granddaughter Emily Caton McTavish. Not yet open to the public, you can be among the first to preview this spectacularly renovated historic property - festively decorated for the holidays.

You are also invited to explore the Shrine of St. Anthony (1931), designed as a small replica of the friary and burial place of Saint Francis of Assisi -Sacro Convento of Assisi - and enjoy musical performances by the Marriotts Ridge Madrigals and refreshments.
