Primary elections having finally come and gone, we're now looking ahead to the general election in November. Our league put out a long and detailed *Voters' Guide* for the primaries, edited by Nancy Lawler, and we held several candidate forums

across the city, activities that will of course continue in the coming months. Efforts to inform and register young voters (catch their interest early on!) have

continued apace, with educational projects underway during term time in several public high schools. A new project, Leaguers in the Library, places a volunteer in several public libraries each month to answer questions and possibly register citizens to vote.

We also now have an active committee focused on DEI (Diversity, Equity, and Inclusion), as well as our ongoing Voter Data Analysis Project that's analyzing voter turnout across the city; the aim is to develop strategic programs targeted specifically at areas in Baltimore with especially low voter turnout.

A successful and most enjoyable in-person Annual Meeting took place at Gertrude's in June. There we approved numerous bylaws amendments, as well as a slate of officers and directors for the coming year. Dana Petersen Moore of the Baltimore City Office of Equity and Civil Rights gave the keynote address. It was a great relief to be free for once from yet one more meeting on Zoom!

Our Outlook for Work, also approved at the Annual Meeting, stresses growing the League and engaging even more members in our various activities. We plan to continue our ongoing involvement with voter education and registration, a primary mission of any league. In addition, we're looking ahead to increasing active advocacy by the League on issues of direct concern to Baltimore City. In coming weeks, we also hope to have an attractive and informative new website up and running. And we expect to continue our engagement with Open Works in downtown Baltimore.

As you can tell, all in all we're looking ahead to an exceptionally busy and productive year for our already very active League!



Outlook for Work: Voter Growth/Strength/Visibility, Education, Services

District 43A Delegate Candidate Forum by Gail Sunderman

The League of Women Voters Baltimore City and co-sponsor the Northeast Community Organization (NECO) hosted a primary candidate forum for district 43A delegates on June 16. This hybrid forum—both in person and virtual was held at Emmanuel Lutheran Church. In this age of Zoom events, the idea was to give people options and include the benefits of meeting in person. Thirty-five people attended in person and another 55 were virtual. The forum followed the typical League template, with opening and closing statements from the candidates and questions from the audience. Gail Sunderman, LWV Baltimore City organized and hosted the forum, Corey Holland, NECO moderated, Tonaeya Moore, LWV Baltimore City was the timekeeper, and Barbara Dent, LWV Baltimore City assisted with check in and collecting questions. District 45 Primary Forum by Flo Valentine

The 45th District Primary forum with Barbara Jackson, President of the Frankfort Community Association, Inc, was held at Mt Pleasant Church and Ministries located at 6000 Radecke Ave, Baltimore, MD 21206. Mt. Pleasant had a great layout and atmosphere for the forum.

All of the candidates were invited to the forum: Jackie Addison; Chanel Branch; George Johnson; Stephanie Smith; and Caylin Young. The three candidates that showed up for the forum were: Chanel Branch; Stephanie Smith and Caylin Young.

Toni Moore-Duggan, of the League of Women Voters, moderated the forum. The 3 candidates were all very forceful and had many creative ideas for solving some of the problems that plaque the city and District 45 specifically. The incumbents of District 45, Chanel and Stephanie, seemed to agree and work closely together, as the responses indicated. Caylin Young acknowledged this and also was very cohesive with the two delegates.

There was a lot of concern about mental health from the audience. Del. Smith said that she will reintroduce a bill to address alternative solutions. The other candidates were in full agreement with the concerns for future health providers.

The audience was very robust in the questions that were asked of the candidates. Many questions also focused on pubic safety, transportation, and climate change.

Meet and Greet- State's Attorney Office by Flo Valentine


There also was a Meet and Greet for the Baltimore City State's Attorney Office. All candidates were invited and Thiru Vignarajah was the candidate who showed up. He spoke for a short time, because of a prior engagement. Toni Moore-Duggan asked Thiru several questions, including about his priorities for the office. The audience was especially interested in the violent crime in the neighborhood and his plans for solving that problem. What stood out in his comments was that more firearms cases should go to federal court where repeat offenders face stiffer penalties.






Precinct dashboard provides voter data of city

The goal of this project is to have data that informs where the League should conduct outreach and advocacy. The project provides clear information on areas and populations that the League or voting partners can engage to increase civic engagement.

The two images to the right highlight this point. In image 1, Baltimore City data shows that Southwest Baltimore and jailed populations have the lowest turnout and League activities could focus on these areas.

Futher, image 2 shows the areas with least access to the Internet. This would indicate that the League should have more printed materials available for these areas.

We look forward to highlighting future League activities that this project has helped to address in upcoming newsletters.
