strategist at Coursera. I hope to affect real progress in student outcomes, which we must prioritize above all else.

**AREA OF NEED:** The #1 thing we can do to improve student outcomes is attract, train, and retain the very best educators. We're facing a national crisis on this front, as so many people are deciding that pay and benefits just aren't high enough. The hard truth is that the BOE can't solve this alone; we need state and county lawmakers to step up and find a way to increase funding levels. I will work tirelessly to address this daunting challenge at every level necessary.

**SCHOOL ENVIRONMENT:** At a fundamental level, there are two requirements: 1) physical safety and 2) emotional security. These are complex challenges that require a multi-faceted approach, including: clean, well maintained facilities; strong (and numerous) adult presences throughout our campuses; well trained staff; thoughtful prevention and response policies; mental health support; student education; and community engagement. AACPS has made progress on some of these, but there is a lot of work to be done.

MENTAL HEALTH: Yes. We can't afford not to. Suicide rates among teens and pre-teens have grown at a shocking and heartbreaking rate over the last decade. Being an educator is becoming progressively more challenging and stressful. We cannot expect positive student outcomes without positively influencing the mental health within their environment. I will be a staunch advocate for increased mental health resources in our schools to ensure that students and educators have access to the care and support they need.

**EMPLOYEE SATISFACTION:** Besides pay and benefits, there are several initiatives that I would support, including (but not limited to): professional development opportunities, mentorship networks/programs, recognition and career advancement opportunities, work-life balance improvements, priority access to the county's School Age Child Care (SACC) program, and equity and diversity programs.

FISCAL OVERSIGHT: Everything starts and ends with student outcomes; we must prioritize investments with the greatest impact on our students. For me, that starts with attracting and retaining quality educators, investing in early childhood education, enhancing college and career readiness programs, increasing mental health support, addressing critical infrastructure needs, and supporting vulnerable student populations. There is always a balancing act, but at a high level those are my highest priorities.

### • VOTE BY MAIL-IN BALLOT.

Apply at <u>elections.maryland.gov/voting/absentee.html</u> by Tuesday, May 7 to receive a mail-in ballot by regular mail or by Friday, May 10 to download and print a mail-in ballot. Return your completed ballot at an early voting center or polling place, by USPS mail or in a ballot drop off box (see locations on page 3). Ballots must be returned or postmarked by 8 pm on May 14.

• VOTE IN PERSON ON ELECTION DAY. Go to your assigned polling place to vote in person on May 14. To confirm your polling place, check the sample ballot sent by the Board of Elections or go to the Board of Elections website.

# • CHOOSE YOUR VOTING METHOD AND VOTE ONCE.

If you vote during early voting, you cannot vote by mail-in ballot or on election day. If you request a mail-in ballot and decide to vote in person, you

will vote on a provisional ballot that will be counted only if your mail-in ballot is not received.

to the National Association of School Boards. When students are suffering mental distress, it is very difficult for them to focus and learn. That, in turn, puts a greater burden on teachers and all AACPS staff.

**EMPLOYEE SATISFACTION:** Initiatives I support to ensure greater employee satisfaction include: Offering teachers tuition reimbursement to attain additional degrees and certifications; developing a less cumbersome process for certification for conditional teachers, particularly career changers; robust mentoring programs for new teachers with pay/support to veteran educators who serve as mentors; and more equitable time off for custodians and maintenance staff who must come in on inclement weather days, to name a few.

FISCAL OVERSIGHT: The following initiatives complement and support the goals of the Blueprint and promote continuously improving student outcomes: Ensure lowest paid employees earn a living wage, at least \$20 per hour, essential in a district where median income is above \$120,000 a year; maintain robust instruction in all areas of the arts; provide sufficient transportation so all students have access to school based extracurricular activities; continue to grow bilingual immersion programs throughout the county.

### **VOTER REGISTRATION FAQs**

### Am I registered to vote?

In Maryland, registration is permanent as long as you continue to live in the state and keep your address current. To verify your status and your address, go to voterservices.elections.maryland.gov/VoterSearch, or call the Board of Elections.

When you register to vote or change your registration (name, address or party affiliation), the Board of Elections will mail you a Voter Notification Card. If you don't receive a card within three weeks or the information on the card is incorrect, contact the Board of Elections.

### Am I eligible to register to vote?

To register, you must be at least 16 years old, a U.S. citizen and a Maryland resident. You must not be under court-ordered ineligibility to vote. Citizens who are incarcerated for a misdemeanor or while awaiting trial are eligible to register and vote. Individuals convicted of a felony may register and vote when they have completed their court-ordered sentence of imprisonment.

How and when can I register, change party or update my address? For the May 14 primary election, the deadline to register to vote or update your registration online or by mail is Tuesday, April 23.

If you are eligible to vote, you may register in person at one of the early voting centers (see page 2) or at the polling place assigned to your current address. Take your driver's license, state ID card or a utility bill or other mailing that verifies your name and address.

Registered voters may not change their party affiliation at in-person primary election voting sites.

### Who can vote in the 2024 Maryland Primary Election?

Registered voters must be at least 18 years of age on or before November 5, 2024 (the date of the general election) to vote in the primary.

In Maryland, a closed primary state, a voter must be affiliated with a political party to participate in that party's primary election. However, all registered voters in a councilmanic district vote for Board of Education candidates when there is a contested primary race (three or more candidates). The deadline to affiliate with a party is Tuesday, April 23.

AREA OF NEED: Improving early childhood literacy is a topic the Board has discussed for years. We have addressed this issue by selecting a nationally recognized superintendent who has ample experience improving student outcomes. A new curriculum based on the science of reading will be implemented next year alongside enhanced supports for secondary students who continue to struggle in this area. Expanding access to full day preK as well as community partnerships to mentor students will also improve outcomes.

SCHOOL ENVIRONMENT: I stand by my record of supporting a school climate that is inclusive, welcoming, safe, & supportive:hiring 73 new school counselors, psychologists, & social workers, supporting our SROs, implementing restorative & positive behavioral practices, & fighting censorship & regressive policies, to name a few. Additionally, I supported budgets & dozens of contracts that include a variety of school safety systems & measures (cameras, locks, etc). All will continue in a second term

**MENTAL HEALTH:** My record proves my support: I've voted to add more school counselors every year.. Many of our students come to us with trauma, exacerbated by the pandemic & the national gun violence epidemic. Stress & feeling unsafe adversely impact learning & teaching. My worst days as a Board member are when my phone rings with the news of yet another suicide. I will always support measures & cooperative efforts with the county to support student & staff mental health including those in the Blueprint.

**EMPLOYEE SATISFACTION:** Our excellent teachers require better pay. Over the last five years I have substantially increased teacher pay & restructured salary scales which moved us from 19th to 4th for new teacher salary in MD, supported "grow our own" programs to encourage our students to pursue careers in teaching & recruitment efforts nationally & internationally, career ladders that incentivize teachers to stay in the classroom, & student schedules that increased planning time for all elementary school educators.

FISCAL OVERSIGHT: My budgetary priorities are in line with the Blueprint: higher teacher pay, expanded early childhood education, more opportunities for students to prepare for college and career, and more mental health services. Our Superintendent supports these priorities as well. We must ensure that public school funding is not siphoned away to private and home schools so our students have the resources they need which must be distributed equitably. I remain against unfunded mandates imposed by the state.

**SCHOOL ENVIRONMENT:** To secure safe, supportive, and conducive learning spaces, I would prioritize tackling physical safety measures foremost. I'd also hold individuals accountable for disruptions hindering teaching and learning, fostering a culture of respect to create an environment where teachers can teach effectively and students can learn without impediments.

**MENTAL HEALTH:** As a mental health therapist, I strongly advocate for schools offering support to students as well as staff. However, I recommend optimizing community resources. Schools should serve as hubs for parents and children to access information and seek referrals to various community-based providers within the county for comprehensive support.

EMPLOYEE SATISFACTION: Attracting and retaining high-caliber teachers and staff across the district requires a multifaceted approach. Professional development must be a priority as this will enable teachers to refine their skills and excel in their profession, striving to become top-tier professionals in the field. Additionally, soliciting feedback from staff and implementing their suggestions can enhance job satisfaction and retention. FISCAL OVERSIGHT: My budgetary priorities revolve around ensuring adequate funding for essential educational resources, improving reading and math proficiency among elementary students and updating curriculum materials. To balance these priorities with the Maryland Blueprint for Education mandates, I would allocate resources strategically, prioritizing initiatives that align with the blueprint's goals while seeking innovative and cost-effective solutions to meet all educational needs.

### **President of the United States**

**DUTIES:** The President is: the head of state of the United States of America; the Chief Executive Officer; and, the Commander in Chief of all military forces. The powers of the President are prescribed in the Constitution and federal law. The President appoints the members of the Cabinet, ambassadors to other nations and the United Nations, Supreme Court Justices, and federal judges, subject to Senate approval. The President, along with the Cabinet and its agencies, is responsible for carrying out and enforcing the laws of the United States. The President may also recommend legislation to the United States Congress.

**TERM:** Four years. Limit of two terms.

**SALARY:** \$400,000 per year.

### U.S. Senator

**DUTIES:** U.S. Senators make laws along with the members of the U.S. House of Representatives, ratify treaties, and conduct investigations on issues of national importance. The Senate confirms presidential appointments, including Supreme Court justices.

**TERM:** Six years. No term limit.

**SALARY:** \$174,000.

**HOW ELECTED:** Elected statewide. In 2024, Maryland voters will elect one of our two Senators. About one-third of the 100 members of the Senate are elected every two years.

We must develop public-private partnerships to assist our students in receiving mental health care. Staff should also be trained in de-escalation techniques, to help lower high-emotion situations. **EMPLOYEE SATISFACTION:** Teachers, like all others, want to feel valued. Working with new teachers, I heard many speak of the high cost of housing in our area. Again, I would recommend the redevelopment of the New Teacher Housing Initiative, a program for which I had, during my career, gained county government support and developer support but did not



# **Anne Arundel County Board of Education: Districts 1 - 7**

BACKGROUND: Legislation enacted in 2017 changed the Anne Arundel County Board of Education from an appointed to an elected body and eliminated one adult Board position. Implementation of the new structure began in 2018 with the election of four Board members to a six-year term. In 2020, three Board members were elected to a four-year term, and in 2024, all seven adult Board positions are on the ballot.

**DUTIES:** The duties of the Board include, but are not limited to, the following: selecting and appointing the Superintendent of Schools; appointing personnel; continuous appraisal of the educational and administrative management of the school system; communicating and meeting with community members, staff and students; ratifying collective bargaining agreements; adopting policies, budgets, and courses of study; establishing school boundaries; making decisions on facility, procurement and financial matters; and deciding appeals.

**TERM:** Four years; limited to two consecutive terms.

**SALARY:** \$8,000 per year.

**HOW ELECTED:** Elected by voters in each councilmanic district. See councilmanic district map on page 55.

**QUALIFICATIONS:** The Board is comprised of seven adult members, and one student member who serves a one-year term. Members must be residents of Anne Arundel County; elected members must reside in the councilmanic district they represent. The student member is selected by the Chesapeake Regional Association of Student Councils (CRASC) and is a regularly enrolled senior-year student of good character and in good standing in a public county high school.

# **Party Convention Delegates**

**DUTIES:** Party Convention Delegates represent voters in each party in selecting the party's nominee for U.S. President/Vice President at the party's national convention. In the primary election, voters affiliated with each party elect Convention Delegates who support their choice for President. Presidential nominees are not selected directly by voters in the primary.

### **Democratic Delegates**

**HOW ELECTED:** Maryland Democratic voters will elect 63 Convention delegates, with the number per Congressional district based on the number of Democratic voters in that district. Each of Maryland's eight Congressional districts will elect approximately equal numbers of female and male delegates. The candidate's gender and presidential candidate they support will be listed under their name on the ballot. Presidential candidates will receive delegates in proportion to their share of the vote in that district.

### **Republican Delegates**

**HOW ELECTED:** Maryland Republican voters will elect a total of 24 Convention delegates and 24 alternate delegates. Three delegates and three alternates will be elected from each of Maryland's eight Congressional districts. Republican party ballots list the candidates for Convention delegate and alternate delegate, along with the name of the presidential candidate each one supports. The presidential candidate receiving the greatest number of votes in each district will receive the votes of all three of that district's delegates.

# **Judge of the Circuit Court: Circuit 5**

**DUTIES:** Judges preside over trials in the Circuit Court, which is a court that hears major civil cases and serious criminal cases, such as those requiring a jury trial. Circuit Courts may decide appeals from the District Court and certain administrative agencies. The Fifth Circuit Court serves Anne Arundel County.

HOW ELECTED: Elected countywide. The state is divided into eight Judicial Circuits. When there is a vacancy, a nominating commission reviews the qualifications of applicants for the judgeship and recommends several names to the Governor, who appoints a person from that list to fill the office. Each newly appointed judge must run for office at the first election that occurs at least one year after the vacancy occurred. Sitting judges must also run for re-election after serving for 15 years. Attorneys who are members of the Maryland Bar may also run to challenge a newly appointed or sitting judge. All candidates run on both the Democratic and Republican primary ballots.

**TERM:** Fifteen years. No term limit. Mandatory retirement at 70 years of age.

**SALARY:** \$194,433 per year.


