About This Voters' Guide

This *Voters' Guide* is published by the League of Women Voters of Queen Anne's County and covers all races for which voters in Queen Anne's County may vote. The League has a long tradition of publishing the verbatim responses of candidates to questions important to voters. All candidates for state or local office, who filed with the State Board of Elections, were invited to submit information about their candidacy to our web-based VOTE411 system. All invited candidates were asked to provide their campaign contact information and their responses to a series of questions posed for each office. All candidates were limited to 400 characters for each response; responses shown are what candidates entered up to the stated limit. All candidate responses appear as written in their own words and are included in VOTE411 in their entirety. Due to printing constraints, not all questions and responses are included in this Guide; and only candidate website, if available, is included here for contact information. Go to VOTE411.org to see all questions and candidate-submitted information. The League offers this Voters' Guide to assist citizens in their decision-making process as they prepare for participation in the 2022 gubernatorial elections.

Party Primaries in Maryland

Party primaries in Maryland are "closed" primaries. You must be a member of a political party to participate in that party's primary, though all voters may vote for nonpartisan offices such as the Board of Education. You may change your party affiliation up until the close of voter registration on June 28 by completing a voter registration form and submitting it to your County Board of Elections.

You may also change your party affiliation online if you have a Maryland driver's license or identification card from the Motor Vehicle Administration.

If you have not previously registered to vote, you may register during early voting (July 7-14) at an early voting center in your county and choose a party at that time. For those already registered, you may correct your address or other information during early voting; however, you cannot change your party registration at that time.

You must be at least 18 years old by Nov 8, 2022 and a registered voter in your County to be eligible to vote in the Primary.

HOW TO USE THIS GUIDE

Read this *Guide* with your mail-in or sample ballot in hand, and mark your ballot accordingly. Take your sample ballot with you when you vote as *you are not permitted to use electronic devices, such as smartphones, tablets, and computers, inside polling places.*

Pay attention to the number of votes you can cast for each race; checking more than the maximum allowed will invalidate your vote for that race.

Check both sides of your ballot for additional races.

DUTIES: The Governor is the head of the executive branch and appoints the heads of statewide departments and judges in the state courts. The Governor proposes the annual operating and capital budgets to the legislature and may veto legislation passed by the legislature. The Lieutenant Governor assists the Governor and carries out specific duties assigned by the Governor. The Lieutenant Governor fills the office of Governor in case of death, resignation, or disability.

QUALIFICATIONS: State Delegate Dan Cox is a husband, father, Republican conservative candidate for Governor of Maryland and believer in the goodness of God for the people of our great State. QUALIFICATIONS: The Baker/Navarro ticket is

the most experienced in the race, with unrivaled State and local governing experience. Both candidates understand how to get things done in Maryland like few others, precisely because they have done them. They will use this experience to bring together diverse stakeholders from across the State together to address our greatest challenges.

ECONOMIC INEQUITIES: The State is the central player in reducing economic disparities, and lifting up the people who have been historically left behind by the people in power. Our campaign has released the Roadmap for Equity, Inclusion, and Diversity which will tackle this problem and help

HEALTH CARE: Despite all that has purportedly been done on this issue, the prohibitive cost of healthcare in this country is shameful. That is why it is our goal to implement a single-payer system in the State to ensure all Marylanders are able to access the care they need, when they need it. We know that this will be a monumental task, but it is a necessary one for so many who have suffered without care.

NATURAL RESOURCES: Every Marylander knows that the heart and soul of the State rests in the Chesapeake Bay. It is our greatest asset, and at the moment we are not treating it with anywhere near the respect it deserves. To tackle this, we will establish a pollution revolving fund, which will incentivize polluters to clean up their own waste, and save taxpayers money in the process.

INFRASTRUCTURE: Given the dire situation we are faced with right now, environmental concerns must take precedence over convenience. That said, we believe our infrastructure needs go hand in hand

with our environmental ones. My infrastructure priorities are projects like the Baltimore Red Line and starting the Southern Maryland Light Rail. These projects will be done sustainably and take cars off the roads.

other priorites: One of the greatest challenges we face today is the corrupting influence of money in our political system. That is why we decided to fund our campaign through public financing, to ensure that voters know that we will not deal with PACs and big money donors. Our administration will expand this program, allowing more candidates the ability to run for office without letting dark money influence them.

QUALIFICATIONS: I'm a former nonprofit executive and Clinton Administration official with a record of driving real change from inside and outside government. After serving in the Clinton Administration, I founded a nonprofit that sparked a movement to advance evidence-based policymaking—working with the Bush & Obama Administrations to enact major reforms that led to significant gains in wages, education, & more.

ECONOMIC INEQUITIES: Wages for the bottom 40% in MD have been stagnant since the 1980s, as income inequality has soared. We'll partner with MD businesses to provide proven job training programs to every adult who wants to advance. Done right, job training can increase earnings 20-40%. The key is to focus on fast-growing industries, and work hand-in-hand with employers who provide paid internships to the trainees.

PUBLIC SAFETY: We'll fund crime-fighting strategies shown to produce big reductions in violent crime while building community trust, such as Focused Deterrence—an approach targeted at

repeat violent offenders. When implemented in Oakland CA, it helped cut homicides by 50%. We'll also invest in community policing in "hot-spots" where half of all urban crime occurs—an approach found to cut crime as much as 25%.

EDUCATION: More than ¼ of MD middle schoolers can't read at a basic level; more than ½ can't do basic math. We'll expand solutions that are tested and proven to deliver results. For example, we'll raise an army of tutors from the community to help every struggling 1st and 2nd grader in MD—moving them up toward grade level early, before their problems become serious, & reversing COVID-related learning loss.

HEALTH CARE: Marylanders are paying 50% more in out-of-pocket healthcare costs than they were 10 years ago, after adjusting for inflation. That's unacceptable. Our administration will negotiate significantly lower prescription drug prices - saving Marylanders up to \$100 million each year and offer a robust public option health insurance plan cheaper than those currently on the market. **NATURAL RESOURCES:** MD must lead the nation in cutting carbon emissions. We'll pursue a regional approach, building on the successful Regional Greenhouse Gas Initiative — an 11-state cap-and-trade program that's cut power plant emissions 47%. We'll expand this approach to other sectors by joining the Transportation and Climate Initiative (focused on transportation), as part of our comprehensive climate policy.

administration will ensure a thorough environmental review precedes implementation of any infrastructure project, and we will not pursue projects that would cause unnecessary or irreparable harm to the environment. From mass transit to highways and other investments, our administration will strike a balance between needed

infrastructure and protection of our natural resources.

OTHER PRIORITIES: Our campaign is not taking a dime from corporations, PACs, or MD lobbyists, because Maryland deserves a governor who answers to the voters – not special interests. Our administration will also require independent assessments of our key policies – the results of which will be reported to the governor, voters and General Assembly at the same time.

My extensive track-record in public service has demonstrated that I know the issues that are unique to Marylanders, and I have successfully implemented solutions to solve their problems. help people access job training and placement that lead to stable, lifelong careers. I define the middle class as good wages, healthcare, home ownership, and retirement. I believe the State can help stimulate these opportunities by investing in new infrastructure like world class public transit and renewable energy, and partnering with stakeholders like unions on them.

PUBLIC SAFETY: I have no tolerance for police misconduct or crime. My policies will approach public safety through a lens that situates it within a broader social context rather than as a stand alone challenge. I support policies such as ending no knock warrants, prioritizing community policing, evaluating police training standards, treating

addiction as a health issue, and focusing on violent repeat offenders

EDUCATION: I will be an education-oriented governor with a focus on empowering our students and teachers. I will address student/teacher burnout by reducing standardized testing, and allow collective bargaining on classroom size. I will also pilot an experiential learning model, push for fully elected local school boards, and ensure no school building suffers from a lack of infrastructure.

HEALTH CARE: I am committed to lowering health costs and expanding affordable primary and preventative care. I will expand Medicaid coverage, focus on controlling prescription drug prices, and expand Maryland's total cost of care model for the commercial insurance market to control the rising costs. I will also ensure every Marylander is within a 15-minute commute to a Federally Qualified Health Center.

NATURAL RESOURCES: One of my greatest concerns is that we do not have a justice oriented approach to addressing environmental concerns. Improving the environment is a matter of effectuating justice. I will remove polluters which are disproportionately placed in communities of color, and provide job training/placement for those who work in industries that will become increasingly obsolete in the new economy.

INFRASTRUCTURE: I believe we can walk and chew gum at the same time, and I will implement policies that align our infrastructure initiatives with our environmental goals. That means building more public transit for the economy of tomorrow, while alleviating traffic congestion today. I will also require the entire fleet of state vehicles to convert to electric by the end of my first term.

OTHER PRIORITIES: I am committed to building a world-class transit system by reviving the Red Line project and increasing pedestrian/cycling trails. I will make voting more accessible, and secure

access to high-speed broadband and 5G wireless technology for every Marylander. All of my policies are integrative, and with my experience I will improve the quality of life of all Marylanders.

As a former federal prosecutor, Montgomery County State's Attorney, and MD Attorney General, I am the only candidate with a background in criminal justice, and along with my running mate, a former Mayor, we are the only team with executive-level experience in government.

ECONOMIC INEQUITIES: Safe communities are strong communities. As governor, I will be aggressive about lifting communities out of poverty through education and economic development. As we create new jobs, we will strengthen schools and workforce training to get Marylanders into these new jobs. By building more housing near transit, we can make living in Maryland more affordable and make access to these new jobs easier.

PUBLIC SAFETY: We cannot reduce crime without increasing accountability because when people don't trust the police they are less likely to call them when they need them most. My Safe Maryland plan, which will add 1,000 police statewide, recognizes this and weaves the need for better-trained and better-paid police with bold actions that will work to rid agencies of bad practices, bad policies, and bad officers.

EDUCATION: Teachers and students were resilient through COVID, but now two years later many have returned to the same unsafe buildings, large classrooms, and demanding tests they left --

only this time with additional challenges due to the COVID learning gap. As governor, I will ensure full, timely implementation of the Blueprint, add SRO's, and take actions to increase student achievement and wellness now.

The Comptroller collects and administers Maryland taxes on income (both personal and corporate), retail sales, motor vehicle fuel, tobacco, beer, and wine and liquor, as well as estate taxes. The Comptroller serves on the Board of Public Works along with the Governor and the state Treasurer, who is appointed by the General Assembly. The Board of Public Works must approve major contracts for the purchase of goods or service by any department of state government.

TERM: Four years. No term limit.

SALARIES: \$150,000.

I was an Assistant District Attorney in the Bronx, NY; Chief of the Bronx DA Homicide Bureau; Prosecuted David Berkowitz, "Son of Sam" killer, for 3 Bronx murders; an Assistant Attorney General of New York State; Attorney for United States Department of Justice, Antitrust Division. Since 1994, private law practice in Maryland.

ADMINISTRATION OF JUSTICE: I will establish community offices throughout the State where every month an Assistant Attorney General will meet with residents to hear their concerns, complaints and information that will help our office initiate, investigate and prosecute, if necessary, criminal conduct, discrimination, and other violations of law in areas such as the environment, elections, civil rights, and elder abuse.

PUBLIC SAFETY: Reducing crime will be my top priority. I will create a Major Offense Bureau to assist or replace local prosecutors in the prosecution of violent and repeat offenders. No plea bargaining or deals with these offenders. Police accountability will be reviewed by my staff with my personal involvement. Restoring public trust in policing and the criminal justice system will come from more transparency.

PUBLIC HEALTH: The most violent and serious offenders of these crimes must be prosecuted vigorously with no plea bargaining or deals. This includes dealers and distributors of illegal drugs and narcotics. Drug users and addicts should be given drug treatment, therapy and counseling. Addiction is a disease and should be treated so that they can be cured.

JUVENILE JUSTICE: The crime committed by a juvenile and their history should determine their punishment and/or treatment. As a prosecutor, some of the most violent and heinous crimes I've seen have been committed by juveniles as young as 14. Juveniles committing non-violent offenses and who are not serious repeat offenders need treatment, counseling, drug or mental health programs. Others may need incarceration.

CONSUMER PROTECTION: Consumer fraud is primarily an offense against the elderly, infirm and most vulnerable. To me, these are very serious criminal offenses especially by those who prey on these victims. The most effective way to deter these

scammers is to seek meaningful jail sentences against the worst offenders. This will deter others from scamming and defrauding victims not just fines and desist orders.

TERM: Four years. No term limit. **SALARY:** \$52,343 as of January 11, 2023.

HOW ELECTED: Elected district-wide. The state is divided into 47 legislative districts. Each district is represented by three Delegates, for a total of 141 Delegates statewide.

They maintain and update the Talbot County Code and oversee the administrative units of the County including Planning, Planning and Zoning, Public Works, and Budget and Finance. The County Council is composed of five members elected at large.

QUALIFICATIONS: O'Donnell runs a small business and is a 10th generation Eastern Shore resident. As an outdoorsman, he values the natural beauty of our county and wants to preserve the peace and safety we enjoy. Kyle holds a bachelor's of science in Textile Technology with an emphasis on manufacturing and a Masters in Business Administration with a concentration in sustainability.

BUDGET: Talbot County has the lowest property tax in the state. We should keep it that way. In 2021, Talbot County Government taxes and service fees totaled ~\$133,000,000. That's more than enough money to run our government and provide for education, peace and safety, and the judiciary. Ideally, we can select, consolidate, and eliminate

some minor taxes, fees, and expenses to decrease complexity.

PRIORITIES: 1) Keep taxes low 2) Continue to preserve the peace that makes Talbot a safe place to live. Increase passive infrastructure design to reduce accidents and fatalities on our county roads, sidewalks, bike lanes, and intersections. 3) Upgrade end-of-life wastewater treatment plants, whose extended life is thanks to the hard work and creative maintenance of the sanitary sewer staff.

bevelopment and Land use: There should be no radical changes to land use outside of town limits. Towns set their own land use.

Suburban sprawl outside of towns and overexpansion should be avoided, while allowing flexibility around auxiliary dwelling units like granny flats or studios for young people on a family's land to keep families together. Increase walkability with safe sidewalks and greenways for outdoor exercise.

EMPLOYMENT: Over 10 years, average income in Talbot has risen from 55k to 76k thanks to small businesses and organic growth of the private sector, supported by county infrastructure. Counter water, wastewater, roads, bridges, and infrastructure should be in good working order, leaving space for these families to naturally let the local economy flourish, let wages rise, and see people increase their skills.

AFFORDABLE HOUSING: Net-zero multifamily homes on Port and West Street are great, along with the Habitat for Humanity's program. These units are attractive and fit the local character of our county, in contrast to cookie-cutter apartments rectangles. There's an opportunity here for public-private partnerships to get state and federal grant money into our county. Auxiliary dwelling units are affordable options too.

PUBLIC HEALTH: The old saying goes, "an ounce of prevention is worth a pound of cure." Increase walkability, exercise opportunities, and

QUALIFICATIONS: I have several professional experiences that equip me to address issues that are important to our votes. I've been leading the transition of a shared sanitation system to Talbot County for the past four years, building important relationships with local and state government. I

built and developed healthcare practices in Talbot County, and understand the imperative need for broadband..

BUDGET: Ensuring that our county can continue to prosper means equipping our county employees - teachers, law enforcement and fire fighters - with equitable and competitive pay. We must solve for how we to do this, especially with inflation outpacing revenue opportunities. Looking for revenue generating opportunities outside of the tax base is one way to challenge the status quo in Talbot County.

PRIORITIES: Our next County Council will serve a critical role in developing the comprehensive plan which will set our compass for the next ten years. This is an important responsibility and is due respect and investment by the Council. Critical issues include healthcare and public safety, broadband availability, clean water and ethical sanitation and education. These issues effect every resident.

DEVELOPMENT AND LAND USE: One of the contributing factors that drew my family to Talbot County was the rural environment. Our community places significant value on this. Watermen and farmers rely on this land to provide for their families. I am focused on thoughtfully developing Talbot County to meet our residents and businesses where they need, but always being mindful of the values that make Talbot County special.

PUBLIC HEALTH: Our public health system in Talbot County rose to the occasion during COVID and demonstrated how exceptional they are as a community resource. We must provide for our public health system with resources to include a new office. COVID is very likely sticking around for some time, and the better we are able to resource the public health system, the better our community can be cared for.
