

### **Petition to the San Bernardino County Supervisors**

Sunday, June 12, 2022

Dear San Bernardino County Board of Supervisors,

We ask that you enact an immediate 'pause' on the renewal of, and issuance of new Short Term Rental (STR) permits in the un-incorporated communities of San Bernardino County.

We are not advocating for the abolition of STRs, however the unchecked proliferation of STR 'businesses' are contributing to a housing crisis that is exacting a terrible toll on the citizens, businesses and communities of the County. The first step in solving any problem is to acknowledge, and then define the problem; a 'pause' will provide the time needed to undertake studies and analyses that will culminate with the adoption of balanced policies and regulations needed to address our housing crisis.

#### **SECTION I - COMMENTS**

	Full name	Comment
1.	Pam Anders	Please, please, please! Our local Community is collapsing.
2.	Anna Aramburu	Due to concern for our community and the need for housing, I ask that you consider limiting the amount of STRS one individual or corporation can have to 2. I am a teacher and work for MUSD. Families can't afford to live here and work locally if all the housing goes to STRs rentals.
3.	Cathleen Armstrong	This is overdue. Short-term rentals are degrading quality of life for full-time residents.
4.	Russel Bainbridge	We need to stop with all of these short term rentals . It's causing people to be homeless. Thx Russ

5.	Mary baumann	Please pause and rethink STR plan for JT. There is no balance or method to the madness.
6.	Sandra Beckwith	Consideration of impact on local communities, businesses, infrastructure, resources, housing, people, must be a part of the permit issuance process, for the health of our communities.
7.	Shelley Black	I own two long term rentals in Big Bear City and have an interest in limiting STRs in the unincorporated areas of San Bernardino County. We need more long term housing options for our permanent residents who support the infrastructure of our community. The influx of STRs is taking housing from permanent residents.
8.	Brenda Blank	After being displaced, from the home we were renting for 8 years, and given 60 days to move, so it could become an "Air BnB, the only somewhat affordable housing we could find was a month to month lease, at a increased rental of 500 a month above what we were paying. My husband has since lost his leg due to burns sustained by a faulty faucet in the new rental, with no recourse. We now pay 1750.00 for a month to month lease. I need security for my family. As do so many others. The situation has become dire for so many. Something must be done for the families that ARE the community!
9.	Lori Bloom	Please place a pause on new STR permits until the balance of the needs of the community and the STR owners can be figured out.
10.	Lance Bowen	1 month should be the shortest rentals allowed in the area,
11.	Ronald Bukovac	I have 5 STRs around me. Also, we are losing long term rentals for our hospitality and service workers, forcing them off the mtn
12.	Kerry Cole	I had to move 2 times in the last year because people are selling their rental homes. Each time we had to move the rent prices have gone up. I currently pay double the rent as the home I originally rented a year and a half ago. I had to move further from work because no rentals are available. I now live an hour away from the school where I teach.

13.	Caroline Conway	Our small house at the western edge of Joshua Tree National Park is now surrounded by 6 STRs and we are losing our longtime neighbors in Monument Manor. Our dirt roads cannot handle the traffic and the trash situation has gotten worse as rental bins are overfilled and often topple. The wildlife has suffered and we know poison bait is being used by the STR management company in our area. Traffic has increased and we are terrified that guests who do not understand the the fire danger will lose control of one of the their frequent recreational fires.  This pause is necessary as the County needs to see how STRs have changed our communities.
14.	Martin Cox	You have ruined our desert home.
15.	Petrina Cressy	I have Airbnb's on both sides of me across from me and behind me. One of which looks directly down into my backyard. we no longer have families, children, or neighbors. Everything is about out of towners profiteering from our wonderful desert, I have six children and none of them will ever be able to afford to live in the town I raised them in I was born in Yucca Valley in 1965 and moved to Joshua tree in 1988. This is a very sad reality for my children!
16.	Chris Crow	We're experiencing deteriorating roads, trespassing, unmonitored recreational fires, increased traffic, rodenticide use, diminished wildlife (except for ravens & roaches), late night lights & noise, overflowing trash bins, & speeding.  Time for a breather to better manage the increasing problems resulting from treating an otherwise peaceful residential area as a commercial enterprise zone.
17.	Carrie Dagher	I no longer live in peace. My neighborhood has become a corporate entity which was never zoned to be one. Why is this even legal?
18.	G. DaPonte	We are drowning in AirBnBs - our neighborhoods are not motels! No more!!!
19.	Michelle DiSimome	Businesses don't belong in residential neighborhoods. What used to be my "happy place" has been overrun by STR hotels with an everrevolving door of strangers infiltrating our formerly peaceful community.  Enough is enough. Please enact a pause on new and renewal permits until realistic regulations can be determined and adopted.

We are already experiencing a labor shortage in our town because of this. And what's with all the new pools? We're in the middle of a severe drought, we're being asked to reduce our water usage, and permits are still being issued for new in-ground pools, consuming thousands of gallons of water, for these STR's?

44.	David Hertel	It feels like my quiet Joshua Tree residential neighborhood is being rapidly taken over by STRs. I have no objection to a reasonable amount of STRs, which are an important source of income, but there should be some limits. Especially concerning are units that allow large numbers of people and cars. These attract renters who want to party, talk loudly outside, play amplified music day and night, light campfires and turn on bright lights. This happens not just on weekends or special occasions but just about daily somewhere nearby. All of these activities are inappropriate for an area where sound carries very far, the roads are delicate, fire danger is high, rare wildlife gathers, and dark skies are valued. It is annoying to the point where people are moving away because of the STR issues, which then potentially makes the problem worse. Thankfully the new mechanisms for reporting problems and assessing fines are having some effect, but I think it's important to hit the pause button and evaluate where everything is going and what we want the end game to be. At some point a lack of sufficient permanent neighbors alone will be enough to drive remaining long term residents away.
