

Petition to the San Bernardino County Supervisors - ADDENDUM & FINAL SUMMARY- June 13, 2022

This ADDENDUM includes signatures and comments received after the Petition was sent to BoardMeetingComments@cob.sbcounty.gov on Sunday, June 12, 2022. The online petition is now closed. The total data summary below includes what was sent previously plus 23 additional signatures and 13 additional comments.

Monday, June 13, 2022

Dear San Bernardino County Board of Supervisors,

We ask that you enact an immediate 'pause' on the renewal of, and issuance of new Short Term Rental (STR) permits in the un-incorporated communities of San Bernardino County.

We are not advocating for the abolition of STRs, however the unchecked proliferation of STR 'businesses' are contributing to a housing crisis that is exacting a terrible toll on the citizens, businesses and communities of the County. The first step in solving any problem is to acknowledge, and then define the problem; a 'pause' will provide the time needed to undertake studies and analyses that will culminate with the adoption of balanced policies and regulations needed to address our housing crisis.

4.	Laura Emerick	A PAUSE to STR permits is very much needed for the well-being of the Morongo Basin's economy. Too many local month-to-month renters are being pushed out of their homes, employers get too few applicants for job openings, STR hosts have lower than expected bookings due to a glut of STRs in the Morongo Basin, the school district has recently lost about 10% of its students, Mojave desert habitat is being scraped at an unprecedented rate by out of the area investors who are now late to the quick profit investment game. And how long are the lines for a table at a restaurant in Joshua Tree? There aren't sufficient services or infrastructure for an overwhelming influx of tourists. A PAUSE in STR permits is very much needed at this time. Thank you.
5.	Jennifer Good	STR's in Joshua Tree have become prevalent in a community that needs more properties for people to rent, live and work in the area. We have four houses in a row, close by that are now short term rental properties. It is changing the whole spirit of our neighborhood. There seems to be no ordnance to limit the number of properties that can be rented in this manner in one street. Owners of the STR's are very often out of state and in a different time zone. Contacting them when noise levels are extreme is difficult. I vote for a pause on granting the permits for STR's in Joshua Tree, and full evaluation of the situation and impact on small communities.
6.	Karen Kennaugh- Holmes	I know families that have to uproot their children, because the homeowners are selling to STR buyers, and the families are unable to find another rental. We do need balance and limitations.
7.	Susan Lefevre	I wish more locals had the proper foresight to object back when our county supervisors allowed STR's to be licensed and permitted here in the entire Morongo Basin. Small, residential areas have been invaded and consumed by illegal commercial enterprise. Shameful. Please fix this now and return STR's to be allowed only on personal property that is owned and lived on by the individal persons who are non-commercial land-owners. Ban all LLC's and corporations who operate these illegal businesses in our neighborhoods.
