## **Thank You Poll Watchers**

Thank you for becoming a poll watcher in Mclean County. I know you are interested in making positive changes in our county. One of the most powerful local offices that many people have not heard of is Precinct Committeemen. Precinct Committeemen are elected every two years by the voters of their local voting precinct. Some of the duties of a PC are as follows: Commission election judges, distribute information on candidates that they personally support, recommend candidates for office, register voters, be a poll watcher, elect county party leaders who then elect state party leaders, pass candidate petitions, and Drive Out the Vote!

McLean County has 111 precincts. Currently, the Republican Party of Mclean County has 62 PC positions filled. Forty-nine precincts in McLean County do not have anyone performing the essential duties of the PC. Your voter registration card shows your precinct number. You can easily see from this list if your PC position is filled. If unsure, you can contact Connie Beard (<a href="mailto:chairman@mcleancountyrepublicans.org">chairman@mcleancountyrepublicans.org</a>) or Joanne Knipmeyer (<a href="mailto:executivedirector@mcleanGOP.com">executivedirector@mcleanGOP.com</a>).

PCs were elected in the June primary to serve for two years. Running on the ballot as a PC is easy. It starts by collecting ten signatures of registered voters in your precinct, and you will be on the ballot. The good news is that even though the election for PCs is over, if your precinct does not have an elected PC, you can be appointed by Connie Beard. Connie is the McLean County GOP Chair. It is as easy as emailing Connie (<a href="mailto:chairman@mcleancountyrepublicans.org">chairman@mcleancountyrepublicans.org</a>) and expressing your interest in being appointed to serve as a PC. If your precinct has an elected PC and you are interested in assisting with the duties on the PC list, Connie Beard can give you contact information for your PC, and you can ask to assist as a block captain.

# What Happened To The Expected "Red Wave"?


Many conservative voters across the nation were looking for a "red wave" to materialize during the November General Election. It did appear here and there. Unfortunately, it did not materialize everywhere. Some states, like Florida, experienced the red wave, but others, like Illinois, did not.

Locally, we had hoped for a swing away from a 50-50 Republican-Democrat County Board to one decidedly Republican. After the election was over, however, McLean County was left with 10 Republicans and 10 Democrats as before, with no straightforward way to determine how the Board will be led. The status quo was maintained, but things will be much more confusing and controversial.

On a statewide level, we did not win the Governorship (Darren Bailey), Lt. Governorship (Stephanie Trussell), and its accompanying offices such as Secretary of State (Dan Brady), Attorney General (Tom DeVore), Treasurer (Tom Demmer), and Comptroller (Shannon Teresi). Neither did the Republican candidate for the US Senate, Kathy Salvi, win her election. Locally, our candidates for State Senate (Desi Anderson) and Representatives (Scott Preston and Esther Joy King) did not win. Fortunately, several other Republican state and local candidates were returned to office.

This pattern was repeated time and again across the nation. Again, the expected red wave did not materialize. What happened, and what will be the consequences? MCGOP leadership will keep these comments and concerns in mind as we move forward to this spring's consolidated elections for the Unit 5 school board and city and town governments of Bloomington and Normal.



## Ingredients:

1 env. unflavored gelatin

1 c. granulated sugar

½ tsp. salt

4 egg yolks

1/3 c. fresh squeezed lemon juice

1 tsp. grated lemon peel

4 egg whites

1 c. Cool Whip topping

2 shallow 9-inch graham cracker crusts

#### Directions:

Combine gelatin, *half* of the sugar, and salt in a heavy saucepan. Beat egg yolks together, adding lemon juice and 2/3 cup water. Stir into gelatin mixture. Stir over medium heat until the mixture comes to a boil and the gelatin dissolves. Remove from

heat and stir in grated lemon peel. Chill in an ice bath, occasionally stirring, until partially set. In a separate bowl, beat egg whites together, gradually adding the remaining sugar. Continue beating until soft peaks form. Fold egg whites into a partially set gelatin mixture. Fold in the Cool Whip topping. Pour into graham cracker crusts and chill until firmly set.

# **City And Town Council Races On The Ballot**

Bloomington and Normal had seven candidates file for positions on their respective city/town councils in the April 4<sup>th</sup> election. Normal has also received three petitions for offices that do not exist but are mandated by the Illinois Municipal Code that the town appears to have been ignoring for many years. This election will feature these candidates and candidates for school boards, though it will be a few days before school board petitions are due.

In **Bloomington**, the following candidates have filed for city council:

- Ward 1: Jenna Kearns has filed for candidacy. Incumbent Grant Walch chose not to run.
- Ward 2: Donna Boelen, the incumbent, is seeking re-election.
- Ward 4: Steven Nalefski and John Wyatt Danenberger have filed for candidacy. Incumbent Julie Emig did not file for a second term.
- Ward 6: Jordan Baker and Cody Hendricks have filed for candidacy. De Urban, who was appointed temporarily to replace Jenn Carillo, did not file.
- Ward 8: Kent Lee is the only candidate to file for candidacy to replace Jeff Crabill, who is not running for a second term.

Other City Council seats in Wards 1, 3, 5, and 7 will be filled in the 2025 election. At this time, a mayor also will be elected.

In **Normal**, three trustees' four-year terms are expiring and are up for election: Stan Nord, Karyn Smith, and Kathleen Lorenz. Four additional individuals have filed for election as trustees: Marc Tiritilli (former mayoral candidate), Andy Byars, Karl Sila, and Rachael Lund.

Three candidates also filed for non-existent seats in Normal town government following this summer's failed referendum to declare the town a village. In the outcome of a legal hearing, Normal was ruled an incorporated town. It, therefore, appears to lack town officers mandated by the Illinois Municipal Code. The following filed for these positions:

Amy Conklin submitted petitions for town clerk Charles Sila filed for town collector Robert Shoraga filed for town supervisor

These offices are not generally on the ballot, so their petitions could be contested to see how the fallout from the recent town vs. village controversy will be handled.

While the turnout for these sorts of elections tends to be low, the elections are critically important to the operations of our municipalities and schools.


