## According to Illinois Law, the State's Primary Election will be held on March 19, 2024. Party primaries include the following candidates for office:

- ✓ President of the United States
- ✓ Representatives in U.S. Congress All 17 Districts
- ✓ State Senators in Districts 1, 4, 7, 10, 13, 16, 19, 22, 25, 28, 31, 34, 37, 40, 43, 46, 49, 52, 55, and 58.
- Representatives in the Illinois General Assembly All 118 Districts
- ✓ Sanitary District Commissioners/Trustees
- Circuit Clerks
- Recorders (in counties with a population of 60,000 or more inhabitants)
- State's Attorneys
- ✓ Auditors (in counties with a population over 75,000 and under 3,000,000)
- ✓ Coroners
- ✓ Regional Superintendent of Schools (vacancies)
- ✓ County Commissioners (Counties not under township organization)
- ✓ County Board Members (Counties under township organization)
- ✓ Judges (Additional Judgeships if required)
- ✓ Supreme Court Judges, Vacancies will be filled
- ✓ Appellate Court Judges, Vacancies will be filled
- ✓ Circuit Court Judges, Vacancies will be filled
- Resident Circuit Court Judges, Vacancies will be filled
- ✓ Subcircuit Judges, Vacancies will be filled

#### **PolitiBits**

PoliltiBits are bits of useful political information too small to merit a separate article. They are compiled here for their appeal and interest. (Please note that announcements of candidacies do not constitute endorsements.)

- ★ On October 14, a small contingent of McLean County Republicans participated in the ISU Homecoming Parade. Here at the assembly point are Gary Stevens (with violin), Brandon Hepner (driving), and Jim Fisher.
- ★ On October 20, the MCGOP held a members-only film screening featuring *Sound of Freedom*. General and premium MGCOP members were invited to watch the movie in a comfortable setting with a 75″-screen TV, surround sound, and plenty of treats. A small contingent attended, but they had a rollickingly good time thanks to the event sponsor.
- There are now seven announced Republican candidates for State Senate in the 53<sup>rd</sup> District. Since last month's MCGOP newsletter, new candidates to announce from our vicinity are Washington Mayor Gary Manier and Jesse Faber, a farmer who teaches agriculture at Pontiac High School. Manier and Faber join Grundy County Chair Board Chris Balkema and former Livingston County Board member Mike Kirkton in the race to fill the seat now held by Senator Tom Bennett. Bennett declined to run again, fulfilling a campaign promise to serve only a limited number of terms. The 53<sup>rd</sup> District is a predominantly Republican region with parts of thirteen Illinois counties, including McLean, Peoria, and Tazewell.
- \* Randall Knapp has been appointed as the newest member of the McLean County Board for District 5 in Normal. His appointment was approved by the Board on Thursday, October 12, with a decisive 17-2 vote. His appointment was made among four individuals who had applied for the position. Following the vote, Knapp replaced longstanding member John McIntyre, who had served as the Board chair until September. McIntyre, a Republican, resigned due to health issues, and according to Board rules, his seat had to be filled by a fellow party member. The appointment of Knapp received unanimous support from all the Board's Republicans, with the endorsement of the new chair, Catherine Metsker. However, two out of the 10 Democrats on the board, namely Beverly Bell (District 6) and Corey Beirne (District 10), cast dissenting votes.
- \* Randall Knapp and Chad Berck will run in the April primary for seats on the McLean County Board. Both will be running in District 5. Knapp will be running for the two-year term; Berck will be running for the four-year term. Staggered terms exist at this point in the election cycle due to the decennial census that causes a "realignment" of positions every ten years. Other candidates might be running for this and other offices, so this listing might not be complete. The list in the article above might be more so.
- ★ Milan resident Scott Crowl has entered the race for Illinois' 17th Congressional District in the upcoming election. Crowl, a life-long farmer and former president of the AFSCME union, emphasizes that he is not a seasoned politician. He is vying for the GOP nomination alongside retired judge Joe McGraw from Rockford, both aiming to secure a House seat that has been under Democratic control for over ten years.
- ★ Don't forget that candidates for elective office are now making the rounds to gather petition signatures so they can be placed on the spring primary ballot. If they should come calling, please give them the courtesy of your support.
- ★ Many MCGOP NewsDesk feature stories have recently appeared in the <u>McLean County Times</u>. Six articles appeared in the <u>Times</u> between October 9 and 16, with more to follow. - ★ Did you hear our advertisements for the Lincoln-Reagan Dinner on Cities 92.9 FM? Ads began running just before mid-October and continued for several days.
- \* A new proposal regarding "assault weapon" registration has been introduced, <a href="Illinois House Bill 4150">Illinois House Bill 4150</a>, in response to the Democrats' recently implemented gun ban/registration law. The purpose of the present Bill is to safeguard the personal information of law-abiding gun owners, particularly the data they are obligated to provide to the state for the registration of specific firearms. The newly enacted gun ban/registration law prohibits the ownership of several commonly held firearms and mandates that gun owners register additional firearms and attachments with the state by January 1. Despite ongoing legal challenges in the courts, House Bill 4150 aims to address concerns about the privacy of gun owners' information. If this Bill is successfully passed and the gun ban law is deemed unconstitutional, it would require the State Police to promptly destroy all personal information submitted by gun owners for compliance with the registration requirements of the law. ★ On October 15, two proud members of McLean County Republicans – Joanne Knipmeyer and Chelsie Leffelman – graduated from the Lincoln Series program. They, along with six others, were honored at a Hesed House celebration in Heyworth. The Lincoln Series is the foremost educational and preparatory leadership initiative for Republican Women. This program equips participants with essential tools, knowledge, and a broad state-wide network, fostering the development of purposeful leadership among Republican women in Illinois. A key objective is to amplify the presence of Republican women in both elected and appointed roles within governmental and political spheres. Notably, over 200 graduates of the Lincoln Series have successfully transitioned into diverse roles, contributing to government, policy, and campaigns. Federal law requires us to use our best efforts to collect and report the name, mailing address, occupation and name of employer of individuals whose contributions exceed \$200 in an election cycle. Contributions to Judge Joe McGraw for Congress are not tax deductible as charitable contributions for federal income tax purposes. By federal law, the maximum amount an individual may contribute is \$3,300 per election or \$6,600 per couple. Political Action Committee (PACs) may contribute up to \$5,000 per election. Contributions from corporations, labor unions, foreign nationals and federal government contractors are prohibited.

#### INGREDIENTS

% cup butter
 1 medium onion, chopped (1/2 cup)
 2 large celery stalks, chopped
 9 cups soft bread cubes (15 slices)
 1 teaspoon salt
 ½ teaspoon ground sage
 ½ teaspoon pepper
 ½ cup raisins (optional)


1½ teaspoons chopped fresh thyme leaves or 1/2 teaspoon dried thyme leaves

#### DIRECTIONS

Grease a 3-quart casserole or rectangular baking dish, 13x9x2 inches.

Melt butter in a 4-quart Dutch oven over medium-high heat. Cook celery and onion in butter 6 to 8 minutes, stirring occasionally, until tender. Remove the Dutch oven from the heat.

Toss celery mixture and remaining ingredients (raisins optional), using a spoon, until bread cubes are evenly coated. Place stuffing in casserole. Cover with lid or aluminum foil and bake at 325°F for 30 minutes; uncover and bake 15 minutes longer.
