IV. Candidate Presentations and Q & A Intros & Moderation by Jane Moscowitz & Janet Stearns

Florida Attorney General Candidate Daniel Uhlfelder

- He served as a judicial clerk to the Hon. Donald Middlebrooks; two years at Colson Hicks law firm; now lives in Santa Rosa, Florida where has a general practice of 23 years
- Second generation Floridian, worked with Lawton Chiles, Bob Graham, Janet Reno; married with 2 children
- Key issues rate increases for utilities and insurance; stop attacks on democracy by restrictive legislation on voting and education; minimum wage and marijuana legalization
- As AG will not prosecute people and medical professionals who elect to have or perform abortions
- Wants court reporters at cabinet meetings; will issue subpoenas re: DeSantis' agenda
- Wants to reclaim the narrative in the Jewish Community from DeSantis speak the truth about the fact that he is autocratic and a fascist

Miami Commissioner and US Representative District 27 Candidate Ken Russell

- City of Miami Commissioner; was a yo-yo demonstrator and kite surfer; owns a watersports sales business; 3 children; became community activist for clean parks
- Issues affordable housing and environmental protection, LGBTQ rights, women's rights, fair housing, development
- Maria Salazar has raised 2.5M, what is your path to raising funds has raised 1.4M and is confident will be competitive after the primary; will not take money from the sugar lobby, energy, FPL
- Maria Salazar has voted no on build back better, price gouging on gas, baby formula, women's rights
- How to build a stronger Democratic party in Miami: need to build consensus on critical issues; climate, finance for infrastructure



- Recently passed a gun buyback program where guns would be sent to Ukraine
- The Socialism Question: we must be very vocal about what we stand for rather than getting defensive; response to people focused on the price of gas – it's a global issue, but expects wages going up due to an emerging strong labor union movement
- What he has done as a Miami City Commissioner passed the \$400M Miami Forever Bond; created a community redevelopment agency in West Coconut Grove which can distribute \$500M in affordable housing funds; wrote strong environmental ordinance, passed an environmental crimes ordinance; Police oversight – equivalent increases for civilian oversight as the police budget.
- Support for the embargo in Cuba the embargo alone is not the solution.

US Representative District 27 Candidate Angel Montalvo

- Acknowledged that land was taken from Indigenous people and the history of slavery
- Personal background born and raised in Miami, 29 years old; "a poor person fighting for poor people"
- Issues: housing; healthcare; gun violence; environment
- Funding: no corporate money whatsoever; focus on grassroots donations
- Criticism of Salazar: she's a standard Republican; her rhetoric is unhinged
- How to rebut the socialist label: be authentic and talk about solutions; the Democratic Party is very unpopular even though the policies are among the most supported; Joe Manchin and Kristen Sinema are what is wrong with the party

State Senator and US Representative District 27 Candidate Annette Taddeo

- Dropped out of the governor's race because she could not raise sufficient funds during the legislative session because of ethics rules prohibiting fundraising during session
- Fundraising: was selected for the Red to Blue list; has not taken money from private prisons
- Winning Republican votes: can get Republican women onboard and build a coalition with independents; has won twice in a district where Donald Trump won twice
- Messaging against the incumbent: call her out on her lies. She says she was born in Miami and came here with "five dollars in her pocket;" she promised not to draw a salary, but has; votes against our community against lowering the price of insulin and against controls on the price of gas
- Cuba Embargo: willing to speak up against the President; supports family reunification; the embargo should only end if political prisoners are freed, there are free elections and there is freedom of speech and press
- Would not know what to say if the President or Vice President offered to help her campaign because she doesn't know if it would be helpful
