- 6. The results of the General Election at Exhibit "B" include the final results of recounts in the following races, which were conducted under the authority of the Chief Electoral Officer as set out at subsection 105(c) of the Act and in accordance with the procedures for recounts as prescribed by the Act:
  - a.) a complete recount in the race for District Captain in Athabasca Landing Métis District No. 20, conducted on September 22, 2023.

7. I hereby certify the results of the 2023 General Election of the Otipemisiwak Métis Government as set out in Exhibit "B" to be accurate and final.
