David Hodgkinson is a partner at law firm HodgkinsonJohnston, an Associate Professor at the University of Western Australia, and executive director of the UNFCCC-accredited NGO EcoCarbon Inc (in which capacity he attended COP21 in Paris). His publications include the books "Global Climate Change: Australian Law and Policy" (LexisNexis) and the loose-leaf service "Australian Climate Change Law and Policy."

Since 2010, Peter has been keenly focussed on sequestered carbon in the WA rangelands.



Simon Abbott graduated from Muresk Institute of Agriculture and spent 10 years in the Esperance district contract land developing, share-farming and contract spraying. After working at the Department of Agriculture, he won a national Landcare award for his work using airborne geophysical data for creating salinity management focussed farm plans. He is now the manager of agricultural and natural resource management products at Landgate Satellite Remote Sensing Services.



Russell Teede completed his Honours thesis at James Cook University in the field of Satellite Oceanography, where he developed a passion for visualising environmental issues using remote sensing and GIS. He has continued delivering innovative solutions using satellite and aerial imagery, for marine and terrestrial applications across a diverse range of challenges, such as marine habitat mapping and developing imagery enhancement algorithms. Russell is currently a Research and Development Officer at Landgate, where he has worked for the past 10 years.

Mark Alchin is a leading expert in the science and economics of the emerging carbon offset credit industry in Australian pastoral land. He has over 12 years experience in driving continuous improvement in environmental management, business and government policy within the resources industry and agricultural sector. While at the Department of Agriculture and Food (WA), Mark pioneered baseline field accounting and economic evaluation of opportunities for carbon offset credits and found that commercialisation of carbon in Australian pastoral land could lead to the development of a multi-billion dollar industry.



Harley Lacy has worked in Agriculture, Mining and Environment. Originally from Meekatharra and growing up in the rangelands, he trained as a pastoralist and became a partner in Polelle station. In 1990 he commenced study in environmental science and developed Outback Ecology an environmental consultancy. In 2006 he initiated work on arid land carbon sequestration, which further advanced the science and commercial potential to sequester carbon across the leasehold lands of WA.



Sam Anderson is the lead Project Officer at Carbon Link, a privately owned company born out of the need to enable graziers to earn income by improving their soil. Growing up on the land, she developed a strong passion for livestock and the grazing industry from an early age. She completed a Bachelor of Agriculture and for the past nine years has focussed her professional career on production and commercial developments within the agricultural industry.



Richard Glover is a Rangelands Botanist and Landscape Scientist with nine years experience in landscape management and the development of Environmental Management Plans in the Western Australian rangelands. Richard has managed regional NRM projects across two Australian states working both within Government and as a private consultant, and been involved in the development of over 60 previous Ecologically Sustainable Rangelands Management (ESRM) plans. He holds degrees in Agricultural Science majoring in Rangelands management, and Geographic Information Sciences (GIS).



Peter-Jon (PJ) Waddell has worked and travelled extensively throughout rangeland environments for the past 20 years. PJ joined the WA Department of Agriculture in 2000 as a Resource Management and Protection Officer in Kalgoorlie before being seconded to the Centre for the Management of Arid Environments, as a landscape ecologist, where he developed pastoral property plans and trialled rangeland rehabilitation treatments. He has continued developing his understanding of landscape ecology through managing the WA Department of Agriculture and Food's Rangeland Survey Project.



Kent Broad is a founding director of Carbon Neutral Pty Ltd, a privately owned company that specialises in revegetating degraded areas of the Western Australian wheatbelt with a biodiverse mix of endemic native species.
