Summary

Aether seeks to hire a full-time Investment Analyst. The selected candidate will work most closely with Aether’s investment team but will interact with all members of the organization.

All employees of Aether sit together in an open floor plan offering Investment Analysts exposure to every area of the business. Remote work is permitted on Fridays and the first and third Wednesdays of every month. Employees are expected to work in the office during all other working weekdays.
