 - Collaborated with Albany Police and Community Stakeholders to establish a discipline matrix, collaborated with Albany Police to re-establish the use of Mediation working closely with Program Director Michele Andre to identify best practices, collaborated with Albany Police to provide education to new police recruits, advocated and collaborated with community groups for the passage of Local Law J in 2020 providing the Police Review Board with increased independence and autonomy to investigate complaints

independently, review police discipline files, review body and police camera footage in critical incidents prior to public dissemination, advocated and received budget increase to operationalize mandates of new powers, identified independent legal counsel to support compliance of the law and subpoena power, identified and hired expert contract investigators to respond to high profile complaints.

4. Why do you want to serve on NACOLE's Board? What makes NACOLE's mission important to you?

As a community member impacted by police practices, I became curious about the system and joined the board in 2016. I wanted to learn and operationalized how to support my local community and establish transparency, accountability, and build bridges to progress within oversight locally.

As a tenured member in Albany, I believe joining NACOLE now nationally to use my skills, knowledge, and expertise would be a value add to the community of oversight. It would be an honor and privilege to carry on and expand the work of previous practitioners that have come before me.
