# Two steps need to be taken...



Dealing with the National Emergency – ceasing and reversing Mass Immigration and Illegal migration.

Thereafter adopting policies which ensure our constitution and culture are not threatened by immigration.

This draft policy concentrates on the National Emergency.

We welcome all comments from our members and the public at large. We aim to continually refine this policy, though it is more than sufficient, as drafted, to address the emergency.

# Prepare the ground

Declare a National Emergency under the Civil Contingencies Act 2004 to enact temporary special legislation “emergency regulations”.

Repeal the Humans Right Act (1998) and Equality Act (2010) amongst others.

Withdraw from the ECHR, UNHCR and similar bodies and conventions.

Terminate the EU Withdrawal Agreement, all EU agreements that permit foreigners to move to the UK.

# Prepare the ground

Wherever necessary:

Withdraw from all international institutions, laws, pacts, treaties and agreements that obstruct Parliament acting on its democratic mandate and in the interests of the British people.

Repeal/Revise any UK law does not support Parliament acting on its democratic mandate and in the interests of the British people.

# Prepare the ground

Restore power to Lord Chancellor to remove judges if they countermand Parliament directly or join political associations in violation of oaths.

Slash the size of the Civil Service to drive efficiency and accountability.

Remove civil servants who block the Government's democratic mandate.

Dismantle most QUANGOS to increase direct Government accountability and defund ALL NGOs that undermine Government policy.

# Stop the damage

Abolish the new granting of Indefinite Leave to Remain.

Reverse ILR status for anyone granted ILR since 2019, to be replaced by time limited visas.

Cease granting asylum and reverse asylum grants made since June 2019.

Cease granting British Citizenship to foreigners.

Halt the granting of new work visas to people from countries not on a new Green List (draft list below).

Cancel all visas granted to families of students on visas.

All work visas already granted to be honoured with the possibility of renewal, particularly in high skilled areas, professional services where salaries exceed £100,000 per annum and in key sectors such as the NHS.

# The Green List (Draft)

United States of America, Canada

Australia, New Zealand, Japan, Singapore

Countries within the European Union

Switzerland, Norway, Iceland, Israel

Andorra, Monaco, San Marino, and Vatican City.

Student visas only for those who pay all their tuition fees up-front.

# Reverse Mass Immigration

Abolish all benefits for foreigners – Universal Credit, NHS, Housing, Education.

Remove the right to vote from all foreigners.

Encourage repatriation of all those legally in the UK, including dual nationals, with a time limited incentive.

Classify anyone in the UK with an expired or cancelled visa as being illegally in the country.

# Reverse Mass Immigration

Publish a Migration Transparency Report — a quarterly publication of fully transparent migration data: entries, exits, removals, public expenditure, tax revenues, and all relevant crime data.

Establish a census to understand the demographic composition of our country and the changes taking place.

# Reduce the migrant workforce



Welfare payments to British citizens out of work to cease after 12 months.

Tax on basic rate taxpayers to be reduced by increasing the threshold at which income tax is paid.

Full details to be in Economic Policy.

# Protect our culture

Introduce a **Residence Covenant**, the breaching of which would trigger cancellation of a visa

All non-nationals in the UK automatically required:

- To adhere to the law in all respects;
- Only to engage in the activity permitted by their visa;
- Not to engage in political activity, including but not limited to political associations, meetings and protests;
- Not to advocate for any foreign countries; and
- Not to proselytise.

# Illegal migration

Any foreigners entering the country illegally, remaining in the country after the expiry of their right to stay or being convicted of a crime will be regarded as an illegal migrant.

Illegal migrants will be arrested, detained and deported to the maximum extent possible, with no appeals.

There will be no exceptions and no right of appeal.

# Illegal migration

Every effort will be made to deport them to their country of origin, including sanctioning that country, if necessary.

All foreign criminals held in jails will be deported.

Establish a credible deterrent: cash/assets will be seized to pay for processing; when country of origin is unknown or cannot be returned, illegal migrants will be deported to a third country.

# Enforce our borders

The Royal Navy will be directed to intercept dinghies carrying illegal migrants and ensure they do not enter British territorial waters.

They will be provided with specialist training, fast boats, drones, sensors and barricades as necessary.

It will be made illegal to aid and abet the entry of illegal migrants. This will include the activities of the RNLI and similar bodies.

People smugglers in the country will be targeted.

All payments being made to France will be stopped.

# Establish an Immigration Enforcement Force and Tribunal (IEFT)

A new IEFT will be established to oversee the Residence Covenant and to deal with illegal migrants.

There will be no right to appeal an order passed by the IEFT.

The IEFT will have the power to direct the police as required, powers of arrest and powers to adjudicate all matters in relation to the above including deportation orders.

# Establish an Immigration Enforcement Force and Tribunal (IEFT)

The IEFT will pursue the firing of company directors who knowingly employ illegal migrants, as well as the fining of such companies.

The IEFT will be given a mandate to target sectors known to feature high abuse (barbers, construction, etc) and to create a whistle blower system.

The IEFT will be directed to promptly end contracts with SERCO and move illegal migrants to low-cost, temporary, and secure camps.

The IEFT will help to negotiate international agreements for returns, applying pressure on countries (sanctions, visa suspensions, etc).
