Orange County Justice United organizes to build power for making change, through a coalition of 21 congregations and organizations in Orange County. We are a non-partisan, multi-racial, multi-lingual, multi-issue group. We harness two universal sources of power -- organized people and organized money -- to put our vision and our ideals into action.

We're dedicated to the formation of community leaders who want to make change. We connect individuals and organizations, across divides, multiplying their power. We take on overwhelming problems and carve out specific, measurable, winnable issues. We organize people by the hundreds to change the power balance, so that those traditionally in power are accountable to the community. We set high goals, design innovative strategies, and stick with issues until they are fully addressed.

Most importantly, we challenge people to imagine the changes they can create together, to make our community more just for all.

Affordable Housing

Fighting Gentrification: \$500K+ in Property Tax Relief

To preserve existing affordable housing and make sure that rising property taxes don't push homeowners out of their neighborhoods, leaders organized to win the current version of the Orange County property tax assistance program, for homeowners making low-incomes. The program, won in collaboration with the Marian Cheek Jackson Center and EMPOWERment, Inc., currently provides the **most funding per household of any program in the state.**

St. Paul Village Moving Forward:

350 Affordable + Workforce Housing Units

Justice United members joined founding member congregation, St. Paul AME, to ensure that the visionary St. Paul Village can move forward with the necessary Conditional Zoning Permit. Over 50 members attended two Chapel Hill Town Council meetings to emphasize the critical importance of St. Paul Village in addressing our affordable housing crisis. The **20-acre project will include 88 affordable rental units, 100 units for residents ages 55+, 100% of units affordable as workforce housing**, retail space for small business ownership, 10 acres of permanent green space, and indoor and outdoor recreation.

St. Paul Village was launched by local leaders whose predecessors literally built our community. Leaders took action when they saw that legacy being erased, with longtime Black residents involuntarily displaced through discrimination, lack of affordable housing, and lack of economic opportunity. The project's goal is to directly address this longstanding inequity with a multi-faceted plan that will benefit the entire community.







Addressing a Crisis: \$1.5 million for bilingual mental health


After learning that Spanish-speaking and uninsured community members had essentially no access to mental health services, with stories of parents taking their children to the ER in crisis, **over 365 Justice United leaders organized for a solution. Justice United won a \$1.5 million investment** over three years from Alliance Health, the company that controls Orange County's public mental health funds. Investments include four Community Health Workers (now hired and in training!) to provide no-cost, bilingual, culturally appropriate mental health intervention to 240 clients a year.




District Attorney Commitments: Transparency + Diversion

Over 350 Justice United members used the first competitive District Attorney race in over 20 years as leverage to win commitments from the most powerful person in our local justice system -- the DA! Both candidates, Kayley Taber and winner Jeff Nieman, pledged **to make** diversion options for mental health and substance use treatment "the rule," to implement data tracking for racial disparities, and to increase drivers license restoration for those who can't afford the fines and fees. At our accountability assembly a year later, DA Nieman reported good-faith progress.

Expenses: \$81,882.33
