Together winning candidates Maureen O'Connor and Evelyn Lundberg Stratton raised one million dollars more than the two losing candidates. O'Connor raised \$1,777,617; Stratton raised \$1,898,484. O'Connor's opponent Tim Black generated \$1,323,136 and Stratton's challenger Janet Burnside generated \$1,192,941.

O'Connor and Stratton had a unified and clear message and were able to organize grass-roots contributors. The winning candidates received over 4 times more contributions in increments smaller than \$200. The wining candidates received more individual contributions and the average size of contributions was lower. O'Connor's average contribution size from individuals was \$224.97 and Stratton's \$239. Black's average contribution from individuals was \$446.42; Burnside's \$421.21.

Evelyn Lundberg Stratton received most of her contributions from the physicians and hospitals. Maureen O'Connor raised almost as much from health care but received the largest percentage of her contributions from a variety of business interests, including finance, real estate and insurance. Between October 16 and December 31, Maureen O'Connor received a swell of contributions from physicians. She received \$31,216 during this time period. This can be compared with \$300 to Black, \$750 to Burnside and \$2,360 to Stratton.

The biggest gap between the winning and losing candidates was the money from insurance and physicians. Together the winning candidates O'Connor and Stratton received over 109 times more from insurance companies and physicians. O'Connor received a total of \$503,274 and Stratton \$573,394; Black received \$8,425 and Burnside \$1,525. Tim Black and Janet Burnside, in contrast, received most of their contributions from lawyers.

Most of the contributions to candidates for Ohio Supreme Court were from residents of Ohio. Less than 5% of the money came from out-of-state contributors, totaling \$293,376.

Contributions to 2002 candidates for Ohio Supreme Court totaled nearly two times more than the \$3.1 million raised by 2000 justice candidates. In 1998, all the candidates for Ohio Supreme Court raised \$2,731,288 and in 1996 all the candidates for Ohio Supreme Court raised \$1,375,635. In the space of a 6-year Supreme Court term, contributions to candidates for Justice of the Ohio SupremeCourt have more than quadrupled (4.5 times) the amount raised during all of 1996. All of the 2002 candidates raised more than the top fundraising candidate, Terrence O'Donnell, in the past three election cycles. O'Donnell generated \$1,117,044 in 2000.




Overview of contributions to 2002 candidates for Ohio Supreme Court

Almost half (46.75%) of all contributions made to the 2002 candidates for Ohio Supreme Court came from individuals who gave \$200 or more. Political action committees (PACs) and labor union contributions followed at 19.34%, closely followed by political party and candidate committees at 13.60%. Contributions from "other" interests at 12.77% came in at fourth place. "Other" interests are unincorporated businesses usually "mom and pop shops." These unincorporated businesses are not required to have PACs to make their contributions. Individuals who gave less than \$200 accounted for 7.53% of all contributions.

Recommendations

Establish an 18-member Commission on Judicial Selection and Qualifications. The Judicial Summit on March 6 is a good beginning. However, a one-day conference cannot build consensus for reforms that will address the problems with Ohio's election of judicial candidates. Chief Justice Thomas Moyer has urged the Ohio General Assembly to establish a commission to review judicial selection and reform options. This commission could explore a variety of reforms including public financing and would provide the time needed to build consensus.

Improve disclosure requirements so that contribution information is required between the Post-Primary filing and the monthly filings. Disclosure needs to be timely during election years. Currently, candidate committees are not required to provide contribution information between the Post-Primary filing (June 7, 2002) and the beginning of the July monthly filing (July 1, 2002). Some candidates wait until the Pre-General to provide this information.

Improve disclosure requirements so that expenditure information is required at monthly filings. The candidates for justice of Ohio Supreme Court do not have to file their expenditures for monthly filings. The expenditures could be filed with the Pre-General filing. In other words, the balances on the summer campaign reports could be completely inaccurate, because they do not have to reflect the outgoing expenses.

- The 1999-2000 *Run for the Money* database in which the Center had prepared an analysis of 1999-2000 contributors,
- A list of contributors to Political Action Committees in Ohio

For each candidate the total amount in this database includes the following:

- Contributions received

- In-kind contributions received
